Opinion

We have audited the financial statements of Bud Luty Charitable Scholarship Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

NOTE A - DESCRIPTION OF PLAN

The Bud Luty Charitable Scholarship Trust was formed in 1993 for the purpose of providing scholarship benefits to the employees of contributing employers who have entered into collective bargaining agreements with the United Food & Commercial Workers Union, Local 1776KS or who have participation agreements.

The Trust awards scholarships to students who will be attending school on a full-time basis and are pursuing either a post secondary degree from an accredited college or university or a certificate of graduation from an accredited vocational school.

The Fund is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA).

The foregoing description of the Fund provides only general information. Employees should refer to the Plan's booklet for a more complete description of the Plan's provisions. Copies of the booklet are available from the Fund office.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Revenue Recognition -

Employer contributions are recognized as revenue when earned by participants on the basis of hours worked or paid. For contributions receivable that were not subsequently collected by the date of this audit, an allowance for doubtful accounts has been recorded. Interest income is recorded as earned.

Investment Valuation -

Investments are stated at fair value which equals cost.

Basis of Accounting -

The financial statements have been prepared on the accrual basis of accounting.

Estimates -

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE C - TAX EXEMPT STATUS

The Internal Revenue Service has ruled that the Plan and Trust qualify under Section 501(c)(9) of the Internal Revenue Code and are, therefore, not subject to tax under present income tax law.

NOTE D - PRIORITIES UPON TERMINATION

It is the intention of the Trustees to continue the Plan indefinitely. If the Plan were to be terminated by the Trustees, the assets of the Trust Fund would be used for the exclusive benefit of eligible employees to provide scholarships and pay fund expenses until exhausted.

NOTE E - ADMINISTRATIVE SERVICES

The Trust entered into an administrative service agreement with the UFCW, Local 1776KS and Employers Health Fund to provide certain administrative services to the Trust. In return, the Trust will pay the Health Fund monthly, an amount equal to a fixed fee per participant and a direct reimbursement of certain costs. Effective January 2024, the Trust will pay the Health Fund monthly, the actual costs of administrative expenses rather than a fixed fee per participant.

NOTE F – SUBSEQUENT EVENTS

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through April 21, 2025, the day the financial statements were approved and authorized for use.
