## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Nodaway Valley Bank 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of Nodaway Valley Bank 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") for employees of Nodaway Valley Bank (the "Company"). Charles Schwab Trust Company ("Schwab") serves as the Plan's custodian for mutual funds, money market fund and individually directed brokerage accounts. Nodaway Valley Bank serves as the Plan's custodian for the certificates of deposit ("CD"). K-Trade serves as the Plan's recordkeeper. Employees of the Company serve as the Plan's trustee.

**Eligibility** – An individual is eligible to make salary deferrals to the Plan after working one hour and reaching the age of 21. Plan entry dates are the first day of each calendar quarter. An employee becomes eligible for Company contributions after working one year and 1,000 hours and enters the Plan on the first day of January or July. Employees who are subject to collective bargaining agreements and leased employees may not participate in the Plan.

**Contributions** – Participants may elect to contribute any fixed dollar amount of their compensation, subject to certain Internal Revenue Code ("IRC") limitations.

The Company may make discretionary matching and/or profit-sharing contributions. During 2024, the Company matched 100% of the first \$500 of the participant's contribution and awarded each eligible participant a profit-sharing contribution proportional to his or her respective eligible wages, which was approximately 9.45% of eligible compensation. The total of the employer matching and profit-sharing contributions was \$1,200,000 and was paid into the trust in 2025. In order to receive Company contributions, a participant must be employed on the last day of the year and have worked 1,000 hours during the year.

**Participant Accounts** – Each participant's account is credited with the participant's and Company's contributions, interest and dividends earned on the investments, and is charged with the participant's withdrawals and expenses (if applicable). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options** – Participants may choose to invest their money in certificates of deposit issued and held by the Company, or in investments through Schwab, who offers a variety of mutual funds and a money market fund for participants. Participants who are looking for more investment access, choice and flexibility in their retirement accounts may invest in the Schwab Personal Choice Retirement Account ("PCRA"). PCRA is a self-directed brokerage account with investment choices which include common stocks listed on U.S. exchanges, mutual funds, and fixed income investments.

**Vesting** – Participants' contributions are fully vested at all times. The employer contributions vest as follows:

**Forfeitures** – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeiture amounts from employer match contributions are used to reduce employer contributions. Forfeiture amounts from profit sharing contributions are allocated to participants in the same manner as a profit-sharing contribution. During 2024, approximately \$55,000 was reallocated to eligible participants.

**Payment of Benefits** – Upon termination of employment, the participant, or in the case of death, the participant's beneficiary, receives the participant's account balance in a single lump-sum. Participants may receive distributions in the next quarter following their termination. Participants may also choose to leave their money in the Plan.

**Notes Receivable from Participants** – Participants may take a loan against their vested account balance. Loans range from a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan payments are made through payroll deductions and must be repaid to the participant's segregated account within three to five years, depending on the amount of the loan. Loans for a principal residence may be paid back over a longer term. The loans are secured by the balance in the participant's account and bear interest at reasonable rates as determined by Plan management. Participants are responsible for paying a one-time loan initiation fee, ranging from \$150 to \$250.

**Administrative Expenses** – The Company pays certain recordkeeping expenses of the Plan. Participants pay investment related fees for funds held by Charles Schwab.

**Termination of the Plan** – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants' accounts would become fully vested, and all remaining Plan assets would be allocated to the participants as described in the full text of the Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions** – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

**Other Liability** – In 2024, the Plan received a \$6,241 contribution to the CD account relating to a 2025 payroll.

**Investment Valuation and Income Recognition** – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is accrued when earned.

Management fees and operating expenses charged to the Plan for investments in mutual funds and money market fund are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for doubtful accounts is considered necessary.

**Payment of Benefits** – Benefit payments are reported in the year paid.

**Date of Management's Review** – Subsequent events have been evaluated through May 12, 2025, which is the date the financial statements were available to be issued and there were no reportable subsequent events noted.

### 3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds, Common Stocks and Money Market Funds – Valued at the closing price reported on the active market on which the individual securities are traded. Note that common stocks are held in the individually directed brokerage accounts.

Certificates of Deposit – Valued at cost plus any accrued interest, which approximates fair value. The interest on the CD is paid at the end of each month.

The methods describe above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the financial statements.

#### 5. INFORMATION CERTIFIED BY A CUSTODIAN

The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included in the Plan’s financial statements that was prepared by or derived from information prepared by Charles Schwab Trust Bank, a custodian of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained a certification from this custodian that such information is complete and accurate as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

- Investments in mutual funds and money market funds
- Investments in individually directed brokerage accounts
- Investment income (excludes interest income on certificates of deposit)
- Notes receivable from participants and related interest income
- Supplemental Schedule of Assets (Held at End of Year) (excludes investment in certificates of deposit)

**6. PARTY-IN-INTEREST TRANSACTIONS**

A Plan investment is a Certificate of Deposit issued and held by Nodaway Valley Bank, the Plan's Sponsor. Nodaway Valley Bank is a custodian as defined by the Plan and the Plan Sponsor; therefore, these transactions qualify as party-in-interest.

A Plan investment is a money market fund issued and held by Schwab. Schwab is a custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest.

Notes receivable from participants are party-in-interest transactions. Additionally, certain expenses are paid from the Plan to K-Trade and to an investment advisor. These are party-in-interest transactions.

**7. TAX STATUS**

The Company adopted a Prototype Non-standardized Profit-Sharing Plan with CODA which received a favorable opinion letter from the IRS on March 22, 2021, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. CONCENTRATION OF INVESTMENTS**

Approximately 24.6% and 28.0% of the Plan's net assets consist of a Certificate of Deposit issued and held by the Plan Sponsor, for the years ended 2024 and 2023, respectively. Each participant in the Plan investing in the CDs is insured by the Federal Depository Insurance Corporation to a maximum amount of \$250,000.
