### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Contamination Control and Certification Holdings, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). #### Note 1. Plan Description

The following description of the Contamination Control and Certification Holdings, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering employees of Contamination Control and Certification Holdings (the Plan Sponsor), as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Eligibility:** Effective January 1, 2023, employees become eligible immediately upon employment. However, non-elective employer contributions and matching employer contributions are applicable for employees who have completed six months of service. Employees may begin participating in the Plan beginning on the first day of the month immediately following or coinciding with an employee's satisfaction of the eligibility requirements.

**Contributions:** Participants are permitted to contribute pre-tax and after-tax contributions to the Plan. Participants may make contributions of up to 100% of their annual compensation, as defined in the Plan, subject to an annual limit imposed by the Internal Revenue Code (IRC). Participants who have attained the age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans.

The Plan includes an automatic salary contribution feature. The Plan Sponsor will automatically withhold a portion of an employee's compensation for each payroll period and contribute to the Plan as a pre-tax contribution. The automatic contribution provision applies to all new eligible employees who become participants on or after the effective date of the automatic contribution provisions. The amount to be automatically withheld from an employee's pay each payroll period will be equal to 3% of compensation. The amount will increase annually by 1% of compensation up to a maximum of 15%. Plan participants have the option to specify their individual contribution rate or opt out of participation altogether and may increase or decrease the amount of contributions at any time.

In addition to participant contributions, the Plan Sponsor may make a discretionary matching contribution equal to a uniform percentage of participant contributions to an active participant during the contribution period. The Plan Sponsor's matching contributions for the year ended December 31, 2023, equaled 2.5% of participant eligible wages up to total contributions. The Plan Sponsor may make discretionary nonelective contributions at the option of the Plan Sponsor's Board of Directors. No discretionary nonelective contributions were made during the year ended December 31, 2023. Contributions are subject to certain limits.

**Investment options:** Participants direct the investment of their contributions and any employer contributions into various investments offered by the Plan, which include mutual funds and common collective trust funds. Participants may change their investment options daily.

**Participant accounts:** Each participant's account is credited with the participant's contributions and allocations of the Plan Sponsor's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Note 1. Plan Description (Continued)

**Payment of benefits:** Upon termination of service, death, retirement or disability, a participant or beneficiary will receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. Participants may request hardship distributions, as defined. Participants can request in-service distributions upon reaching the Plan's normal retirement age.

If the participant's vested account is less than or equal to balance exceeds \$5,000, no distribution will be made from the Plan without the participant's consent. If a participant's vested account balance upon termination of service, death, disability or retirement is greater than \$1,000 but less than \$5,000, a participant can elect a distribution option or if no election is made, the Plan Administration will pay the distribution in a direct rollover to an individual retirement account designated by the Plan Administrator. If a participant's vested account balance is \$1,000 or less, a lump-sum amount distribution is the required form of distribution on termination of service, death, disability or retirement.

**Vesting:** Participants are immediately vested in all participant contributions, including catch-up and rollover contributions. Participants are vested in the Plan Sponsor's contributions plus actual earnings thereon based on years of continuous service. A participant vests based on the following years of service:

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Administrative expenses of the plan are allocated to participant accounts.

**Forfeitures:** At December 31, 2023 and 2022, forfeited non-vested balance totaled approximately \$77,000 and \$6,000, respectively. Forfeitures can be used to pay plan expenses or to reduce employer matching contributions. During the year ended December 31, 2023, approximately \$42 of forfeitures were used to pay administrative expenses.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest payments are paid ratably through payroll deductions.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The Plan prepares its financial statements on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes gains and losses on investments bought and sold as well as held during the year.

**Contributions:** Contributions from Plan participants and the contributions from the Plan Sponsor are recorded in the year in which the participant compensation is paid.

**Note receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of benefits:** Plan benefits are recorded when paid.

**Subsequent events:** Management has evaluated subsequent events through May 12, 2025, the date the financial statements were available to be issued. Effective January 1, 2024, the plan has been renamed as Technical Safety Services, LLC 401(k) Plan.

#### Note 3. Information Certified and Provided by Fidelity Management Trust Company (Trustee)

#### Note 4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The Fair Value Measurements and Disclosures Topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) requires the use of valuation techniques that are consistent with the market approach, the income approach and/or the cost approach. Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset or liability. Inputs may be observable, meaning those that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from independent sources, or unobservable, meaning those that reflect the Plan's own assumptions about the assumptions market participant would use in pricing the asset or liability developed based on the best information available in the circumstances. In that regard, the Topic establishes a fair value hierarchy for valuation inputs that give the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

**Level 1:** Quoted market prices in active markets for identical assets or liabilities.

**Level 2:** Observable market-based inputs or unobservable inputs that are corroborated by market data.

**Level 3:** Unobservable inputs that are not corroborated by market data.

When available, quoted market prices are used to determine the fair value of investments held in the Plan and such items are classified within Level 1 of the fair value hierarchy. A description of the valuation methodologies used for instruments measured at fair value, as well as the general classification of such instruments pursuant to the valuation hierarchy, is set forth below. The level to which an asset or liability is classified is based upon the lowest level of input that is significant to the fair value measurements.

There have been no changes in valuation methodologies at December 31, 2023, compared to December 31, 2022.

**Mutual funds:** Mutual funds are reported at fair value based on the quoted market price of the fund and are classified within Level 1 of the valuation hierarchy.

**Common collective trust funds:** Common collective trust funds invest primarily in traditional guaranteed investment contracts and other short-term investments. The Plan's investment is not considered a direct investment in investment contracts, and accordingly, the fund is presented at fair value using the net asset value practical expedient. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur immediately.

Participants that transfer out of certain common collective trust investments may be subject to a 90-day wait period prior to transferring funds back to the common collective trust fund.

#### Note 5. Related Parties and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management and administration services amounted to \$64,542 for the year ended December 31, 2023. The Plan Sponsor also paid certain administrative expenses of the Plan.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their entire accounts.

#### Note 7. Tax Status

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The Plan has been amended since adopting the pre-approved plan document; however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Note 10. Nonexempt Transactions

During 2021 through 2023, the Sponsor inadvertently failed to deposit approximately \$2,192,044 of participant deferrals within the required timeframe as stated by the DOL regulations. The Sponsor reimbursed to the Plan for lost interest on the 2022 participant deferrals in 2024. The Sponsor intends to reimburse the Plan for lost interest on the 2021 and 2023 participant deferrals in 2025. The Sponsor intends to file Form 5330 Excise Tax Return and intends to pay the applicable excise tax in 2025. The excise tax payments will be made from the Sponsor's assets and not from assets of the Plan.
