**Note 1: Description of Plan**

The following description of the Sheetz, Inc. 401(k) Retirement Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

Sheetz, Inc. (the "Company") established the plan to provide additional incentive and retirement security for eligible employees by permitting them to make elective contributions on a pre-tax and Roth after-tax basis and thereby share in Company matching contributions. Employees who both have attained age 18 and completed six months of service and 500 hours of service are eligible to participate in the plan as of the first day of the next calendar month. The Plan also contains an automatic enrollment and annual escalation provision for participants if certain criteria is met.

**Contributions**

The Company matches eligible employee elective contributions on a dollar-for-dollar basis up to and including 4% of pay per payroll period. The Company does not match additional employee elective contributions. Employees may also make "rollover contributions" to the plan from other qualified retirement arrangements. The Company does not match rollover contributions. The plan offers various investment options for participants.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, employer's contributions, and Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan agreement.

**Vesting**

Participants are immediately vested in both their contributions and Company contributions plus actual earnings thereon.

**Notes Receivable from Participant**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years, or a reasonable period of time longer than 5 years for a purchase of a principal residence. The plan administrator determines a reasonable rate of interest.

**Payment of Benefits**

All benefits will be paid by lump sum, by a series of substantially equal payments over a fixed period of years, or by a specified dollar amount each year. Payment is eligible upon termination of service, retirement, eligible in-service withdrawals, death, and disability. Vested participants who separate from employment with the Plan sponsor, and whose account is more than de-minimis, may elect to leave their funds in the Plan. Effective January 1, 2024, the de-minimis amount was increased to \$7,000 from \$5,000. The Plan allows for in service hardship withdrawals if certain criteria is met.

**Forfeited Accounts**

As of September 30, 2024 and 2023, no forfeited, nonvested accounts exist, as participants are always 100% vested in their account balance.

**Note 2: Summary of Significant Accounting Policies**

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of September 30, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are, therefore, excluded from these financial statements. Investment-related expenses are included in net realized and unrealized appreciation of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

**Secure Act and Secure Act 2.0**

The Plan is currently working with their third party administrator to ensure compliance and any required plan changes are made to comply with the Secure Act and the Secure Act 2.0.

**Date of Management's Review of Subsequent Events**

Subsequent events were evaluated through May 7, 2025, which is the date the financial statements were available to be issued.

**Reclassifications**

Certain prior year amounts have been reclassified for consistency with the current year presentation. These reclassifications had no effect on the reported results of net assets.

Gains and losses in net assets available for benefits for years ending September 30, 2024 and 2023, are reported in net realized and unrealized appreciation of investments.

The Plan's policy is to recognize transfer of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended September 30, 2024 and 2023, there were no transfers of investments into or out of Level 3.

There have been no changes in the methodologies used or level designations at September 30, 2024 and 2023.

**Level 1 Fair Value Measurements**

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

**Level 2 Fair Value Measurements**

Common/Collective Trusts and pooled separate accounts are valued using the net asset value based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. The Plan can redeem these investments daily. There are no restrictions on redemptions.

(a) In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

**Note 3: Fair Value Measurement** (Continued)

(a) This class includes investment in common/collective trust that primarily invests in investment contracts and security backed contracts. The investment contracts are issued by a financial institution to provide a stated rate of return to the buyer of the contract for a specified period. A security-backed contract has similar characteristics as traditional investment contract and is comprised of two parts: the first part is a fixed income security or portfolio of fixed income securities; the second part is a contract value guarantee (wrapper) provided by a third party. Wrappers provide contract value payments for certain participant-initiated withdrawals and transfers, a floor crediting rate, and return of fully accrued contract value at maturity. The Fund's investment objective is to maintain principal. The fair value of the investments in this class have been estimated using the net asset value per unit of the investments in the trust.

**Note 4: Income Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated February 9, 2014 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

**Note 5: Information Prepared and Certified by Trustee**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Principal Trust Co., the trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of September 30, 2024 and 2023, the supplemental Schedule H, Line 4i, Schedule of Assets Held at End of Year as of September 30, 2024, and the related investment activity and interest on participants notes reported in the Statements of Changes in Net Assets Available for Benefits for the years ended September 30, 2024 and 2023.

**Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA.

**Note 7: Related Party Transactions**

Certain Plan investments are shares of mutual funds managed by Principal Financial Group. Principal Financial Group is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

The plan received transfers from Sheetz, Inc. ESOP of \$810,152 and \$334,073 for the periods ending September 30, 2024 and 2023, respectively. Plan transfers occur when Sheetz, Inc. ESOP participants make diversification elections during the plan year. The Sheetz, Inc. ESOP is another qualified retirement plan of the plan sponsor and, therefore, the transfers qualify as a related party transaction. The transfers are included in rollover contributions on the statements of changes in net assets available for benefits.

Contract administrator fees and other expenses paid by the Plan amounted to \$877,396 and \$720,039 for the years ended September 30, 2024 and 2023.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**Note 8: Separated Participants**

Amounts allocated to withdrawing participants are recorded on the Schedule H of Form 5500 for benefit claims that have been processed and approved for payment prior to September 30 but not yet paid as of that date.

Vested accounts of terminated participants included in investment balances as of September 30, 2024 and 2023 totaled \$7,936,336 and \$9,605,896, respectively, as reported to the Internal Revenue Service on Form 8955-SSA.

**Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term, and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
