Opinion

Note 1: Plan Description

The following brief description of the Sheetz, Inc. Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for complete information.

Sheetz, Inc. established the Sheetz, Inc. Employee Stock Ownership Plan (Plan) effective as of January 1, 2001.

The most current plan restatement was effective January 1, 2024.

Eligibility

Employees of Sheetz, Inc. and such of its affiliated entities have adopted the Plan for their employees referred thereafter as (the Company and/or Plan Sponsor) are generally eligible to participate in the Plan after one year of service providing they worked at least 1,000 hours during such plan year and reaching 18 years of age. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year.

Payment of Benefits

No distributions from the Plan will be made until a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company and its participating subsidiaries. Distributions are made in cash or, if a participant elects, in the form of Company common shares plus cash for any fractional share.

Voting Rights

The Trustee shall vote all shares of stock, including fractional shares, allocated to a participant's account, or held in the unallocated stock account and any suspense account.

Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the code. Upon termination of the Plan, the Employee Benefits Administration Committee shall direct the Trustee to pay all liabilities and expenses of the trust fund and to sell shares of financed stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participant's nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation.

The Plan provides that the number of shares allocated to each participant is based on that participant's allocation units. The number of allocation units each participant has is based on two factors. Those factors are eligible compensation and length of service.

Vesting

Post the October 1, 2014 plan restatement, if an employee is credited with at least one hour of service on or after October 1, 2014, they will be 100% vested in their account if their employment terminates after they have completed three years of service. Notwithstanding the foregoing, five years of service is required for 100% vesting, if all service was completed prior to the Plan year beginning October 1, 2014. For this purpose, service is measured from the date the employee begins to work for the Company through the day their employment terminates. If the employee has a period of absence of less than one year, the period of absence will be credited as "service." If the employee has a period of absence of for more than one year, but less than five years, their pre-termination and post-termination service (but not the period of absence) will be added together. Also, if the employee has three years of service before their termination, they will keep all of their prior service.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants, and that is not readily tradable on an established market or that is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Each participant who has reached age 55 and who has completed at least 10 years of participation in the Plan shall be permitted to make a diversification election in accordance with the procedure adopted by the Committee. A diversification election shall be in writing and shall apply to an amount that (a) is not less than \$500, and (b) does not exceed 25% (50% for the last year for which an election may be made) of the stock allocated to a participant's account reduced by the amount previously diversified.

Note 1: Plan Description (Continued)

Participant Accounts and Forfeitures

Employer contributions and Plan forfeitures are allocated to each participant's account based upon the relation of the participant's allocation units for the Plan year. Forfeited nonvested account balances at September 30, 2024 and 2023 totaled \$0 and \$0, respectively. Net forfeited shares of 2.0798 for the year ended September 30, 2024 were allocated to participants' accounts. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

Note 2: Summary of Significant Accounting Policies

Date of Management's Review

Subsequent events were evaluated through May 7, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The common shares of the Company are valued at fair value on September 30, 2024 and 2023. Fair value is determined by annual, independent appraisals.

Dividend income is accrued on the ex-dividend date.

Purchases and sales of securities are recorded on a trade date basis. Realized gains and losses from security transactions are reported on the average cost method.

Operating Expenses

All expenses of maintaining the Plan are paid by the Company and excluded from the financial statements.

Secure Act and Secure Act 2.0

The Plan is currently working with their third party administrator to ensure compliance and any required plan changes are made to comply with the Secure Act and the Secure Act 2.0.

Note 3: Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available. There have been no changes in the methodologies used or level designations at September 30, 2024 and 2023.

Level 3 Fair Value Measurements

The fair value of the sponsor company common stock is determined by an annual independent appraisal. This appraisal was based on a combination of the market and income valuation methods consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities. Note 4: Administration of Plan Assets

The Plan's assets, which consist principally of sponsor company common shares, are held by the Trustee of the Plan.

Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee's fees are paid directly by the Company.

Note 6: Plan Contributions

For the Plan year ended September 30, 2024, the Plan received contributions totaling \$18,596,953 cash and \$490,291 stock.

Note 7: Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 16, 2014 that the Plan is qualified, and the trust established under the Plan is tax-exempt, under the appropriate sections of the Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

Note 8: Transaction with Related Parties

Employees of the Company served as Trustees for the Plan in 2024 and 2023. At September 30, 2024 and 2023, the trust's investment portfolio was entirely composed of securities of the Company. The Company contribution of \$18,596,953 cash for the year ended September 30, 2024 was approved by the Board of Directors of Sheetz, Inc. and paid or accrued to the Trust.

Benefit payments for the year ended September 30, 2024 included \$810,152 of diversification elections, which resulted in a transfer of plan assets from Sheetz, Inc. ESOP to Sheetz, Inc. 401(k) Retirement Plan. The Sheetz, Inc. 401(k) Retirement Plan is another qualified retirement plan of the plan sponsor and, therefore, the transfer qualifies as a related party transaction.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 9: Concentrations

The assets of the Plan consist of 100% of the outstanding stock of the Company. The Company operates in the convenience store industry.

Note 10: Risks and Uncertainties

The Plan invests in the Plan Sponsor's company stock. All investment securities are exposed to various risks such as market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11: Distributions

During 2024, the Plan made distributions of Company stock in the amount of 234.5084 shares at a value of \$20,955,671 which is included in the \$42,076,313 of distributions to participants on the statement of changes in net assets available for benefits for the year ended September 30, 2024.

Note 12: Separated Participants

Amounts allocated to withdrawing participants are recorded on the Schedule H of Form 5500 for benefit claims that have been processed and approved for payment prior to September 30, but not yet paid as of that date.

Vested accounts of terminated participants included in investment balances as of September 30, 2024 and 2023 totaled \$9,301,038 and \$14,431,541, respectively, as reported to the Internal Revenue Service on Form 8955-SSA.
