NOTES TO FINANCIAL STATEMENTS

Note 1 - Description of the Plan

The following description of the Friendship House Group Medical Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a health and welfare benefit plan that provides benefits to employees of the Friendship House (the Plan Sponsor). The Plan also provides benefits to former employees electing coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) provisions. In order to be eligible for medical benefits, the employee must be a full-time employee who works at least 30 hours a week and employed for 60 days. Benefits are also provided to dependents of these individuals who elect coverage on their behalf. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective June 1, 2022, the Plan is a member of Veris Benefits Consortium, LLC, which operates as a health insurance consortium under which the members negotiate and establish employee welfare benefit plans for their employees. The Plan year end was changed to June 30. Some expenses of the health plan are paid through the Veris Benefits Consortium, LLC Trust. The employees are required to pay for a portion of the cost of the benefit.

Contributions

The Company shall contribute such amounts to the Plan as necessary for timely payment of all claims and administrative expenses of the Plan. The Company provides for stop loss insurance over a specified amount as per agreement with the reinsurance carrier, with the premiums being paid by funds deposited in the Plan. Employee contributions are determined on a fixed fee basis. The amount varies depending on the selection of individual or eligible dependent coverage.

Benefits

The Plan provides health (medical, hospital, surgical, major medical, and prescription drug) benefits to all employees of the Company who meet the service requirements of the Plan and to their covered dependents. Retirees of the Company are eligible to continue medical insurance coverage after retirement. The Plan also provides continuation of certain benefits upon termination of employment through COBRA as defined in the plan document.

All health benefits are self-insured. These claims are currently processed through Highmark.

The Company provides most health insurance benefits and pays the administrative fees incurred. The employees pay a portion of their health coverage based upon the coverage chosen.

Note 1 - Description of the Plan - (Continued)

Stop Loss Coverage

The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, IBNR, claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits

Premiums paid by the trust are recorded as insurance premiums in the accompanying statement of changes in net assets available for benefits when paid.

Claim payments are recorded when paid by the third-party claims processor.

Stop Loss Insurance

The Plan has a stop loss insurance arrangement whereby the stop loss insurance will cover the Plan's obligations for any plan participant's claims in excess of a fixed dollar amount (self-insured retention). The self-insured retention for the Company was \$50,000 per covered person for the year ended June 30, 2024. In addition, the Plan has an aggregate stop loss insurance arrangement whereby the aggregate stop loss insurance will cover the Plan's obligations if all claims exceed a fixed dollar amount. Premiums for stop loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits. Stop loss refunds of \$119,114 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the one month ended June 30, 2024.

Note 2 - Summary of Significant Accounting Policies - (Continued)

Benefit Obligations

Plan obligations at June 30 for claims incurred by active participants, but not reported at that date, are estimated by the Plan's actuary in accordance with accepted actuarial principals based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment. Such estimated amounts are reported in the accompanying statement of plan's benefit obligations. Due to the short-term nature of the reserve liability, time value of money was not used to discount future payments.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party administrators, the custodian, and actuary. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

Subsequent Events

The Plan has evaluated subsequent events through April 14, 2025, the date the financial statements were available to be issued and concluded no events or transactions occurred during that period requiring recognition or disclosure.

Note 3 - Investments

The Plan's investments are held by a bank-administered trust fund. All investments in the Plan are nonparticipant-directed.

Note 4 - Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 4 - Fair Value Measurements - (Continued)

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 or 2023.

Money Market Funds: Shares of the money market funds are valued at the quoted net asset value of shares held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no transfers between levels during the plan years ended June 30, 2024 or 2023.

Note 5 - Related Party Transactions

Plan investments are managed by the UMB Bank, custodian of the Plan. The Plan has several arrangements with service providers. These transactions qualify as party-in-interest transactions under ERISA.

Note 6 - Tax Status

The Plan is funded through the Veris Benefits Consortium, LLC Trust. The Veris Benefits Consortium, LLC Trust is included on the U.S. Income Tax Return for an S Corporation Form 1120S of the third-party administrator for the Plan. Plan management believes that the Plan is being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for tax years before 2020.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to active employees, discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for any other purposes other than for the exclusive benefit of the Plan's participants.

Note 8 - Risks and Uncertainties

The Plan invests in money market funds. Money market funds are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with money market funds, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
