Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the accompanying financial statements of Franklin County Home Health Agency, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for plan benefits (in liquidation) as of October 31, 2024 and the related statement of changes in net assets available for plan benefits (in liquidation) for the period January 1, 2024 to October 31, 2024, and the statement of net assets available for benefits as of December 31, 2023 (ongoing), and the statement of changes in net assets for the year ended December 31, 2023 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Franklin County Home Health Agency, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2024 and December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Franklin County Home Health Agency, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 1 to the financial statements, the governing body of Franklin County Home Health Agency, Inc. 401(k) Plan approved a plan of liquidation on March 15, 2024 and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting 2024 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Notes to Financial Statements

For the Period January 1, 2024 to October 31, 2024 and for the Year Ended December 31, 2023

(1) Description of Plan

The following description of the Franklin County Home Health Agency, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

- (a) General – The Plan was a 401(k) cash or deferred profit sharing plan covering all employees of Franklin County Home Health Agency, Inc. ("the Agency" or "the Employer"). It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Directors on March 15, 2024, approved the termination of the Plan. Full liquidation of Plan assets was completed on October 31, 2024.

- (b) Contributions – Participants could elect to defer any percentage of compensation within Internal Revenue Code annually adjusted limits. The Plan had an "auto escalate" feature for contributions. Any participant who contributed less than 11% of their compensation to the Plan had their contribution automatically increased annually on July 1 by 1% until the participant's contribution was 11% or elected a different percentage. Participants could opt out of auto-escalation.

The Agency made a safe harbor contribution equal to 100% of participants' salary deferrals that did not exceed 3% of participants' compensation plus 50% of salary deferrals between 3% and 5% of participants' compensation. There were no eligibility requirements to receive the safe harbor contribution.

For any plan year, the Employer could contribute a discretionary contribution. The contribution would be allocated among participants employed on the last day of the plan year proportionately based on each participant's compensation in relation to the aggregate compensation of all participants. For the period January 1, 2024 to October 31, 2024 and for the year ended December 31, 2023, there were no such contributions.

The Plan also allowed for matching contributions. For the period January 1, 2024 to October 31, 2024 and for the year ended December 31, 2023, there was a 100% match on the first 2% of contributing participants' gross eligible wages on a per payroll basis.

For any plan year, the Employer could make an additional contribution to all non-highly compensated participants who had one year of eligible service, called a qualifying non-elective contribution. Allocations of any such contributions were made on the basis of compensation. For the period January 1, 2024 to October 31, 2024 and for the year ended December 31, 2023, there were no such contributions.

- (c) Participant Accounts – Each participant's account was credited with the participant's contributions, allocations of the Agency's contributions, and the plan earnings. Allocations of earnings were based on participants' earnings on account balances. The benefit to which a participant was entitled was the percentage of their vested interest.

- (d) Vesting – Employee-elected deferrals and investment earnings allocated to the deferrals were always 100% vested.

Description of Plan (continued)

A provision for the safe harbor contribution was that the contribution was immediately 100% vested. Participants' vested interest in their account derived from employer contributions other than safe harbor contributions and investment earnings was based on the following vesting schedule:

- 20% after one year of service
- 40% after two years of service
- 60% after three years of service
- 80% after four years of service
- 100% after five years of service

- (e) Forfeitures – Forfeitures of non-vested portions of employer contribution funds of terminated employees were used to reduce future Agency contributions. Forfeitures amounted to \$0 and \$847 as October 31, 2024 and December 31, 2023, respectively. For the period January 1, 2024 to October 31, 2024 and for the year ended December 31, 2023, there were \$847 and \$7,757 in forfeitures used, respectively.
- (f) Notes Receivable – Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested interest, whichever was less. Participants could have one loan outstanding at a time. The loans were secured by the balance in the participant's account and bore interest at a constant rate throughout the term.
- (g) Payment of Benefits – At normal retirement, termination, death, or disability, the total vested value of a participant's individual account, including investment earnings, was a lump sum available for a distribution.

(2) Summary of Significant Accounting Policies

- (a) Basis of Accounting – The financial statements of the Plan were prepared using the accrual method of accounting. Effective January 1, 2024, the financial statements were presented on the liquidation basis of accounting.
- (b) Investment Valuation and Income Recognition – The Plan's investments were stated at fair value. Fair value was the price that would have been received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities were recorded on a trade date basis. Interest income was recorded on an accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could have differed from those estimates.

Summary of Significant Accounting Policies (continued)

- (c) Risk and Uncertainties – The Plan’s assets were held in investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities occurred in the near term and that such changes could have materially affected participants’ account balances and the amounts reported in the statements of net assets available for plan benefits.
- (d) Administrative Expenses – The Agency paid certain costs related to the operation of the Plan. Personnel and facilities of the Agency were used by the Plan for its accounting and other activities at no charge to the Plan.
- (e) Payment of Benefits – Benefit payments were recorded when paid.
- (f) Notes Receivable – Notes receivable from participants were reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan Document.
- (g) Subsequent Events – The Plan evaluated subsequent events through May 21, 2025, the date the Plan’s financial statements were available to be issued.

(3) Information Certified by the Plan’s Custodian

The Plan administrator had elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC had certified to the completeness and accuracy of all amounts and types of investments reflected on the accompanying statements of net assets available for benefits as of October 31, 2024 and December 31, 2023, and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the period January 1, 2024 to October 31, 2024 and for the year ended December 31, 2023.

(4) Fair Value Measurements

Generally accepted accounting principles in the United States of America establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that were observable for the asset or liability;
- inputs that were derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input had to be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following was a description of the valuation methodologies used for assets measured at fair value. There had been no changes in the methodologies used for the period January 1, 2024 to October 31, 2024 and for the year ended December 31, 2023.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities were traded.

Common collective trust: Valued at net asset value (NAV) of units held. The NAV was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liability.

The preceding methods described may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

(5) Tax Status

On January 1, 2022, the Plan adopted the Basic Volume Submitter Plan Document. Corbel had obtained a favorable opinion from the Internal Revenue Service on June 30, 2020, indicating that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Service. The Plan's administrator and management believed that the Plan and amendments were designed and were currently being operated in compliance with the requirements of the Internal Revenue Service. The Plan was required to operate in conformity with the IRC to maintain its tax-exempt status. Therefore, no provision for income taxes had been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America required plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not have been sustained upon examination by the applicable taxing authorities. The plan administrator had analyzed the tax positions taken by the Plan and had concluded that as of October 31, 2024, there were no uncertain positions taken or expected to be taken that would have required recognition of a liability (or asset) or disclosure in the financial statements.

The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax period in progress. The plan administrator believed it was no longer subject to income tax examinations for years prior to 2021.

(6) Related-Party Transactions

The Plan had a number of service providers. Such parties were considered parties-in-interest under ERISA.

(7) Plan Termination

The Plan Sponsor reserved the right to amend or terminate the Plan at any time. As discussed in Note 1, the Plan was terminated and all assets disbursed in 2024. The net assets of the Plan were allocated, as prescribed by ERISA and its related regulations.
