To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Parched Hospitality Group Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 1, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the 120 days ended May 1, 2023 and for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Parched Hospitality Group Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

NOTE 1 - Description of the Plan

The following description of the Parched Hospitality Group Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General:

The Plan, which was adopted and established effective January 1, 2021, was established for the exclusive benefit of all eligible employees and their beneficiaries with the intention to provide a measure of retirement security for their participant's future. The control group members are as follows:

- Hole in the Wall 626 1st Avenue LLC
- Hole in the Wall Cliff Street LLC
- Hole in the Wall Flatiron LLC
- Hole in the Wall Midtown LLC
- Hole in the Wall Williamsburg LLC

- J2 Enterprises LTD (ceased March 31, 2022)

The Plan is a cash or deferred profit sharing plan which covers substantially all employees of the Sponsor. Employees are eligible to participate if they have at least one month of service. For matching and vesting purposes, participants earn a year of service for eligibility purposes when completing 1,000 hours of service. The salary deferral portion of the Plan was effective as of October 1, 2021. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Merger:

The Plan merged into OneDigital Open Pooled Employer Plan FBO Parched Hospitality Group, Inc., PEP Plan, on May 1, 2023. As of May 1, 2023, total assets transferred to the PEP Plan was \$168,399. The successor plan obtained legal control of the Plan assets as of May 1, 2023. As described in the restated plan documents, predecessor service time may be counted under the surviving plan.

Employee Contributions:

Participants are automatically enrolled in the plan thirty days after the date of hire with an automatic deferral percentage of 5%. The Plan's contribution feature will not change the participant's contribution level if they make or made an election regarding the level of contribution to the plan, or elect not to contribute to the Plan. The participants can also continue to elect not to have automatic contributions made on their behalf, and the right to choose a different amount or percentage of compensation to contribute. For the plan years beginning January 1, 2023 and 2022, the individual maximum allowable

contribution is was \$22,500 and \$20,500, respectively, and the maximum catch-up contribution for employees over age 49 was \$7,500 and \$6,500 respectively.

Employer Matching Contributions:

The Sponsor may make a discretionary matching contribution on the last day of the Plan year.

Discretionary/Profit Sharing Contributions:

The employer may make a discretionary contribution which will be deemed the employer's non-elective contribution. The contributions for any plan year shall not exceed the maximum amount allowable as a deduction to the employer under the provision of Code Section 404.

Vesting:

The company Discretionary/Profit Sharing Accounts and Employer Matching Accounts are vested according to the following schedule:

Participants are fully vested at all times in their voluntary 401(k) Accounts. Participants are also fully vested upon attainment of age 65, death, or disability.

Participant Accounts:

The employer shall establish and maintain three separate accounts for each participant.

- Deferral Account - maintained to account for the participant's Salary Deferral Contributions.
- Matching Account - maintained to account for all Employer Matching Contributions.
- Discretionary/Profit Sharing Account – maintained to account for the Profit Sharing Contributions.

Each participant's account is credited with the participant's contributions and allocation of (a) the Employer's contributions, and (b) the participant's share of earnings on their chosen investment options. Plan income and expenses are credited or debited to participant accounts based on the pro rata share of the participants individual account balance to total plan assets, except for transaction fees which are charged directly to the participant's accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

NOTE 1 - Description of the Plan (continued)

Payment of Benefits:

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or over the life of the participant and/or a designated beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 of the participant's vested interest minus any existing loan balance, or \$50,000 reduced by the participant's highest outstanding loan balance in the previous twelve months even if all or a portion of this amount has been repaid. The loans are secured by the balance in the participant's accounts. Principal and interest is paid ratably through payroll deductions. Loans are repaid over a period selected by the participant not to exceed five years with the exception of principal residence real estate loans which may be longer.

Forfeited Accounts:

Forfeitures result from a participant's termination of service prior to achieving full vesting in the Plan's contributions. Such forfeitures are transferred out of the participant's account and are held in a separate account. Forfeitures are first applied to pay Plan expenses for the year in which the forfeiture arises, or may be used at the discretion of the Plan to reduce the Plan's discretionary matching contribution. There were no forfeited non-vested account totals as of May 1, 2023 and December 31, 2022, respectively.

Plan Termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 2 - Significant Accounting Policies

Basis of Accounting:

The financial statements of the plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Valuation of Investments:

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. As applicable, interest income is recorded on the accrual basis, and dividend income is accrued on the ex-dividend date. The income or loss of each investment option, including the change in market value of investments, is allocated to participant accounts based on each participant's proportionate interest in the investment option. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses:

Reasonable expenses for the administration, investments, and processing transactions relating to the ongoing maintenance and operation of the plan (including expenses or fees charged on a one-time or ongoing basis for legal, accounting, or recordkeeping services) may be charged against the assets of the plan and trust, paid by the employer, or allocated among terminated and active participants (or beneficiaries) in the plan. In some instances, these expenses are deducted directly from the investment returns of the investment funds offered under the plan as an investment related fee.

When the plan elects to pay their administrative expenses through the plan and trust, to the extent they are not paid from the forfeiture account, they can allocate them among their terminated and active participants (or beneficiaries) on a pro-rata or per capita basis.

The plan is also permitted to charge against a participant's (or beneficiary's) account any individual expenses that directly relate to a transaction processed through their account.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. As of May 1, 2023 and December 31, 2022, notes receivable was \$0 and \$0, respectively.

Payment of Benefits:

Benefits are recorded when paid.

Date of Management's Review:

The Sponsor has evaluated subsequent events and transactions through March 24, 2025, the date the financial statements were available to be issued.

NOTE 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the asset or liability.
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.
If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 1, 2023 and December 31, 2022.

- *Pooled Separate Accounts investing in Mutual funds.* Valued at their "accumulation unit value" (AUV). The separate account is valued daily as the number of accumulation units held multiplied by the AUV. The AUV is first established when a new fund starts and is then determined daily based on the net asset value of shares of the underlying fund, the fund's dividends and the Contract's separate account charges. Transactions occur daily in and out of the accounts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies

NOTE 5 - Party-in-Interest

Certain Plan investments are shares of mutual funds managed by John Hancock. John Hancock is the Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 6 - Income Tax Status

The Sponsor has adopted a non-standardized plan pre-approved by the Internal Revenue Service (“IRS”). The IRS issued an opinion letter dated June 30, 2020, that the non-standardized plan is acceptable with the applicable section of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Sponsor and the Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - Delinquent Contributions

In 2023, the sponsor failed to remit participant contributions in a timely manner. The sponsor identified two instances for a total of \$4,181, in which participant contributions were remitted to the Plan in violation of the Department of Labor (DOL) regulations. For 2023, the sponsor calculated the amount of lost earnings, which were determined to be immaterial, and remitted them to the plan in 2025.
