REASONABLE CAUSE RELIEF STATEMENT

TAXPAYER RESPECTFULLY REQUESTS RELIEF FROM PENALTY IMPOSED FOR THE FAILURE TO TIMELY FILE FORM 5500-SF FOR THE TAX YEAR 1/01/2021-11/30/2021. THE TAXPAYER RESPECTFULLY ASSERTS THAT THE FAILURE TO COMPLY WITH THE FILING REQUIREMENT WAS DUE TO REASONABLE CAUSE, AND NOT DUE TO WILLFUL NEGLIGENCE.

IN ACCORDANCE WITH THE PROVISIONS OF SECTIONS 6038, 6038A, 6038B, AND 6038C, AND CONSISTENT WITH THE GUIDELINES IN IRM §20.1.1.3.2 (11/21/17), THE TAXPAYER EXERCISED ORDINARY BUSINESS CARE AND PRUDENCE IN DETERMINING ITS TAX OBLIGATIONS. DESPITE THIS, THE TAXPAYER WAS UNABLE TO FILE FORM 5500-SF BY THE REQUIRED DEADLINE DUE TO MISCOMMUNICATION RESULTING FROM FINAL YEAR TAX PREPARATION SERVICES. THE TAXPAYER'S FORM 5500 COMPLIANCE WAS HISTORICALLY HANDLED BY ADP AND UNBEKNOWNST TO THE PLAN ADMINISTRATOR, ADP DID NOT SUBMIT THE FILING AFTER TERMINATION OF THE PLAN.

THE TAXPAYER'S FAILURE TO FILE WAS NOT DUE TO ANY WILLFUL NEGLIGENCE BUT WAS AN UNINTENDED OVERSIGHT. UPON REALIZING THE OMISSION, THE TAXPAYER TOOK IMMEDIATE CORRECTIVE ACTION BY FILING THE REQUIRED FORM AS PROMPTLY AS POSSIBLE. THE TAXPAYER HAS A HISTORY OF TIMELY FILING AND FULL COMPLIANCE WITH TAX LAWS AND HAS ALWAYS ACTED IN GOOD FAITH TO MEET ITS OBLIGATIONS.

BASED ON THESE FACTS AND THE CIRCUMSTANCES OF THE CASE, WE RESPECTFULLY REQUEST THAT THE IRS GRANT REASONABLE CAUSE RELIEF AND ABATE ANY PENALTIES RELATED TO THE LATE FILING OF FORM 5500-SF.
