INDEPENDENT AUDITORS' REPORT

The Board of Trustees of
SDC – League Health Fund

Opinion

We have audited the financial statements of SDC – League Health Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of August 31, 2024 and 2023, and the related statements of changes in benefit obligations and in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the benefit obligations and net assets available for benefits of SDC – League Health Fund as of August 31, 2024 and 2023, and the changes in benefit obligations and in net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

**NOTES TO FINANCIAL STATEMENTS
AUGUST 31, 2024 AND 2023**

NOTE 1 – DESCRIPTION OF PLAN

The following description of the SDC – League Health Fund (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions.

General: The Plan is a collectively bargained multi-employer plan that provides health benefits to eligible participants in the theatre industry covered by collective bargaining or other agreements between contributing employers and the Stage Directors and Choreographers Society (the “Union” or the “SDC”). The Plan is funded by a trust (the “Trust”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Administration: The administration of the Plan is the responsibility of a Board of Trustees comprising Union and Employer Trustees. The Union Trustees and Employer Trustees have equal voting rights. The Plan’s investments are maintained and managed by independent investment managers who have full discretion and authority to effect transactions for the benefit of the Plan within the investment guidelines established by the Trustees.

Benefits: The Plan provides health benefits, as listed in Note 12, to active participants of the Plan and to their beneficiaries and covered dependents. The benefit that a participant is entitled to is based upon the level of contributions received from the employer and participant, and the options elected by the participant.

The Plan provides health benefits to participants during periods of unemployment, provided they have met the eligibility requirement.

During the year, the following insured benefits were in effect:

All other benefits are self-insured through a medical spending account.

Contributions: Contributions are made by employers for covered participants as determined by the collective bargaining (or other) agreements in effect at the time. Eligible participants may make direct contributions under COBRA for hospitalization and major medical benefits when covered employment ceases.

Procedure on Termination: In the event of termination of the Plan, the Trust Agreement requires that the Trustees pay all obligations of the Plan and distribute and apply any remaining surplus in such a manner as will, in their opinion, best effectuate the purpose of the Plan, consistent with the Trust Agreement, the Plan, ERISA, the Internal Revenue Code of 1986, as amended (“IRC”) and other applicable law. In no circumstance shall any funds revert or accrue to the benefit of the Union or the employers.

Other: Although they have not expressed any intention to do so, the Trustees have the right to amend or terminate the Plan subject to the provisions set forth in the Plan, the Trust, and applicable law.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements were prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 6 on Fair Value Measurements.)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year. Unrealized gains or losses are the differences between the fair value of the investments held at year-end and those held at the beginning of the year. Realized gains or losses on the sale of investments are based on the historical costs of the individual investments sold for financial reporting purposes, whereas the revalued cost (fair value at the beginning of the year) is used for determining the realized gain or loss for Form 5500 purposes.

Fixed Assets, Depreciation, and Amortization: Fixed assets and improvements are stated at cost less depreciation and amortization accumulated since their acquisition and do not purport to present replacement or realizable value. All assets are depreciated or amortized over their estimated useful lives. Expenditures for normal replacement of equipment are charged to current operations. All other expenditures for fixed assets are capitalized.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities as of the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Plan Benefits: Plan obligations at August 31 for health claims incurred by active participants but not reported at that date and for accumulated eligibility of participants are estimated by the Plan's actuary in accordance with accepted actuarial principles. Such estimated amounts are reported in the accompanying statement of the Plan's benefit obligations at present value.

Accumulated Eligibility Credits: The Plan provides for the payment of benefits for a period of time subsequent to the financial statement date for those participants who have accumulated a sufficient amount of employer contributions. Such rules permit eligible participants to receive benefits during periods of unemployment or inactivity, when employer contributions to the Plan would otherwise not provide coverage or benefits. At the financial statement date, such accumulated eligibility credits represent a liability of the Plan arising from prior employee service for which employer contributions have been received. The liability is determined by applying the average cost of benefits to each eligible participant.

Reclassification: Certain amounts in the 2023 financial statements have been reclassified for comparative purposes to conform to the presentation in the 2024 financial statements.

NOTE 3 – CONCENTRATION OF CREDIT RISK

Financial instruments that subject the Plan to concentration of credit risk include cash and short-term investments. While the Plan attempts to limit any financial exposure, its cash deposit balances may, at times, exceed federally insured limits. Short-term investments are not covered by the Federal Deposit Insurance Corporation.

NOTE 4 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The balance of claims incurred but not reported and accumulated eligibility credits are reported based on certain assumptions, which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 5 – TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to be qualified pursuant to Section 501(c)(9) of the IRC and, accordingly, the Trust's net income is exempt from income taxes. The Plan has obtained a tax exemption letter for the Trust from the Internal Revenue Service, and the Plan administrator and the Plan's counsel believe that the Trust, as amended, continues to qualify and to operate in accordance with the applicable provisions of the IRC.

NOTE 6 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 6 – FAIR VALUE MEASUREMENTS (continued)

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at August 31, 2024 and 2023.

Registered investment companies: Certain registered investment companies are valued at the closing price reported in the active market on which they are traded. Others are valued at estimated fair value as determined by the investment manager based on the market value and estimated fair value of the underlying investments in the portfolio. In establishing the fair value of these investments, the investment manager takes into consideration information about the net asset value of shares held by the Plan at year end.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's eligible employees are provided with a matching 3% 401k contribution, effective January 1, 2024, and 2%, prior to January 1, 2024, through Nationwide Life Insurance, a defined contribution retirement plan. Contributions to the 401k were \$5,729 and \$4,753 for the fiscal years ended August 31, 2024 and 2023, respectively.

The Pension Plan reimbursed the Plan \$2,864 for its share of the 401k employee contributions and \$10,534 for its share of the contributions to the defined benefit multiemployer retirement plan for the fiscal year ended August 31, 2024.

NOTE 10 – TRANSACTIONS WITH RELATED PARTIES AND PARTIES IN INTEREST

The Plan and the Pension (together the “Funds”) share facilities, staff, and other overhead expenses (computer, postage, etc.) with the Union. These shared expenses are allocated to the Funds based upon various methods, such as time and space usage and are initially paid by the Union and then allocated to the Funds. The amount reimbursed to the Union by the Plan was \$172,489 and \$152,477 for the years ended August 31, 2024 and 2023, respectively.

The Funds also share office space, personnel, and certain other administrative expenses. These shared expenses are allocated based on various methods, such as employer contributions, total assets, time analysis, and space usage.
