Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Fort Bend Christian Academy 403b Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended August 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Fort Bend Christian Academy 403b Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of August 31, 2024 and 2023, and for the year ended August 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Notes to Financial Statements for the year ended August 31, 2024

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of Fort Bend Christian Academy 403b Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan established September 1, 2008, covering substantially all employees of Fort Bend Christian Academy (the Academy) who are not non-resident aliens, part-time or covered by a collective bargaining agreement. Covered employees are eligible to participate in the Plan immediately upon hire. The Plan entry dates are the first day of the first and seventh months of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective February 22, 2024, Reliance Trust Company (Reliance) became the custodian of the Plan replacing American United Life Insurance Company (AUL). Effective March 18, 2024, T. Rowe Price Retirement Plan Services, Inc. (T. Rowe Price) became the recordkeeper of the Plan replacing AUL.

Contributions – The Plan provides for both participant contributions and employer contributions as follows:

- *Participant contributions* – Participants may contribute up to 100% of their compensation as defined in the Plan, subject to Internal Revenue Service (IRS) limitations. In addition, participants who attain age 50 before the close of the calendar year or have at least fifteen years of credited service with the Academy may make additional catch-up contributions, as defined by the Plan. Participants may rollover or transfer any amounts they receive as distributions from an existing qualified plan from a prior employer. Participants also are permitted to make Roth elective deferrals.
- *Employer contributions* – For all employees who are age 21 and older, the Academy may elect to make a discretionary matching contribution. The Academy also may elect to make a discretionary non-elective contribution to all eligible employees who have completed 1,000 hours of service and are actively employed on the last day of the employment contract year, regardless of whether the employee contributes to the Plan or not. In the 2024 plan year, the Academy elected to make a matching contribution of 2% as well as a discretionary non-elective contribution equal to 2.53% of eligible employees' compensation.

Participants direct the investment of all contributions into various investment options offered by the Plan.

Vesting – Participants are immediately 100% vested in participant and rollover contributions plus actual earnings thereon. Vesting in employer contributions plus actual earnings thereon is based on years of continuous service. A participant vests 100% after three years of credited service.

Participant accounts – Each participant's account is credited with the participant's contribution and an allocation of the investment earnings and expenses for each fund in which their account is invested. Allocations of investment income and expenses are based on the proportion that each participant's account balance bears to the total of all participant account balances. The only benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Distribution of benefits – The Plan provides for benefit distributions to plan participants or their beneficiaries, equal to the vested balance of their account upon death, disability, retirement, or other termination of employment. Participants may withdraw a portion or all of their vested account balances, while still employed, upon reaching the age of 65. If the benefit of a terminating employee is \$5,000 or less, it will automatically be paid to the participant in a lump sum.

Forfeitures – The Plan uses forfeited amounts, if any, to reduce Plan expenses first and then to reduce future employer matching contributions. During 2024, \$8,602 in forfeitures was used to reduce employer contributions and \$1,000 in forfeitures were used to reduce fees. At August 31, 2024, there were approximately \$7,800 in unused forfeitures. At August 31, 2023, there were no unused forfeitures.

Plan termination – Although it has not expressed any intent to do so, the Academy has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The Plan’s financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the investment adviser and insurance company. See Note 6 for discussion of fair value measurements.

The Plan invests in fully benefit-responsive investment contracts and presents this investment in the financial statements at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value for the fully-benefit responsive investment contract represents contributions plus earnings, less participant withdrawals and administrative expenses.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Contributions from plan participants and employer contributions from the Academy are recorded in the year in which the participant contributions are withheld from compensation.

Benefit payments – Benefit payments to participants are recorded upon distribution.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Academy and are excluded from these financial statements. Fees related to benefit payments are charged directly to the participant’s account and are included in administrative expenses. Certain investment management fees are included in net appreciation in fair value of investments. Other investment-related expenses paid by the Plan are included in administrative expenses.

Estimates – Management must make estimates and assumptions to prepare financial statements in accordance with generally accepted accounting principles. These estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported amounts of additions and deductions. Actual results could vary from the estimates that were used.

NOTE 3 – TAX STATUS

The Academy has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated November 22, 2017 stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Code. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified.

NOTE 4 – INVESTMENTS

At August 31, 2024, certain assets of the Plan were invested in funds managed by T. Rowe Price, the Plan recordkeeper, and AUL, as an insurance company of the Plan. These transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transactions rules of ERISA.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.

NOTE 5 – INFORMATION CERTIFIED BY CUSTODIAN AND INSURANCE COMPANY

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of August 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended August 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by AUL and Reliance, qualified institutions.

NOTE 6 – FAIR VALUE MEASUREMENTS

Generally accepted accounting principles require that certain assets and liabilities be reported at fair value. The three levels of the fair value hierarchy are as follows:

- *Level 1* – Inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the reporting date.
- *Level 2* – Inputs are other than quoted prices included in Level 1, which are either directly observable or can be derived from or corroborated by observable market data at the reporting date.
- *Level 3* – Inputs are not observable and are based on the reporting entity’s assumptions about the inputs market participants would use in pricing the asset or liability.

- (a) The investment accounts included in the pooled separate accounts consist of (1) managed asset allocation accounts, (2) equity accounts, (3) fixed-income accounts, and (4) global and international equity accounts. Managed asset allocation accounts seek high total return over time through a combination of capital appreciation and income by investing in an asset allocation strategy designed for investors planning to retire at certain intervals. Equity accounts seek a favorable rate of return through capital appreciation and investment income by investing primarily in a broadly diversified portfolio of U. S. common stocks. Fixed-income accounts seek a maximum total return, consistent with preservation of capital by investing in fixed-income securities. Global and international equity accounts seek a favorable long-term rate of return through capital appreciation and income from broadly diversified portfolios that consist primarily of foreign and domestic equity securities. There are no participant-directed redemption restrictions; however, the Plan is required to provide a notice 7 days in advance to liquidate its entire share in the accounts.

Following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methods used at August 31, 2024 and 2023.

- *Mutual funds* are valued at the net asset value of the shares held by the Plan at year end.
- *Pooled separate accounts* are variable annuities valued at net asset value per share as determined by the issuer based on market quotations of the underlying investments or prices obtained from independent sources who may employ various pricing methods to value the underlying securities.

These valuation methods may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate, the use of different methods or assumptions could result in a different fair value measurement at the reporting date.

NOTE 7 – INVESTMENT CONTRACTS WITH INSURANCE COMPANY

In 2008, the Plan entered into a fully benefit-responsive contract with AUL. The Plan terminated its fully benefit-responsive contract with AUL effective June 17, 2024. At August 31, 2024, the general account portion of the contract is held in the AUL Alternate Fixed Account (Fixed Account), an interest-earning account in which the assets are commingled with other assets of the insurance company. The Fixed Account value, subject to a withdrawal charge, is payable on June 17, 2025, 365 days from the contract termination effective date. During the 365-day period, all Fixed Account amounts will continue to earn interest at the guaranteed rate in effect as of the contract termination effective date.

The crediting interest rate may not be less than the lesser of (a) the minimum guaranteed rate or (b) the average 5-year constant maturity treasury rate reduced by 1.25%. The minimum guaranteed interest rate shall not be less than 1% nor greater than 3%.

The Plan's ability to receive amounts due are dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

NOTE 8 – SUBSEQUENT EVENTS

Management has evaluated subsequent events through May 20, 2025, which is the date that the financial statements were available for issuance. As a result of this evaluation, no events were identified that are required to be disclosed or would have a material impact on reported net assets available for benefits or changes in net assets available for benefits.

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to

be independent of Fort Bend Christian Academy 403b Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Fort Bend Christian Academy 403b Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Fort Bend Christian Academy 403b Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Fort Bend Christian Academy 403b Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of August 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements for the year ended August 31, 2024

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of Fort Bend Christian Academy 403b Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan established September 1, 2008, covering substantially all employees of Fort Bend Christian Academy (the Academy) who are not non-resident aliens, part-time or covered by a collective bargaining agreement. Covered employees are eligible to participate in the Plan immediately upon hire. The Plan entry dates are the first day of the first and seventh months of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective February 22, 2024, Reliance Trust Company (Reliance) became the custodian of the Plan replacing American United Life Insurance Company (AUL). Effective March 18, 2024, T. Rowe Price Retirement Plan Services, Inc. (T. Rowe Price) became the recordkeeper of the Plan replacing AUL.

Contributions – The Plan provides for both participant contributions and employer contributions as follows:

- *Participant contributions* – Participants may contribute up to 100% of their compensation as defined in the Plan, subject to Internal Revenue Service (IRS) limitations. In addition, participants who attain age 50 before the close of the calendar year or have at least fifteen years of credited service with the Academy may make additional catch-up contributions, as defined by the Plan. Participants may rollover or transfer any amounts they receive as distributions from an existing qualified plan from a prior employer. Participants also are permitted to make Roth elective deferrals.
- *Employer contributions* – For all employees who are age 21 and older, the Academy may elect to make a discretionary matching contribution. The Academy also may elect to make a discretionary non-elective contribution to all eligible employees who have completed 1,000 hours of service and are actively employed on the last day of the employment contract year, regardless of whether the employee contributes to the Plan or not. In the 2024 plan year, the Academy elected to make a matching contribution of 2% as well as a discretionary non-elective contribution equal to 2.53% of eligible employees' compensation.

Participants direct the investment of all contributions into various investment options offered by the Plan.

Vesting – Participants are immediately 100% vested in participant and rollover contributions plus actual earnings thereon. Vesting in employer contributions plus actual earnings thereon is based on years of continuous service. A participant vests 100% after three years of credited service.

Participant accounts – Each participant's account is credited with the participant's contribution and an allocation of the investment earnings and expenses for each fund in which their account is invested. Allocations of investment income and expenses are based on the proportion that each participant's account balance bears to the total of all participant account balances. The only benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Distribution of benefits – The Plan provides for benefit distributions to plan participants or their beneficiaries, equal to the vested balance of their account upon death, disability, retirement, or other termination of employment. Participants may withdraw a portion or all of their vested account balances, while still employed, upon reaching the age of 65. If the benefit of a terminating employee is \$5,000 or less, it will automatically be paid to the participant in a lump sum.

Forfeitures – The Plan uses forfeited amounts, if any, to reduce Plan expenses first and then to reduce future employer matching contributions. During 2024, \$8,602 in forfeitures was used to reduce employer contributions and \$1,000 in forfeitures were used to reduce fees. At August 31, 2024, there were approximately \$7,800 in unused forfeitures. At August 31, 2023, there were no unused forfeitures.

Plan termination – Although it has not expressed any intent to do so, the Academy has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The Plan’s financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the investment adviser and insurance company. See Note 6 for discussion of fair value measurements.

The Plan invests in fully benefit-responsive investment contracts and presents this investment in the financial statements at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value for the fully-benefit responsive investment contract represents contributions plus earnings, less participant withdrawals and administrative expenses.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Contributions from plan participants and employer contributions from the Academy are recorded in the year in which the participant contributions are withheld from compensation.

Benefit payments – Benefit payments to participants are recorded upon distribution.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Academy and are excluded from these financial statements. Fees related to benefit payments are charged directly to the participant’s account and are included in administrative expenses. Certain investment management fees are included in net appreciation in fair value of investments. Other investment-related expenses paid by the Plan are included in administrative expenses.

Estimates – Management must make estimates and assumptions to prepare financial statements in accordance with generally accepted accounting principles. These estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported amounts of additions and deductions. Actual results could vary from the estimates that were used.

NOTE 3 – TAX STATUS

The Academy has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated November 22, 2017 stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Code. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified.

NOTE 4 – INVESTMENTS

At August 31, 2024, certain assets of the Plan were invested in funds managed by T. Rowe Price, the Plan recordkeeper, and AUL, as an insurance company of the Plan. These transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transactions rules of ERISA.

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.

NOTE 5 – INFORMATION CERTIFIED BY CUSTODIAN AND INSURANCE COMPANY

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of August 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended August 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by AUL and Reliance, qualified institutions.

NOTE 6 – FAIR VALUE MEASUREMENTS

Generally accepted accounting principles require that certain assets and liabilities be reported at fair value. The three levels of the fair value hierarchy are as follows:

- *Level 1* – Inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the reporting date.
- *Level 2* – Inputs are other than quoted prices included in Level 1, which are either directly observable or can be derived from or corroborated by observable market data at the reporting date.
- *Level 3* – Inputs are not observable and are based on the reporting entity’s assumptions about the inputs market participants would use in pricing the asset or liability.

- (a) The investment accounts included in the pooled separate accounts consist of (1) managed asset allocation accounts, (2) equity accounts, (3) fixed-income accounts, and (4) global and international equity accounts. Managed asset allocation accounts seek high total return over time through a combination of capital appreciation and income by investing in an asset allocation strategy designed for investors planning to retire at certain intervals. Equity accounts seek a favorable rate of return through capital appreciation and investment income by investing primarily in a broadly diversified portfolio of U. S. common stocks. Fixed-income accounts seek a maximum total return, consistent with preservation of capital by investing in fixed-income securities. Global and international equity accounts seek a favorable long-term rate of return through capital appreciation and income from broadly diversified portfolios that consist primarily of foreign and domestic equity securities. There are no participant-directed redemption restrictions; however, the Plan is required to provide a notice 7 days in advance to liquidate its entire share in the accounts.

Following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methods used at August 31, 2024 and 2023.

- *Mutual funds* are valued at the net asset value of the shares held by the Plan at year end.
- *Pooled separate accounts* are variable annuities valued at net asset value per share as determined by the issuer based on market quotations of the underlying investments or prices obtained from independent sources who may employ various pricing methods to value the underlying securities.

These valuation methods may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate, the use of different methods or assumptions could result in a different fair value measurement at the reporting date.

NOTE 7 – INVESTMENT CONTRACTS WITH INSURANCE COMPANY

In 2008, the Plan entered into a fully benefit-responsive contract with AUL. The Plan terminated its fully benefit-responsive contract with AUL effective June 17, 2024. At August 31, 2024, the general account portion of the contract is held in the AUL Alternate Fixed Account (Fixed Account), an interest-earning account in which the assets are commingled with other assets of the insurance company. The Fixed Account value, subject to a withdrawal charge, is payable on June 17, 2025, 365 days from the contract termination effective date. During the 365-day period, all Fixed Account amounts will continue to earn interest at the guaranteed rate in effect as of the contract termination effective date.

The crediting interest rate may not be less than the lesser of (a) the minimum guaranteed rate or (b) the average 5-year constant maturity treasury rate reduced by 1.25%. The minimum guaranteed interest rate shall not be less than 1% nor greater than 3%.

The Plan's ability to receive amounts due are dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

NOTE 8 – SUBSEQUENT EVENTS

Management has evaluated subsequent events through May 20, 2025, which is the date that the financial statements were available for issuance. As a result of this evaluation, no events were identified that are required to be disclosed or would have a material impact on reported net assets available for benefits or changes in net assets available for benefits.

Revenue Sharing Formula:

The investment options of the Plan include various portfolios within an AUL separate account. The separate account in turn invests in investment portfolios of certain open-end management investment companies. AUL receives indirect compensation from these investment companies for the services provided by AUL.

The compensation received by AUL is computed by each investment company by multiplying the daily account balance of the AUL separate account's interest in a particular portfolio by a predetermined percentage rate negotiated with the investment company. This indirect compensation is not charged to the plan or participants accounts but is paid directly by the investment company.

The investment company, the underlying investment portfolio, and the annual compensation percentages are shown below.
