We have performed an audit of the accompanying financial statements of the Bristow Endeavor Healthcare, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) Audit). As further discussed in Note 9 to the financial statements, the Plan Sponsor of the Plan approved a plan of liquidation on November 16, 2023, and management determined liquidation is imminent. As a result, the Plan's 2024 and 2023 financial statements are prepared using the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

NOTE 1 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The accounting records of the Bristow Endeavor Healthcare, LLC 401(k) Plan (the “Plan”) were prepared on the liquidation basis of accounting.

Administrative Expenses: All expenses incurred in the administration of the Plan are paid by Bristow Endeavor Healthcare, LLC (the “Company”). Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Certain asset management fees are paid by the Plan and allocated to participant’s accounts on a quarterly basis.

Investment Valuation and Income Recognition: The Plan’s investments in pooled separate accounts of registered investment companies are stated at fair value. Shares of mutual funds and money market funds are valued at fair market value as determined by their respective quoted market prices, which in total represent the net asset value of shares held by the Plan at year end. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Use of Estimates: The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Payment of Benefits: Benefits are recorded by the Plan when paid.

Notes Receivable from Participants: Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participants accounts. No allowance for credit losses has been recorded as of May 31, 2024 and December 31, 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

NOTE 2 - DESCRIPTION OF THE PLAN

The following description of the Bristow Endeavor Healthcare, LLC 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Bristow Endeavor Healthcare, LLC, Reliance Medical Management, and Manna Isle Healthcare (Collectively, the Company). Eligible participants are at least 21 years of age and have completed one year of service. A year of service requires at least 1,000 hours worked by the employee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan became effective on January 1, 2016. The Plan allows participants to enroll into the plan the first day of the Plan year, or the first day of the seventh month of the Plan year coinciding with or following the next date after the service requirement is met. Effective September 11, 2017, the age and service requirements were waived for any Eligible Employee employed on or before July 21, 2015. Any such Eligible Employee entered the Plan on January 1, 2016.

Employer Cash Contributions: In order to maintain the Safe Harbor Plan status, the Plan Sponsor is required to make a safe harbor matching contribution equal to 100% of the participant's salary deferrals that do not exceed 3% of the participant's compensation plus 50% of the participant's salary deferrals between 3% and 5% of the participant's compensation. The safe harbor contribution is fully vested and is referred to as a Basic Matching Contribution. Additional amounts may be contributed at the discretion of the Company's management and are allocated to qualified participants as defined by the Plan. The Plan Sponsor may determine separate discretionary matching contributions for Participants working in different business units or locations. The Plan Sponsor is not obligated to make future contributions to the Plan and has no control over the Plan assets other than through its ability to appoint administrators of the Plan. For 2024 and 2023, the participants remitted contributions of \$-0- and \$255,771, respectively.

Participants' Cash Contributions: Active participants may contribute from 1% up to 90% of eligible compensation as defined in the Plan document, not to exceed the maximum dollar amount as set forth by the Internal Revenue Code ("IRC"). Participants have the opportunity to change the contribution percentage they have previously elected daily via their online portal. The maximum amount a participant can contribute on a before-tax basis during the participant's taxable year is \$22,500 and \$20,500 during 2024 and 2023, respectively, in accordance with IRC Section 402(g)(3). For 2024 and 2023, the participants remitted contributions of \$-0- and \$457,894, respectively.

Participant Rollovers: Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

NOTE 2 - DESCRIPTION OF THE PLAN (CONTINUED)

Catch-up Contributions: All employees that are eligible to make elective deferrals under the Plan and who have attained the age of 50 before the close of the plan year are eligible to make catch-up contributions in accordance with, and subject to the limitations of IRC Section 414(v). The maximum catch-up contribution that a participant could defer during the Plan’s period ended May 31, 2024 and December 31, 2023 was \$7,500 and \$7,500, respectively.

Participant Accounts: Each participant’s account is credited with the participant’s contribution and Company matching contributions, as well as allocations of the Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or the participant may elect to receive partial withdrawals subject to minimum distribution requirements. The participant must begin withdrawing funds from his or her account upon attaining age 70 and one-half. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures: Forfeitures of terminated participants' nonvested employer contribution accounts are disposed of in accordance with the Plan Sponsor’s direction. The Plan Sponsor may elect to add the forfeited amounts to any Employer discretionary contribution, used to reduce any non-safe harbor matching contribution, or allocated to all participants in the same proportion that each participants compensation for the plan year bears. Forfeitures may not be used to reduce Employer contributions which are required to be fully vested when contributed to the plan.

Vesting of Benefits: Participants are immediately vested in their own Elective deferral Accounts, Qualified Matching Contribution Accounts, and Qualified Nonelective Contribution Accounts. Other discretionary employer and profit-sharing contributions vest to participants in accordance with the following schedule:

NOTE 2 - DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants: Participants are able to borrow from their account balances with interest charged at a rate equal to the “prime rate” plus 2%, which remains fixed for the duration of the loan. Loan terms range from 60 months for a non-residential loan to 240 months for a residential loan. The minimum loan is \$1,000 and the maximum loan is the lesser of 50% of the vested account value or \$50,000. The loans are secured by the participant’s account balance less any current outstanding loan balance. Principal and interest are paid ratably through payroll deductions. Participants may only have one loan outstanding. As of May 31, 2024 and December 31, 2023, the Plan had notes receivable from participants of \$-0- and \$109,720, respectively. The Plan recognized \$102,525 and \$47,508, in deemed distributions related to defaulted loans for the period ending May 31, 2024 and December 31, 2023, respectively. These amounts are included in the Benefits Paid to Participants on the statement of changes in net assets available for plan benefits.

Hardship Distributions: The Plan provides for participant withdrawals in the event of financial hardship. Financial hardships include the participant’s purchase or construction of a primary residence and certain educational or medical expenses. Hardship withdrawals must be approved by the Company. If a hardship withdrawal is approved, the participant is ineligible to make contributions to the Plan or receive employer matching contributions from the Company for the six months following the distribution. Hardship withdrawals may only be made once per plan year and only from account funds which are 100% vested. Participants must also be employed with the Company at the time of the hardship distribution.

NOTE 3 – TAX STATUS

The Plan Sponsor adopted a Volume Submitter Profit Sharing/Money Purchase Plan with CODA sponsored by Nova 401k Associates, Inc. The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRS and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted by the United States of America require plan management to evaluate the tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan’s investments are shares of mutual funds managed by John Hancock Life Insurance Company (“John Hancock”). John Hancock is the Contract Administrator as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Additionally, Nova 401(k) Associates, LLC and Nova Associates, Inc., also received various direct or indirect payments from the Plan and are considered a party-in-interest. Fees incurred by the plan for the investment management services are included in net appreciation (depreciation) in fair value of the investments as they are paid through revenue sharing rather than a direct payment. The Plan made direct payments to these parties-in-interest in the amount of \$6,675 and \$23,547 for the period ending May 31, 2024 and December 31, 2023, respectively, which was not covered by revenue sharing. The Plan sponsor pays directly other fees related to the Plan’s operations.

NOTE 6 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2024 and December 31, 2023.

Pooled Separate Accounts with Underlying Mutual Fund Investment: Valued based on the observable net asset value of the underlying investment.

Mutual Fund Investment: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

NOTE 7 – GROUP ANNUITY CONTRACT - STABLE VALUE FUND

The Plan is invested in a John Hancock Stable Value Guaranteed Income Fund (the “Fund”), an investment option within the group annuity contract. The Fund’s subaccount is invested into John Hancock Stable Value Fund Collective Investment Trust (JH CIT). Contributions under the group annuity contract can be allocated to the Fund and be held in the John Hancock general account. The Fund earns interest on the principal, less any applicable contract or participant-level recordkeeping charges for the duration the contributions remain in the investment option.

Interest rates are established every January 1 and July 1 and will generally be valid for six months (except in extreme market conditions, in which case it will occur on the first day of each calendar month). All regular ongoing contributions and contributions already invested in the Fund will earn the declared interest rate until the next rate is reset.

The John Hancock group annuity contract as a whole is not fully benefit responsive because the John Hancock Stable Value Guaranteed Income Fund and subaccounts are not registered investment companies or trusts in their own right. Therefore, the Fund will be reported at fair value.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant’s account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE 9 – PLAN AMENDMENTS

The Plan was amended to be terminated effective December 31, 2023. As a result, liquidation became imminent, and the Plan Sponsor adopted the liquidation basis of accounting for the 2024 and 2023 financial statements.

Effective January 1, 2021, the Plan was restated to complete the Cycle 3 restatement as required by Internal Revenue Service (IRS) rules. Because there were no substantial legislative reforms impacting retirement plans enacted between the completion of the last restatement cycle and when the IRS began reviewing the new plan language, this restatement is simply referred to as the third restatement cycle.

Other than the above, the Plan had no significant amendments for the period ended May 31, 2024 and December 31, 2023.

NOTE 10 – TERMINATION OF PLAN

Effective December 31, 2023, the Plan Sponsor elected to terminate the Plan. In accordance with the Plan document, the account of each participant became fully vested to the extent then funded. Participants were notified of the termination and given the election to receive direct payouts or rollover their funds into a qualified retirement plan. For non-responding participants, their funds will be automatically rolled into a traditional individual retirement account with Qualified Trust Company. Effective May 31, 2024, the Plan was officially discontinued, and all assets were distributed from the Plan.
