Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Emphasis of Matter - Plan Termination and Use of Liquidation Basis of Accounting

As discussed in Note 4 to the financial statements, the Board of Directors of AGI, made a decision to terminate the Plan effective November 30, 2020. All plan assets were distributed to participants and beneficiaries during the period ended January 31, 2025. As a result, in accordance with accounting principles generally accepted in the United States of America, the Plan's financial statements are presented on the liquidation basis of accounting for the period ended January 31, 2025 and February 29, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

(1) Description of Plan

The following brief description of the Analytical Graphics, Inc. Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

General

Analytical Graphics, Inc. (AGI) established the AGI Profit Sharing Trust on March 1, 2005 in order for employees to share in the growth of AGI through ownership of AGI common stock. The Plan was amended and restated as of March 1, 2013. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Blue Ridge ESOP Associates served as the record keeper of the Plan and Horizon Trust & Investment Management (the trustee) served as the trustee of the Plan.

The Plan Committee, established and appointed by AGI, served as the plan administrator and was the primary source of information regarding the Plan. The Plan Committee was authorized to develop rules and regulations, resolve questions of eligibility and contributions, and otherwise manage any other issues that arose pertaining to the Plan.

On October 23, 2020, AGI entered into a merger agreement with Ansys, Inc (Ansys). The merger was completed on December 1, 2020. At the date of acquisition, 96% of the proceeds were received. The remaining funds were put into escrow and released as certain milestones/dates occurred.

Effective November 13, 2020, the Board of Directors of AGI provided unanimous written consent to terminate the Plan. The amendment to terminate the plan was effective December 1, 2020. The termination approval request was submitted to the IRS on December 1, 2020, and subsequently approved on December 6, 2021. As of January 31, 2025, all plan assets were distributed to the participants and beneficiaries.

During the year ended February 29, 2024, the Plan received the final escrow proceeds from the merger in the form of 523 shares of Ansys common stock and \$488,153 of cash consideration.

Eligibility

All persons, other than leased employees, who were employees of AGI on March 1, 2005 and worked ninety consecutive days of service, became a participant on that day. Thereafter, any employee other than a leased employee, independent contractor, non-resident alien with no U.S. income, or an employee covered by a collective bargaining agreement was able to participate in the Plan as of the first day of the plan year quarter, after the employee had attained age 21 and completed ninety consecutive days of service. Leased employees, independent contractors, non-resident aliens with no U.S. income, and employees covered by a collective bargaining agreement were not eligible to participate in the Plan.

Payment of Benefits

As a result of the Plan termination, payments were made in distributions as the escrows were released. The participant had the option to take the distribution directly in cash or roll it over to a qualified retirement account.

Plan Distribution Limit

Distributions to participants totaled \$695,322 during the period ended January 31, 2025. No distributions were made during the year ended February 29, 2024.

Company Contributions

Effective November 13, 2020, the Board of Directors of AGI provided unanimous written consent to terminate the Plan. The amendment to terminate the plan was effective December 1, 2020. Therefore, as of December 1, 2020, AGI was no longer contributing to the Plan.

Participants were not permitted to contribute to the Plan.

Participant Accounts

The Plan held \$509,559 in a money market account and 523 shares of Ansys, Inc. common stock as of February 29, 2024.

As a result of the Plan's election to terminate (see Note 4), effective November 13, 2020, all participants' accounts became fully vested.

(2) Summary of Significant Accounting Policies

Basis of Accounting

As a result of the plan termination, further discussed in Note 4 of the financial statements, the accompanying financial statements are prepared on the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

In 2025, the Plan incurred \$799 in administrative fees for the final distribution. All previous costs associated with maintaining the Plan were covered by an escrow account established by AGI at the time of acquisition.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through April 10, 2025, the date the financial statements were available to be issued. None were noted.

(3) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 31, 2025 and February 29, 2024.

Interest bearing cash: Valued at the estimated net asset value (NAV).

Ansys common stock: The stock is valued at the closing price reporting on the active market on which the individual securities are traded.

(4) Plan Termination

On November 13, 2020, the Board of Directors of AGI provided unanimous consent to approve an amendment to terminate the Plan. The amendment to terminate the plan was effective November 30, 2020. Upon termination, all participants were considered fully vested as of the plan termination date and employees with an account balance received lump sum payments in accordance with the amendment from the Plan. The interest of each participant in the Plan has been distributed to such participant or his or her beneficiary at the time prescribed by the plan terms and the IRC. As part of the merger agreement between AGI and Ansys, described in Note 1, Ansys withheld certain amounts from the merger consideration and deposited those amounts in separate escrow accounts (the Escrow Funds). The Escrow Funds were held until the various dates set forth in the merger agreement. As the Escrow Funds were released into the Plan, the amounts were distributed to the Plan participants in the form of lump sum payments. As of February 29, 2024, all escrows had been released. The final escrow was released on February 16, 2024. The Plan received \$488,153 in cash proceeds and 523 shares of Ansys stock. The shares were subsequently sold on March 26, 2024.

As of January 31, 2025, all plan assets have been distributed to participants and the plan is fully liquidated.

(5) Income Tax

The IRS has determined and informed AGI by a final determination letter in connection with the plan termination on December 1, 2020, dated December 6, 2021, that the Plan was qualified and tax exempt under the appropriate sections of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Risks and Uncertainties

Ansys common stock is exposed to investment risks. As a result, it was at least reasonably possible that the value of the stock could fluctuate in the near term and that such changes could materially affect participant account balances, and the amounts reported in the statement of net assets available for benefits.

(7) Related Party Transactions and Party-In-Interest Transactions

The Plan's assets, which consisted of Ansys common stock, and a money market fund, were administered by the trustee. Company contributions were managed by the trustee who invested cash received, interest, and dividend income and made distributions to participants. Certain administrative functions were performed by officers or employees of AGI or its subsidiaries. No such officers or employees received compensation from the Plan. These transactions qualified as party-in-interest transactions and are exempt from prohibited transaction rules.
