Independent Auditor's Report

To the Plan Administrator
Sonalysts, Inc. Retirement and Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sonalysts, Inc. Retirement and Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i) as of October 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 - Description of Plan:

The following description contains only certain summary information of Sonalysts, Inc. Retirement and Savings Plan (the “Plan”). This description cannot change, add to, or take away from the provisions of the Plan. All questions will be interpreted solely by the Plan without reference to this Plan description.

General

The Plan is a defined contribution profit-sharing plan under Section 401(a) of the Internal Revenue Code (the “Code”) for employees of Sonalysts, Inc. (the “Company” or “Plan Sponsor”). The Plan was restated effective November 1, 2021 and amended effective November 1, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Code. An appropriate Plan fiduciary monitors the investments of the Plan. The next two subsections describe the two elements of the Plan.

Effective November 1, 2008, certain participants in the Sonalysts, Inc. Employee Stock Ownership Plan (the “ESOP”) became eligible to elect to diversify a portion of the balance in each such individual’s Company Stock Account in the ESOP that is attributable to shares of Common Stock of the Company acquired by the ESOP Trust after December 31, 1986, as provided in the ESOP and in Section 401(a)(28)(B) of the Code. There were diversification transfers of \$341,731 and \$45,686 into the Plan from the ESOP for investment purposes only during the years ended October 31, 2024 and 2023, respectively. The diversified account balances remain subject to the distribution rules of the ESOP, not those of the Plan.

Savings Account

The Savings Account is a profit-sharing plan under Section 401(a) of the Code with a cash or deferral arrangement that satisfies Section 401(k) of the Code. The Plan allows for employer contributions and employee salary deferrals. The Company’s matching contribution is 25% of the participant’s eligible salary deferral not in excess of 2% of a participant’s compensation, if certain requirements as outlined in the Plan are met. A participant’s salary deferral cannot exceed limits set by the Plan and the Code.

Retirement Account

The Retirement Account is a profit-sharing plan under Section 401(a) of the Code. The Company’s contribution to the Plan on behalf of each participant was 1% of eligible compensation for the years ended October 31, 2021. The Company amended the R&S Plan to eliminate contributions to the Retirement Account for plan years beginning on or after November 1, 2021. The Company continues to have obligations for contributions to Participants who qualify for such contributions under the Uniformed Services Employment and Reemployment Rights Act regulations, if applicable. The Company’s contributions net of forfeitures were \$455 and \$1,405 for the years ended October 31, 2024 and 2023, respectively.

Forfeitures

The forfeiture reserve of \$32,105 and \$13,483 at October 31, 2024 and 2023, respectively, is available to offset Company cash contributions. Forfeitures used to offset Company contributions amounted to \$14,479 and \$21,406 for the years ended October 31, 2024 and 2023, respectively. Forfeitures used to pay Plan expenses amounted to \$-0- for the year ended October 31, 2024 and \$17,631 for the year ended October 31, 2023.

Participation, Accounts, Expenses, Vesting, Distributions, Notes Receivable from Participants, Diversification, and Other Provisions

Eligibility for participation, forms of accounts and the conditions associated with them, allocation of expenses, vesting rights, events and forms of distribution, notes receivable from participants, diversification transfers from the ESOP, and other provisions are contained in the Plan. They are also summarized in the Summary Plan Description provided to participants.

Discretionary Absorption by the Company of Certain Plan Expenses

The Company from time to time may in the discretion of its Board of Directors decide to absorb, by direct payment to service providers or by reimbursement to the Plan, certain of the Plan's operating expenses that could instead have been charged to the Plan itself. For the Plan Year ended October 31, 2024, the Plan's expense obligations were \$98,660 (excluding (i) \$140 of participant loan origination fees charged to the borrowers' accounts, and (ii) the variable investment management fees for the individual investment choices of participants). The Company directly paid a total of \$69,440 of the \$98,660 to CohnReznick for its audit services, and to Vanguard for recordkeeping fees incurred for those participants who were active employees of Sonalysts. For the Plan Year ended October 31, 2023, the Plan's expense obligations were \$102,200 (excluding (i) \$240 of participant loan origination fees charged to the borrowers' accounts, and (ii) the variable investment management fees for the individual investment choices of participants). The Company directly paid a total of \$54,139 of the \$102,200 to CohnReznick for its audit services, and to Vanguard for recordkeeping fees incurred for those participants who were active employees of Sonalysts. The Company did not reimburse record-keeping fees for separated participants, origination fees for participants obtaining loans from the Plan, or the variable investment management fees of participants generally. The purpose of the Company's payment/reimbursement, in years when made, is to improve the overall benefit to participants, with emphasis on those who are active employees.

Note 2 - Summary of Significant Accounting Policies:

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Income Tax Status

The Plan obtained its latest determination letter on May 1, 2014, in which the Internal Revenue Service (the "IRS") stated that the Plan, as amended, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the latest determination letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America ("GAAP") require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 31, 2024 and 2023.

Subsequent Events

Management has reviewed subsequent events through May 27, 2025, the date at which the financial statements were available for issuance.

Investment Valuation and Income Recognition

Investments are valued at quoted market prices. Net appreciation in fair market value of investments represents the increase in fair market value from the prior year. The term “fair market value,” as used herein, is defined in the proposed Department of Labor regulations as “... the price at which an asset would change hands between a willing buyer and a willing seller when the former is not under any compulsion to buy and the latter is not under any compulsion to sell, and both parties are able, as well as willing, to trade and are well informed about the asset and the market for such asset.”

In accordance with GAAP, investments are reported on the Statements of Net Assets Available for Benefits using the term “fair value.” Fair value is defined and discussed in Note 4 below. Fair value and fair market value are equal for each investment of the Plan. Accordingly, the terms “fair value” and “fair market value” are used together throughout these financial statements (other than in Note 4) for clarity of presentation.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on the investments bought and sold as well as held during the year.

Risk and Uncertainty

The Plan’s assets are invested, at the direction of the individual participants, in an array of choices including twenty mutual funds and a common collective trust, all offered by Vanguard Fiduciary Trust Company (“Vanguard”). These investments are exposed to various forms of risk, as a result of which the value of the Plan assets will fluctuate over time, and could change significantly over a short period of time. It is, therefore, uncertain whether the net amount reported in the Statements of Net Assets Available for Benefits (and the account balances in the last of the quarterly individual statements to participants, which aggregate to the net amount in such Statements) will be materially different for dates after the dates of such Statements.

Note 3 - Certified Investments:

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at October 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the years then ended, that are disclosed in the accompanying financial statements and supplemental accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Vanguard as the trustee of the Plan and holder of the Plan assets.

Note 4 - Fair Value Measurements:

Fair market value is defined in Note 2 above. As indicated there, fair market value and fair value are equal for each investment of the Plan. In this Note 4, for clarity of presentation, only the term “fair value” is used. Elsewhere in these financial statements both terms are used together because of their equivalence.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, Fair Value Measurement, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2024 and 2023.

Common Collective Trust: Valued at the net asset value (“NAV”) of units of a collective trust. The NAV is based on the value of the underlying assets owned by the trust, minus its liabilities, and then divided by the number of shares outstanding. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The use of the NAV as fair value is deemed appropriate as the common collective trust funds do not have finite lives, unfunded commitments relating to these types of investments, or significant restrictions on redemptions. Were the Plan to initiate a full redemption of the collective trust, the trustee reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities’ liquidations will be carried out in an orderly business manner.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and the Code. In the event of Plan termination, participants (as defined in the Plan) will become 100 percent vested in their accounts.

Note 6 - Related Party and Party-in-Interest Transactions:

Plan assets include investments in funds managed by Vanguard, the trustee of the Plan, and, as such, transactions with the trustee qualify as party-in-interest transactions. Notes receivable from participants (loans) also qualify as party-in-interest transactions. The transactions between these parties-in-interest are exempt under ERISA Section 408. The Plan Sponsor provides to the Plan certain accounting and administrative services for which no fees are charged.
