# Centrus Savings Program

## Notes to the Financial Statements

### 1. Plan description:

The following description of the Centrus Savings Program (the "Plan"), provides only general information. Plan participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan is administered by Centrus Energy Corp. (the "Company" or "Sponsor") through a plan administrator. Centrus Energy Corp. and its wholly owned subsidiary, United States Enrichment Corporation (together, "Centrus"), are participating employers. The Centrus Benefit Plan Administrative and Investment Committees monitor and oversee administration of the Plan. Fidelity Management Trust Company (the "Trustee" or "FMTC") acts as Trustee and recordkeeper.

#### Eligibility

An eligible employee is an employee that is paid, employed and reported on the payroll and personnel records of Centrus as an employee. An eligible employee may immediately participate in the Plan.

#### Contributions

Participants may contribute between 1% and 50% of eligible compensation in 0.5% increments up to the maximum annual amount allowed under the Internal Revenue Code. Participants may elect either before-tax contributions, after-tax contributions or a combination of both. Effective December 11, 2023, the Plan was amended to allow Roth contributions. With certain exceptions, new employees are automatically enrolled in the Plan at a default contribution level of either 5% or 6% of eligible compensation (depending on the class of employee) unless they make an affirmative election to make contributions at a specified percentage (including zero).

For each payroll period, Centrus provides a 200% matching contribution for the first 2% of the participant's eligible earnings, plus a 100% matching contribution for the next 2% and a 50% matching contribution for the next 2%. The maximum matching contribution is 7% of eligible earnings. Earnings eligible for the matching contribution were limited under the Internal Revenue Code to \$345,000 in 2024.

The Plan accepts rollover contributions from other qualified plans.

#### Participant accounts

Each participant's account is credited with the participant's and employer's matching contributions, and the respective investment earnings (losses) of the individual funds.

#### Notes receivable from participants

Participants may borrow from the Plan in any amount of at least \$1,000, but less than 50% of the participant's vested account balance. A participant cannot borrow more than \$50,000. Loan terms originated under the Plan are for a period not to exceed five years, except for loans taken for the purchase of a primary residence (home loans), which may have terms up to 15 years. Loans are secured by the

balance in the participant's account and bear a rate of interest at the prime lending rate plus one percentage point, subject to usury limits, at the date of loan origination with no refinancing option. Principal and interest on the loans are repaid in substantially level installments. Prepayment in full is allowed at any time. As of December 31, 2024, interest rates on outstanding loans ranged from 4.25% to 9.50%.

**Administrative expenses**

Certain expenses of maintaining the Plan are paid by Centrus.

**Vesting**

Participants are immediately vested in their contributions and associated earnings (losses). Plan vesting in the participating employer's matching contributions and associated earnings (losses) is based on years of credited service to Centrus, as follows:

Years of credited service	Percentage

2	50%
3	100%

**Forfeitures**

Forfeitures are employer contributions retained by the Plan when a participant separates from Centrus prior to vesting and are used to reduce current or future employer matching contributions. During 2024, participant departures prior to vesting resulted in forfeitures of \$21,859. At December 31, 2024 and 2023, forfeitures available to reduce future contributions were \$219,395 and \$186,663, respectively.

**Investment options**

Participants direct FMTC to invest their contributions, the participating employer's matching contributions and associated earnings (losses) among various investment options. At December 31, 2024, investment options consist of 31 mutual funds and a managed fund of short-term bonds and other fixed income securities (Fidelity Managed Income Portfolio II).

Participants may make changes and exchanges among the investment options at any time by contacting FMTC directly.

**Distributions**

Upon termination of service (other than by death) at a time when a participant (1) has reached normal retirement age (age 65), (2) has reached age 50 with 10 years of credited service, (3) is disabled or (4) is eligible for total and permanent disability benefits under a Centrus long-term disability plan, a participant may elect to receive (a) a lump sum amount equal to the value of the participant's vested interest in his or her account, (b) monthly installments over a fixed number of years or over life expectancy or (c) a series of partial payments. If a participant dies before the entire vested portion of the account is distributed, the remaining vested portion of the account is payable to a beneficiary. Upon termination of service (other than by death) before a participant (1) has reached normal retirement age (age 65), (2) has reached age 50 with 10 years of credited service, (3) is disabled or (4) is eligible for total and permanent disability benefits under a Centrus long-term disability plan, upon request, the vested portion of a participant's account may be paid as a lump sum. The amount of any payment from a participant's account is reduced to satisfy income tax withholding requirements, unless the balance is rolled over to a qualifying plan or other tax-exempt option. Participants may make hardship withdrawals from their contributions under certain circumstances allowed by the Plan.

## **Plan termination**

Although Centrus has not expressed an intent to do so, Centrus has the right to discontinue its contributions at any time and to terminate the Plan, subject to applicable law and its obligations under its existing collective bargaining agreements. In the event of Plan termination, participants will become 100% vested in participating employer matching contributions and associated earnings (losses).

## **2. Summary of significant accounting policies:**

### **Basis of accounting**

The financial statements of the Plan are prepared based on the accrual method of accounting. Distributions to participants are recorded on the cash basis.

### **Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities. Actual results could differ from those estimates.

### **Investment valuation and income recognition**

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 3 for further information related to fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

The Managed Income Portfolio II ("MIP II"), a collective trust managed by FMTC, is designed to preserve principal and accumulate earnings and invests in fully benefit-responsive investment contracts. The fair value of the Plan's interest in the MIP II is based on information reported by the issuer of the collective trust at year-end. Participant-directed redemptions have no restrictions and participants can redeem a portion of the collective trust daily; however, the Plan is required to provide a one-year redemption notice to liquidate its entire share in the fund.

The Net Asset Values ("NAV") of the investments in a collective trust fund are provided by administrators of the funds. The Plan's interest in the collective trust is based on the fair value of the collective trust's underlying investments as based on information reported by the investment advisor using the audited financial statements of the collective trust at year end. The NAV for each fund is based on the underlying assets owned by the fund, less any expenses accrued against the fund, divided by the number of fund shares outstanding. For investments in these funds, the NAV's unit price is not quoted in an active market; however, the unit price is based on underlying investments which are traded in an active market.

### **Notes receivable from participants**

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

### **Subsequent events**

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through May 27, 2025, the date on which the financial statements were available to be issued.

### **3. Fair value measurements:**

Financial accounting standards provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Level 1 of the valuation hierarchy includes mutual funds for which the NAV is quoted in active markets. Mutual funds are public investment instruments valued using the NAV provided by the administrator of the fund. The NAV is based on the underlying assets owned by the fund, minus its liabilities, divided by the number of shares outstanding.

\* Equity, bond and money market investments held in collective trust funds are valued based on the net asset value (“NAV”) provided by the administrator of the funds. The NAV for each fund is based on the underlying assets owned by the fund, less any expenses accrued against the fund, divided by the number of fund shares outstanding. While the underlying investments are traded on an exchange, the funds are not. Fair values for the collective trust investments are measured using the NAVs as a practical expedient and are not categorized in the fair value hierarchy.

#### 4. Tax status:

The IRS has determined and informed the Company by a letter dated March 5, 2018, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Subsequent to that date, the Company adopted a pre-approved profit sharing plan which received a favorable opinion letter from the IRS dated June 30, 2020. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

#### 5. Party-in-interest transactions:

Certain Plan investments are managed by FMTC. FMTC is the Trustee as defined by the Plan, and these transactions qualify as party-in-interest transactions.

Certain expenses of the Plan are paid by Centrus to Fidelity. In 2024, no expenses were paid by Centrus since revenue credits were used to offset expenses. Participant loan costs and fund investment management expenses are paid by the participant.

**6. Risks and uncertainties:**

The Plan provides for investments in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**7. Information certified by the Plan's Trustee:**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**8. Plan Amendment CARES Act:**

On March 27, 2020 the U.S. Congress passed the CARES Act. The CARES Act provided temporary relief for retirement plan sponsors and their participants with respect to distributions and participant loans during 2020. The provisions of the CARES Act could be effective and operationalized immediately, prior to amending the plan document.

The Plan Administrator has adopted the distribution relief provisions included in the CARES Act which permitted qualified individuals to request a pre-approved distribution, through participant self-certification of eligibility. The maximum dollar amount that could be requested per participant was \$100,000 up through December 30, 2020.

Additionally, the Plan Administrator has adopted the loan provisions included in the CARES Act which permitted qualified individuals to borrow from their fund accounts in the amount to the lesser of \$100,000 or 100% of the qualified individual's vested account during the period March 27, 2020 through September 21, 2020. Furthermore, qualified individuals were permitted to suspend loan repayments due between March 27, 2020 through December 31, 2020; however, no plan participant elected the option to suspend loan repayments.

The Company amended the Plan before the end of the applicable remedial amendment period to reflect such provisions.
