

NOTE A – DESCRIPTION OF PLAN

The following information of the Spalding Consulting, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan was merged into the Aon Pooled Employer Plan effective October 1, 2024, and all assets were transferred on that date. However, the financial statements are presented as of October 31, 2024, the date through which the Plan's custodian certified the investment information in accordance with 29 CFR 2520.103-5 (see Note C). No Plan activity occurred between October 1 and October 31, 2024.

General

Spalding Consulting, Inc. (the "Company") is the plan sponsor and serves as Plan Administrator. The Plan is a defined contribution plan covering all employees of the Company. Employees are eligible to participate on date of hire. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100 percent of annual compensation, as defined in the Plan. Contributions may be pre-tax 401(k) deferrals or Roth 401(k) deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make a discretionary matching contribution equal to a uniform percentage of a participant's salary deferrals. The company determines the amount of the discretionary percentage. Additional profit-sharing amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participants direct the investment of their contributions, matching contributions, qualified non-elective contributions and discretionary contributions into various investment options offered by the Plan. The Plan currently offers investments in pooled separate accounts with John Hancock Trust Company, LLC (John Hancock).

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after four years of credited service.

Forfeitures

Forfeitures of non-vested Company contributions are used to reduce future Company contributions. During 2024, \$48,473 of forfeited participant accounts were used to reduce the Company's contributions. At October 31, 2024 and December 31, 2023, unapplied forfeitures totaled \$0 and \$24,498 respectively.

Administrative expenses

The Plan permits the payment of Plan expenses to be made from the Plan's assets. If expenses are paid using the Plan's assets, then the expenses are generally allocated among the accounts of all participants in the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. Participants may have two outstanding loans at any time. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25 percent to 9.5 percent, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Direct rollovers of participant loans from existing benefit plans are permitted by the Plan.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or minimum distributions paid over a period not extending beyond the beneficiary's life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under the cash basis of accounting, revenue is recognized when cash is received rather than when it is earned, and expenses are recognized when cash is expended rather than when obligations are incurred. The Plan's modification to the cash basis is in regards to the reporting of participant and employer contributions, which are reported when compensation is paid to the participants and deferral and matching contributions are determinable, the accrual of any employer discretionary contributions allowable under the Plan, the reporting of plan investments at fair values, which includes unrealized gains and losses, and the recognition of any excess contributions noted during the annual discrimination testing.

Estimates

The preparation of financial statements in conformity with Plan's basis of accounting, the modified cash basis, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates and the difference may be material.

Investments Valuation and Income Recognition

Investments are presented at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses of maintaining the Plan are paid by the Plan and the Plan sponsor.

NOTE C – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at October 31, 2024, and net depreciation in fair value of investments, interest and dividends for the ten-month period ended October 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Trust Company, LLC, custodian of the plan.

NOTE D – FAIR VALUE MEASUREMENTS

FASB *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2024 and December 31, 2023.

The Plan's investments are in participation units held in pooled separate accounts through sub-accounts of an insurance company. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

The underlying securities in other pooled separate accounts are listed on national securities exchanges and valued on the basis of year-end closing prices. The Plan has concluded that the net asset value as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company approximates fair value of the investments. The investments are redeemable at the adjusted net asset value under agreements with the insurance company.

It is possible that the redemption rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in market conditions, liquidity requirements, and the economic environment may significantly affect the net asset value calculation for the mutual funds and, consequently, the fair value of the Plan's investments.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – PARTIES-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. Notes receivable from Plan participants qualify as party-in interest transactions, which are exempt from the prohibited transactions rules.

The Plan has investments in participation units held in pooled separate accounts through sub-accounts of John Hancock. John Hancock provides services to the Plan as the custodian and record keeper; therefore, these investments and transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services that were provided by John Hancock and its subsidiaries are included in net appreciation in fair value of investments.

Recordkeeping and Tax services are provided by Duncan Accounting & Tax Services, Inc. These transactions qualify as exempt party-in-interest transactions.

NOTE F – PLAN TERMINATION

Effective October 1, 2024, the Plan was merged into the Aon Pooled Employer Plan. As a result of this merger, all assets, liabilities, and obligations of the Plan were transferred to the Aon Pooled Employer Plan. Participants in the Plan became participants in the Aon Pooled Employer Plan and are subject to the provisions of the Aon Pooled Employer Plan. The merger does not affect participants' account balances, investment options, or other plan benefits. All contributions, including employer matching contributions, will continue as outlined in the plan documents.

NOTE G – TAX STATUS

The Internal Revenue Service has determined and informed the company by a letter dated March 31, 2014, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that at October 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

Plan participants make choices regarding their investments in securities, and are exposed to risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value will occur in the near term and that such changes could materially affect participant account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE I – SUBSEQUENT EVENTS

Subsequent events were evaluated through May 12, 2025, which is the date the financial statements were available to be issued.
