INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Sharon S. Richardson Community Hospice 403(b) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Sharon S. Richardson Community Hospice 403(b) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Sharon S. Richardson Community Hospice 403(b) Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through April 10, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Sharon S. Richardson Community Hospice is the plan sponsor, employer and the plan administrator. Richardson Hospice Resale Store is a participating employer. Associated Trust Company, N.A. ("Associated") is the custodian that holds custody of plan investment assets, recordkeeper that maintains participant accounts and related information, third party administrator that maintains plan documents, investment advisor and tax counsel that performs various compliance tests.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Earnings on investments bought, sold and held during the years are reflected in the statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

Money market and mutual funds - Valued at the daily published market prices as reported by the funds. The money market fund and mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was adopted effective November 1, 2009 as a defined contribution plan established under Internal Revenue Code Section 403(b). It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to make elective deferral contributions and receive employer contributions immediately upon hire as long as they have reached age eighteen.

Contributions - Contributions are recorded in the year in which eligible compensation is paid. Contributions to the plan can be made in the following ways:

- Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferrals.
- Rollover contributions are accepted by the plan from other qualified plans.
- Employer matching contributions are made in conjunction with each pay period. The employer match is at the employer's discretion and equal to 100% of the first 3.50% of employee compensation contributed to the plan as elective deferral contributions in 2024 and 2023.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of the employer's contributions. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each pay period.

Vesting - Participants are always 100% vested in their elective deferral contributions, rollover contributions and related earnings. Participants become 100% vested in any employer contributions and related earnings upon one year of service. Upon death, disability or attainment of normal retirement age (defined as 59 ½) while still employed, participants become 100% vested.

Payment of benefits - Benefit payments are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or retirement. Distributions can be made in the form of single lump sum or installments payments. In-service withdrawals can commence upon attaining the age of 59 ½. Hardship withdrawals are not permitted under the plan.

Administrative expenses - Certain administrative fees of the plan are paid by the employer and not included in these financial statements. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in these financial statements. Such expenses include participant directed charges for distribution fees and nonparticipant directed charges for service and administrative fees. Nonparticipant directed fees are allocated to participants on an account value basis.

Forfeitures - Forfeitures are used to reduce employer contributions or pay plan expenses. Forfeitures used to pay plan expenses were \$2,000 in 2024 and 2023. Unapplied forfeitures were insignificant as of December 31, 2024. Unapplied forfeitures were \$2,000 as of December 31, 2023.

Notes receivable from participants - Participant loans are not permitted under the plan.

3. PARTY-IN-INTEREST TRANSACTIONS

Associated is the custodian that holds custody of plan investment assets and also manages certain of the plan's investment options. As such, transactions between Associated and the plan qualify as party-in-interest transactions. Associated also provides certain administrative services to the plan pursuant to a service agreement between the plan sponsor and Associated. Associated receives revenue from certain mutual fund service providers for services Associated provides to the funds. This revenue is considered indirect compensation and is used to offset certain amounts that would otherwise be owed by the plan to Associated for its administrative services to the plan. Direct fees paid by the plan to Associated were \$31,000 and \$26,000 in 2024 and 2023.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any employer contributions and related earnings.

5. INCOME TAX STATUS

The plan adopted an Associated Trust Company volume submitter plan. The volume submitter plan received its most recent favorable opinion letter on March 31, 2017 in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. As a result, the plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. The plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

6. INFORMATION CERTIFIED BY ASSOCIATED

Management has obtained certifications from Associated, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the fair values of such as of December 31, 2024 and 2023;
- b. Dividends and interest income from investments and net appreciation (depreciation) in fair values of investments during 2024 and 2023; and
- c. Contributions to, withdrawals from, purchases, sales and inter-fund transfers between accounts during 2024 and 2023.

7. NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

The plan sponsor remitted employee elective deferral contributions totaling \$499 relating to the 2024 plan year to Associated later than required by DOL Regulation 2510.3-102. Management is anticipating remitting lost earnings related to the late contributions to account for the investment income that would have been earned had the contributions been remitted on a timely manner.

The plan sponsor remitted employee elective deferral contributions totaling \$705 relating to the 2023 plan year to Associated later than required by DOL Regulation 2510.3-102. Participant accounts were credited in 2024 with the amount of investment income that would have been earned had the contributions been remitted on a timely basis.
