INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Advanced Digital Cable, Inc. 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE A – DESCRIPTION OF PLAN

The following description of Advanced Digital Cable, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the Plan document.

General – The Plan, adopted on and effective January 1, 1999, is a defined contribution plan covering substantially all eligible employees of Advanced Digital Cable, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility – Employees are eligible to enter the Plan after completing six months of service unless waived by a specific amendment of the Plan. Employees are allowed to enter the Plan on the first day of the Plan Year quarter coinciding with or next following the date the eligibility requirements are met and reaching the age of 18. Union employees, nonresident aliens, and part-time employees are not eligible to participate in the Plan.

Contributions – Eligible employees have the option to enroll into the Plan. Pre-tax contributions and after tax Roth elective deferrals are withheld at the employee’s discretion. At any time, a participant may elect an alternative deferral amount or elect not to defer. Participants may elect to make pre-tax contributions of up to 100% of compensation, as defined by the Plan, not to exceed \$23,000 (\$30,500 for participants over the age of 50) in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may make a discretionary matching contribution during the year. The Company match totals 100% of employee contributions up to 3% of annual compensation plus 50% of contributions between 4% and 5% of compensation. Contributions are subject to certain limitations. The Company may make discretionary profit-sharing contributions based on a profit-sharing calculation.

Participant accounts – Each participant’s account is credited with the participant’s contributions, the Company’s contributions, rollovers and earnings in their account, and is charged with an allocation of administrative expenses and specific transactions charges incurred by the participant. Participants direct the investment of their accounts into various investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Payment of benefits – The vested portion of a participant's account is available for disbursement when (1) the participant retires at age 65 or later; (2) the participant becomes permanently disabled; (3) the participant terminates employment; or (4) the participant dies while an active participant in the Plan.

Administrative Expenses – The Company pays administrative expenses related to certain record keeping services. All other administrative expenses and participant transaction fees are paid by participants. Expenses may be allocated either proportionately based on participants’ account balance or as an equal dollar amount based on the number of participants in the Plan. Certain expenses specifically incurred by a participant, such as taking a withdrawal from the Plan, are paid directly by that participant.

NOTE A – DESCRIPTION OF PLAN (CONTINUED)

Vesting – All participants’ contributions and earnings thereon are fully vested. Vesting in the Sponsoring Employer’s matching and discretionary contributions portion of their accounts plus actual earnings thereon is determined by years of vesting service. The Company’s discretionary matching contributions are based on the following schedule:

Forfeited accounts – Forfeitures of terminated participants’ non-vested accounts may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan no later than the last day of the Plan Year following the Plan Year in which the Forfeiture occurs. During the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,986 and \$663, respectively.

Notes receivable from participants – Participant loans are recorded at amortized cost, which represents unpaid principal plus accrued interest. Interest income on notes receivable from participants is recorded when it is earned. In accordance with ASC 326, the Plan utilizes historical information and reasonable and supportable forecasts regarding future events to regularly evaluate the collectability of notes receivable from participants. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The accompanying financial statements are prepared on the accrual basis of accounting.

Estimates – The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payments of benefits – Benefits are recorded when paid.

Administrative expenses – Administrative fees paid by the Plan amounted to \$52,800 and \$44,073 for the years ended December 31, 2024 and 2023, respectively. All other administrative expenses of the Plan have been paid by the Company and are therefore not reflected in the accompanying statement of changes in net assets available for benefits.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment valuation and income recognition – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.

The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation on those investments.

Net appreciation on investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Subsequent events – Subsequent events have been evaluated through May 28, 2025, which is the date the financial statements were available to be issued.

NOTE C – TAX STATUS

The Plan is a non-standardized pre-approved 401(k) profit sharing plan created by Ascensus, LLC. The Internal Revenue Service has determined and informed Ascensus, LLC by a letter dated June 30, 2020 that the plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receipt of the determination letter; however, the Plan Administrator and the Plan's tax council believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision of income taxes has been included in the Plan's Financial Statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan Administrator believes the Plan is no longer subject to income tax examinations for tax years prior to 2021.

NOTE D – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Parties-in-interest as defined by the Plan include Reliance Trust Company as the custodian, Steve and Cory Payne as trustees; Nova Associates, Inc. as the third-party administrator; and Administrative Fiduciary Services Inc. as financial advisor. Therefore, transactions occurring between the Plan, custodian, trustee, and financial advisor of the Plan Sponsor qualify as party-in-interest transactions. Certain administrative fees are deducted from the Plan assets by the custodian.

NOTE F – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near future and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G – FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority of unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are unobservable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE G – FAIR VALUE MEASUREMENTS (CONTINUED)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Mutual funds are valued based on the same securities traded on a national exchange at the last reported sales price on the last business day of the plan year; investments traded in the over-the-counter market and listed securities for which no sale was reported on the last day of the plan year are valued at the last reported bid price. These assets are classified as Level 1 assets within the fair value hierarchy.

Common collective trusts: These accounts consist of investments in participation units held in common collective trust accounts through sub-accounts of an insurance company at December 31, 2024 and 2023, respectively. The underlying securities in common collective trusts are listed on national securities exchanges and valued on the basis of year-end closing prices. The Plan has concluded that the net asset value as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company denotes fair value using the net asset value per share practical expedient.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Company believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE I – SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to reduce the service crediting method for eligibility from 1,000 hours of service to 500 hours of service. Additionally, eligible compensation was amended to exclude reimbursements, allowances, fringe benefits, moving expenses, deferred compensation, and welfare benefits for all contribution types.
