We have performed audits of the financial statements of ECI Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of September 9, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 through September 9, 2024, and the related notes to the financial statements.

NOTE A--DESCRIPTION OF PLAN

The following description of ECI Group 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution plan covering substantially all employees of ECI Construction, Inc. (the "Company", "Plan Administrator" or "Employer") and ECI Management, LLC. Employees who attained eighteen years of age were eligible to participate in the Plan the first day of the month coinciding with or following six months of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Effective September 9, 2024, the Plan merged into the Aprio Advantage Pooled Employer Plan and all Plan assets were transferred on that date. The Plan effectively terminated on this date.

Contributions: The Plan provided for employee elective pre-tax and/or after-tax contributions with an Employer safe harbor matching provision. Plan participants could make contributions from 1% to 90% of their annual compensation, as defined by the Plan, not to exceed the Federal statutory maximum. Participants who attained age 50 prior to the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Employer matching contribution was 100% of the participant's elective contributions, up to 4% of the participant's compensation, as defined by the Plan.

The Plan included an automatic salary deferral feature. The Employer automatically withheld 4% of the employee's compensation as an employee elective pre-tax contribution, unless the participant elected otherwise.

The Plan provided for a discretionary, non-elective employer profit-sharing contribution for all Plan participants who were eligible to defer employee elective contributions. Allocation of the annual profit-sharing contribution was determined annually by Plan management. No non-elective profit-sharing contributions were made for the period from January 1, 2024 through September 9, 2024.

NOTES TO FINANCIAL STATEMENTS--Continued

NOTE A--DESCRIPTION OF PLAN--Continued

Participant Accounts: Each participant's account was credited with their contributions, their account's earnings or losses, the Employer's matching contributions, the Employer discretionary profit-sharing contribution, less an allocation of certain administrative expenses that were paid by the Plan. All investments were participant directed. Participants could change their investment options daily.

Investments: Participants could allocate their contributions and employer contributions among a selection of pooled separate accounts.

Vesting: Participants were immediately vested in their voluntary contributions, safe harbor matching contributions and allocated earnings thereon. Vesting in the Employer non-safe harbor matching and profit-sharing contributions and earnings thereon was based on years of service. A participant was 100% vested after four years of credited service and vested 25% per year. Additionally, a participant became fully vested upon termination of employment with the Company due to death or disability.

Forfeitures: Forfeited amounts could be used to pay administrative expenses of the Plan and to reduce future Employer contributions to the Plan.

Administration: The Plan was administered by the Employer. All funds in the Plan were held by John Hancock Life Insurance Company (U.S.A.) ("the Custodian" or "John Hancock"). The Plan's Custodian invested participants' account balances, as directed by the participants.

Withdrawals: A participant could withdraw his participant elected and rollover contributions, plus earnings thereon, in the case of a financial hardship. Withdrawals were taxable in the year received by the participant and may be subject to a penalty tax. Additionally, after reaching the age of 59½, a participant could request an in-service distribution from vested accounts.

Payment of Benefits: Upon a participant's termination of employment with the Company, or after reaching the age of 65, the participant was entitled to receive a distribution of his vested account balance. The participant could elect to receive a distribution at any time in the form of a lump sum payment. If the participant died prior to receiving his entire vested account balance, the balance would be paid to the participant's beneficiary.

NOTES TO FINANCIAL STATEMENTS--Continued

NOTE A--DESCRIPTION OF PLAN--Continued

Notes Receivable from Participants: Generally, participants could borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Participants could only have one loan outstanding at any given time. Loans were repaid ratably through payroll deductions over periods of up to 60 months, except in circumstances when the loan proceeds were used to purchase the primary residence of the participant. In such circumstances, the loans could be repaid over a period of up to 15 years. The loans were secured by the vested balance in the participant's account and bore interest at the prime rate plus 2% at the date of the loan.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan followed the Financial Accounting Standards Board Accounting Standards Codification as its sole source of authoritative guidance. The financial statements for the Plan are prepared using the accrual basis of accounting.

The Plan's investments were stated at fair value, as further described in Note C. Investment securities, in general, are exposed to various risks, including credit, interest, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is possible that changes in values of investment securities will occur and that such changes could materially affect the amount reported in the statements of net assets available for plan benefits.

Purchases and sales of securities were recorded on a trade-date basis (the date the order to buy or sell is executed). Realized gains and losses on the sale of investments were calculated based on the difference between the selling price and cost on an average cost basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as the change in unrealized gains/losses for securities held at the end of the year.

Contributions were recorded on the accrual basis, which recognized participants' contributions and the related Employer matching contributions at the time the participants' contributions were withheld from their wages. Employer discretionary profit-sharing contributions were recorded in the period recognized in the Employer's financial statements.

Benefits were recorded when paid, with the exception of amounts refundable by the Plan to Participants for contributions made in excess of amounts allowed by the Internal Revenue Service. At September 9, 2024 and December 31, 2023, there were no net assets available for benefits that were not paid.

The Plan was responsible for the payment of administrative expenses. Certain administration expenses were paid by the Employer.

Loans to participants were reported separately from plan investments as notes receivable. These loans were recorded at their unpaid balance, plus all accrued and unpaid interest.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and the disclosure of contingent assets and liabilities, at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent events have been evaluated through February 14, 2025, which is the date the financial statements were available to be issued.

NOTE C--FAIR VALUE MEASUREMENTS

Current accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the accounting guidance are described below:

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled separate accounts: Valued based on quoted market prices of the securities underlying the pooled separate accounts.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at September 9, 2024 and December 31, 2023.

NOTE D--TRANSACTIONS WITH PARTIES IN INTEREST

The Plan had an agreement with the Custodian to maintain the investments of the Plan and to provide administrative and participant recordkeeping services for the Plan. For the period from January 1, 2024 through September 9, 2024, contributions to the Plan of \$1,823,220 were deposited with the Custodian for investment, and participants of the Plan received distributions of \$1,021,858 from funds held by the Custodian. Additionally, for the period from January 1, 2024 through September 9, 2024, the Plan recorded \$79,848 in administrative expenses paid to the Custodian or affiliates of the Custodian and other service providers. At September 9, 2024 and December 31, 2023, the Plan had \$-0- and \$8,594,817 respectively, of assets under the Custodian's custody.

NOTE E--TAX STATUS

The Plan was intended to satisfy the tax qualification requirements under Section 401 (a) of the Internal Revenue Code; therefore, the trust funds of the Plan were intended to be exempt from Federal income taxes. The amended Plan has not requested a favorable determination letter from the Internal Revenue Service since the prototype on which the Plan is based has been determined to be qualified under Section 401(a) of the Internal Revenue Code.

NOTE F--FORFEITED NON-VESTED ACCOUNTS

At September 9, 2024 and December 31, 2023, non-interest bearing cash included \$-0- and \$38,203 of unused forfeitures, respectively. Forfeitures could be used to reduce the Employer contribution, pay administrative expenses, or be allocated to participants. During the period from January 1, 2024 through September 9, 2024, the Plan used \$36,361 of forfeitures to pay administrative expenses.

NOTE G--RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

For the period from January 1, 2024 through September 9, 2024, there were no significant differences between the financial statements and Internal Revenue Service Form 5500.


