#### 1. Description of Plan

The following brief description of Central National Gottesman Inc. (the “Company”) 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Amended and Restated Plan as of January 1, 2021 for a more complete description of the Plan’s provisions.

The Plan, which became effective October 1, 1989, is a defined contribution plan for purposes of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan adopted the Vanguard Fiduciary Trust Company (“VFTC”) prototype savings plan. VFTC is the trustee of the Plan and the Vanguard Group is responsible for all the recordkeeping of the Plan.

Certain employees of the Company become eligible for participation in the Plan: (a) if the employee is scheduled to work at least 20 hours per week and completes at least 1,000 hours of service during the Plan year, and (b) if the employee has completed one month of service. Eligible participants may enter the Plan upon the first pay date of each month.

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contribution, as pertaining to certain eligible divisions’ employees, and (b) earnings on participant account balances and is charged with (c) the participants’ withdrawals, (d) allocations of administrative expenses and (e) losses on participant account balances. The benefit to which a participant is entitled is the participant’s vested account.

Employees hired on or after the effective date are automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. Any participant making contributions to the Plan at a rate lower than 10% of compensation per pay period will have his or her contributions automatically increased by 1% each January 1, until the participant reaches a maximum of 10% of compensation per pay period or he or she opts out of the automatic increases. All other participants may elect to defer, in increments of 1%, up to 25% of their annual compensation. The deferrals are subject to limitations as described in the Plan document. Rollover contributions attributable to an employee’s participation in a qualified retirement plan may be made in accordance with Plan limitations. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants are permitted to request In-Plan Roth rollovers as well as elect to make Roth contributions to the Plan. The Company makes certain non-elective as well as match contributions for certain eligible divisions’ employees (who meet the criteria as defined by the Plan document).

Participants are immediately vested in their contributions, rollover contributions as well as employer contributions plus actual earnings thereon.

The Plan does not normally permit loans. However, the Plan was amended to permit certain loan balances from participants that joined certain divisions as a result of acquisitions that were transferred into the Plan. Loans are secured by the balance in the participant's account and bear interest at 4.25% as of December 31, 2024 and 4.25% to 7.25% as of December 31, 2023. Loan repayments of principal and interest are made through payroll deductions. Loans receivable from participants are reported in the financial statements at the unpaid balances.

Amounts held in a participant's elective account may not be distributed earlier than one of the following events:

- 1) a participant's termination of employment
- 2) a participant's death
- 3) a participant's disability (as defined by the Plan document)
- 4) a participant's attainment of age 59 1/2
- 5) the termination of the Plan
- 6) the financial hardship of a participant, subject to restrictions as set forth in the Plan document

## 2. Summary of Significant Accounting Policies

### a) Principles of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in conformity with U.S. generally accepted accounting principles.

### b) Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### c) Investments Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### d) Administrative Expenses

Expenses incurred in the administration of the Plan are required to be paid with assets of the Plan unless the Company, at its discretion, elects to pay them. For the years ended

December 31, 2024 and 2023 the Company paid the majority of the administrative expenses of the Plan.

**e) Payment of Benefits**

Benefits are recorded when paid.

**f) Subsequent Events**

The Plan has evaluated subsequent events through April 18, 2025, the date the financial statements were available for issuance.

**3. Investment Information Certified By the Plan's Trustee**

Certain information related to investments and loans receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and loans receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on loans receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

**4. Fair Value Measurements**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in the collective trusts are based on the net asset values per unit as reported by the fund manager. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

**5. Party-in-Interest Transactions**

The Plan invests in shares of mutual funds and collective trusts issued by Vanguard, an affiliate of VFTC. VFTC acts as trustee and therefore these transactions qualify as party-in-interest transactions. Amounts paid by the Plan to VFTC for administrative expenses amounted to \$117,529 and \$132,431 for the years ended December 31, 2024 and 2023, respectively. Participant loans receivable amounted to \$846 and \$11,633 at December 31, 2024 and 2023, respectively. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

**6. Termination of the Plan**

Although the Company has not expressed any intent to do so, it may, by action of its Board of Directors, terminate the Plan for any reason and at any time subject to the provisions of ERISA.

**7. Federal Income Tax Exemption**

The IRS issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended from the original prototype, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

The Plan’s tax returns, like those of other Employee Benefit Plans, are subject to examination by the Internal Revenue Service generally for a period of three years after they are filed. Accordingly, as of December 31, 2024, the Plan’s federal Annual Return/Report of Employee Benefit Plan (Form 5500) for the years ended December 31, 2021, 2022 and 2023 were subject to examination by the Internal Revenue Service.

**8. Risks and Uncertainties**

The Plan’s investments are concentrated in funds that invest in marketable registered investment companies and collective trusts. Such securities are subject to various risks that affect the value of the funds. Due to the level of risk associated with equity securities and the level of uncertainty related to changes in the value of such securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants’ account balances and the value of investments reported in the financial statements.
