Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. DESCRIPTION OF THE PLAN:

The following brief description of the Bible Study Fellowship 401(k) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Document for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering all eligible employees of Bible Study Fellowship (the Organization) except union employees and leased employees. Employees are eligible for the 1% auto-enrollment provision immediately upon hire and must be at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The audit committee of the board of directors is responsible for oversight of the Plan. The audit committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

CONTRIBUTIONS

Participants may contribute up to 90% of compensation, as defined by the Plan. Participants are permitted to designate a portion or all of their deferral contributions as Roth contributions. Participants who have attained age 50 prior to the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover). All participant contributions are voluntary.

The Organization makes matching contributions equal to 50% of the first 10% of compensation contributed by the participant. The Organization may make discretionary profit sharing contributions. No discretionary profit sharing contributions were made during the year ended August 31, 2024.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contribution and (b) Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Contributions are subject to certain limitations prescribed by law. Participants may direct all their contributions among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan's provision.

1. DESCRIPTION OF THE PLAN, continued:

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their vested fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 less the highest outstanding loan balance during the prior 12 months or 50 percent of their account balance. The loan interest rate is set at prime + 1% at the time of the loan. Participants are allowed to have up to two loans maximum. Principal and interest is paid ratably through payroll deductions. Participant loans are secured by the balance in the participant's account.

VESTING

Participants are immediately vested in their employee contributions and related earnings. Employer contributions are vested on a tiered schedule as seen below:

2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 +	100%

FORFEITURES

At August 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,360 and \$10 respectively. These amounts are used to reduce future employer contributions and plan expenses. During the year ended August 31, 2024, employer contributions were reduced by \$25,199 from forfeited nonvested accounts.

PAYMENT OF BENEFITS

Upon termination of service, disability, retirement, death, or attaining age 59 1/2, participants may receive a lump sum amount or purchase an annuity contract equal to the value of the participant's interest in his or her account. A participant may request a hardship withdrawal if they experience a severe financial hardship. The hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's account balance, whichever is less.

ADMINISTRATIVE EXPENSES

Certain expenses, of maintaining the Plan, such as accounting and consulting, are paid directly by the Organization and are excluded from these financial statements. For the year ended August 31, 2024, \$1,205 was spent on administrative expenses.

2. SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

USE OF ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are stated at fair value, except for guaranteed investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded based on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Participant loans are recorded as notes receivable from participants in the statements of net assets available for benefits. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of August 31, 2024 or 2023.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

3. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION:

The Plan administrator has elected the method of compliance as permitted by 29 CRF 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company (Reliance), a qualified institution, has certified the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of August 31, 2024 and 2023; the supplemental Schedule H, Line 4i-Schedule of Assets (Held at End of Year) as of August 31, 2024; and the related interest income and investment activity reflected in the statement of changes in net assets available for benefits for the year ended August 31, 2024.

4. FAIR VALUE MEASUREMENTS:

The Plan uses appropriate valuation techniques to determine fair value based on inputs available. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 1 inputs consist of unadjusted quoted market prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

4. FAIR VALUE MEASUREMENTS, continued:

Mutual funds are valued at the daily closing price as reported by the fund. Collective investment trusts are valued at the net asset value (NAV) of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Twelve months' notice is required for a complete liquidation of the collective investment trusts held by the Plan, however the trustee, at their discretion, may waive the twelve month waiting period. Participant directed redemptions are allowed daily with no restrictions. There are no unfunded commitments.

There were no significant changes to valuation methodologies during the year.

5. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Organization may determine.

6. TAX STATUS:

The Plan has adopted a volume submitter plan document sponsored by The Retirement Advantage Inc. The volume submitter plan document has obtained an opinion letter dated October 6, 2020, in which the IRS stated that the volume submitter document satisfies the applicable requirements of the Internal Revenue Code. The Plan has not received a determination letter specific to itself; however, the Plan administrator and the Plan's counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. PARTIES IN INTEREST:

ADP performs recordkeeping and asset management services for the Plan; therefore, the fees paid to ADP for these services qualify as party-in-interest transactions. Direct fees paid to ADP, by the Plan, amounted to \$1,205 for the year ended August 31, 2024. Fees for asset management services and recordkeeping are netted with net appreciation in the fair value of investments on the statement of changes in net assets available for benefits.
