Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of BSC Acquisition Sub, LLC 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed

to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Plan Description

The following description of the BSC Acquisition Sub, LLC 401(k) Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan covering substantially all eligible employees of BSC Acquisition Sub, LLC (the “Company”), Wolf Detroit Envelope Company, Oles Envelope Company, and Florida Envelope Company who are age 18 years or older. The Plan excludes non-resident aliens, leased employees, residents of Puerto Rico, and employees from a stock acquisition or merger.

Contributions

Participants may defer up to 100% of eligible compensation, as defined by the Plan, as Roth or pretax deferrals and may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Eligible employees are automatically enrolled at 3% compensation unless the employee elects otherwise. Participants direct their contributions into various investment options offered by the Plan. The Plan’s discretionary match for 2024 and 2023 was 33.33% of employee and catch-up contributions, up to 10% of eligible compensation. Additional amounts may be contributed at the option of the Company’s Board of Directors. Contributions are subject to the maximum amount deductible under the applicable provisions of the *Internal Revenue Code (IRC)*.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after five years of credited service.

Notes from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to 50% of the employee’s vested account balance or \$50,000 reduced by the highest outstanding note balance in the participant’s account during the prior one-year period. Note terms may not exceed five years unless the note is for the purchase of a primary residence, in which case the term may exceed five years. The notes are secured by the balance in the participant’s account and bear interest at the rate of Prime plus 2.00%. At December 31, 2024, interest rates ranged from 5.25% to 10.50%. Principal and interest shall be repaid at least quarterly through payroll deductions.

Payment of Benefits

Upon termination of service for any reason, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, substantially equal installments, or partial withdrawals, as defined. In-service withdrawals are allowed at age 59 ½. Hardship withdrawals are also available, as defined.

Administrative Expenses

Administrative expenses incurred by the Plan may be paid by either the Plan or the Company. A portion of these fees and expenses were paid by the Plan for the year ended December 31, 2024.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$145,421 and \$113,546, respectively. Forfeitures may be used to reduce employer contributions, including qualified nonelective contributions, qualified matching contributions, and ADP safe harbor contributions, and to pay Plan expenses. Forfeitures may also be reallocated to participants on a pro rata basis. During 2024, forfeitures of \$848 were used to reduce Plan expenses. No forfeitures were used to reduce employer contributions during the year.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive contracts which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefit Payments

Benefits are recorded when paid.

Note 3 – Fair Value Measurements

The Plan's investments in mutual funds and stable value fund are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Level 1 Fair Value Measurements

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

Level 2 Fair Value Measurements

The fair value of the stable value fund is based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted price for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

The stable value fund invests in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While the underlying asset values are publicly quoted prices, the net asset value (NAV) of a unit in these funds is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are reflected in the computation of the NAV and are realized by the participant upon withdrawal.

Note 4 – Investment Contract

The Plan is invested in the Reliance Trust New York Life Anchor Account Stable Value Fund (the “Fund”). The Fund is a common collective trust and maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There is no set interest rate for the Fund, because it owns several investment contracts with varying rates and maturity dates.

The guaranteed investment contract is benefit-responsive and a stable value investment, therefore fair value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 5 – Related Party and Party-in-Interest Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Certain Plan investments are managed by Transamerica. Transamerica is the recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Transamerica provides certain administrative services to the Plan pursuant to a Trust Agreement between the Company and Reliance Trust Company, the Trustee. Transamerica receives revenue from mutual fund and collective investment fund service providers for services Transamerica provides to the funds. This revenue is used to offset certain amounts owed to Transamerica for its administrative services to the Plan. If the revenue received by Transamerica from such mutual fund or collective trust fund service providers exceeds the amount owed under the Trust Agreement, Transamerica remits the excess to the Plan’s expense budget account on a monthly basis. Such amounts may be applied to pay Plan administrative expenses. The Plan Sponsor may make a payment to Transamerica for administrative expenses not covered by revenue sharing. During 2024, revenue sharing of \$134,954 was received by the Plan and \$132,652 was used to pay Plan expenses. Administrative expenses are presented net of revenue credits.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA). In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 – Tax Status

The Company has adopted the Transamerica Retirement Solutions LLC Non-standardized Prototype Plan which received a favorable opinion letter dated June 30, 2020, stating the Plan is designed in accordance with applicable sections of the *IRC*.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
