Report of Independent Auditors

To the Participants and Board of Trustees of
SEIU Local 1 Health Maintenance Fund

Opinion

We have audited the financial statements of SEIU Local 1 Health Maintenance Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of SEIU Local 1 Health Maintenance Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with the modified cash basis of accounting as described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit;
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements;
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed;
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements; and
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

December 31, 2024 and 2023

Note 1. Description of the Plan

SEIU Local 1 Health Maintenance Fund (the Plan) is a multiemployer welfare plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and was established in 1983 as a result of a collective bargaining agreement to provide health care, dental and life insurance benefits for eligible participants and their dependents.

The Plan provides benefits under insurance contracts with BlueCross BlueShield of Illinois, Delta Dental and Dearborn National. The Trustees determine the type and amount of benefits.

To become initially eligible for benefits, a participant must be employed by a contributing employer in the collective bargaining unit represented by the local union or by an employer with a participation agreement in effect. Generally, eligibility for benefits starts as of the first day of the month in which a participant is considered a regular employee as defined by the collective bargaining agreement in place. Eligibility continues for each successive month that contributions are made on a participant's behalf.

Participants and retirees may also continue coverage through self-payment if they meet the requirements under the Plan and make continued monthly payments.

Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by Consolidated Omnibus Budget Reconciliation Act (COBRA), was adopted by the Plan.

Participants should refer to the summary plan description for more complete information.

Note 2. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements of the Plan have been prepared using the cash basis of accounting, modified to record assets or liabilities that arise from cash transactions and events which provide a benefit or result in an obligation that covers a period greater than the period in which the cash transactions or events occurred. The modifications result in the recording of certain assets on the statements of net assets available for benefits. Except for net appreciation or depreciation in the fair value of investments held at year end, all transactions are recognized as either revenue or expenses when received or paid in cash. The modified cash basis of accounting is a basis of accounting other than accounting principles generally accepted in the United States of America (GAAP).

Note 2. Summary of Significant Accounting Policies (continued)

Investments - The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Revenue Recognition - Under GAAP, revenue derived from employer contributions would be recognized in the period in which covered work is performed. Employer contributions are based on the number of participants covered and the contribution rates set forth in the collective bargaining agreements. Employers are required to remit contributions monthly. The Plan carries out its purpose described in Note 1 within a jurisdiction primarily located in Illinois.

Benefit Obligations - The Plan is fully insured and therefore had no benefit obligations as of December 31, 2024 and 2023. Consequently, a statement of benefit obligations and a statement of changes in benefit obligations are not included in these financial statements.

Leases - The Plan recognizes lease expense when rent payments are made, in accordance with the modified cash basis of accounting. Under GAAP, a right-of-use asset and lease liability would be recognized. The Plan has included in the accompanying financial statements informative disclosures about the Plan's operating lease, including relevant terms and monthly lease payments.

Expenses - Certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through May 1, 2025, which is the date the financial statements were available to be issued.

Note 3. Priorities upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

Note 4. Tax Status

The Plan has obtained a notice of exemption in which the Internal Revenue Service stated that the trust is exempt under Section 501(c)(9) of the Internal Revenue Code and is, therefore, not subject to tax under the present income tax laws. The Plan has been amended since receiving the notice of exemption. The Plan's administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The Plan is required to evaluate tax positions taken and disclose the amount of a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Fair Value Measurements

The Plan prepares its financial statements on the modified cash basis of accounting. Because one of the modifications to the cash basis the Plan has made is to record its investment at fair value, the *Fair Value Measurements and Disclosures* Topic of the Financial Accounting Standards Board Accounting Standards Codification, which established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, has been implemented by the Plan. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

The following tables set forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Level 1 Measurements

The fair value of the mutual fund is determined by reference to the fund's underlying assets, which are principally marketable fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value as of the last business day of each period presented.

Level 2 Measurements

Certificates of deposit are valued at cost, which approximates their fair value.

Note 6. Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

The mutual fund and one certificate of deposit represent approximately 55% and 53% of the Plan's net assets available for benefits as of December 31, 2024 and 2023, respectively.

Note 7. Lease

The Plan pays rent on a month-to-month basis to its third-party administrator under a leasing arrangement for office space. During the years ended December 31, 2024 and 2023, the Plan paid a flat monthly rent of \$200. Total rent paid during each of the years ended December 31, 2024 and 2023 was \$2,400. The Plan's administrator and the Plan's legal counsel believe that these transactions meet the conditions required in order to qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

Note 8. Related Organization

The Plan is related to a local union.

Note 9. Funding Policy

The Plan is primarily funded by employer contributions made on behalf of eligible participants pursuant to the terms of the applicable collective bargaining agreement. Contributions depend on the type of coverage. In addition, participants and retirees may elect to continue their participation in the Plan provided they make the required self-pay contributions. Contributions remitted by employers and participants are sufficient to provide for premiums charged by the insurance carriers. For the years ended December 31, 2024 and 2023, the monthly contribution rates ranged from \$676 to \$2,521 and from \$656 to \$2,378 respectively, depending on the type of coverage selected.

Note 10. Major Employers

Contributions from four employers accounted for approximately 68% and 63% of total contributions received during the years ended December 31, 2024 and 2023, respectively. If these employers were to suspend contributions, the Plan would terminate coverage to the employers' participants as required under the Plan document. The Plan would also retain the risk of meeting current fixed administrative expenses until the appropriate adjustments are made.

Note 11. Impact of COVID-19 Legislation

Several major legislative relief packages were enacted in response to the coronavirus outbreak, containing numerous tax, emergency funding and other regulatory provisions affecting healthcare provisions. The American Rescue Plan Act of 2021 (ARPA) provided for a 100% COBRA premium subsidy for up to six months, from April 1 through September 30, 2021, for eligible individuals, as defined under related guidance. During the year ended December 31, 2023, the Plan received \$2,607 in subsidies under ARPA.
