1. Description of Plan

The following description of Academi 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all full-time employees of Academi Training Center, LLC, XPG LLC and Academi ProShop LLC (collectively, the "Company") who have completed 90 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan was amended with an effective date of January 1, 2016. Company management is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. Constellis Management Services is the Plan's administrator and Transamerica Retirement Solutions, LLC is the Plan's recordkeeper.

The Company has entered into an agreement whereby, State Street Bank and Trust Company (the "Custodian") has been appointed the Custodian of the Plan's assets. Under the terms of the agreement, the Custodian holds and invests the funds of the Plan.

Merger:

Effective May 1, 2017, the Plan was merged into the Constellis 401(k) Plan (formerly, Triple Canopy, Inc. 401(k) Plan). As a result, the Company resolved that the Plan be terminated and that the Company would make no further contributions to the Plan and that all participants under the Plan become 100% vested in their account balance. During 2017, all investments were transferred to the Constellis 401(k) Plan and are reflected as Transfer out on the accompanying Statement of changes in net assets available for benefits. Final transfer of funds was completed on May 12, 2017, after which time the Plan was terminated. All descriptions of the Plan included herein are the provisions in effect prior to the termination.

Contributions:

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollovers, amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Safe harbor match provisions provide for employer contributions equal to 100% of the participant's contributions up to 3% of compensation, plus 50% of the participant's contributions between 3% to 5% of the participant's compensation. The Company may also make discretionary matching contributions each payroll period on behalf of participants who made elective deferrals and/or catch-up contributions. The Company may also, at its discretion, make nonelective contributions. In order to be entitled to a nonelective contribution, participants, as defined under the Plan, must complete a year of service (1,000 hours) during the Plan year and must be employed on the last day of the Plan year. No discretionary or non-elective employer contributions were made during the period ended May 12, 2017. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant accounts:

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's nonelective contribution portion of their accounts, if any is based on years of continuous service. Participants vest ratably over three years of credited service. As described in Note 1, the Plan was merged into the Constellis 401(k) Plan, effective May 1, 2017. Active participants in the Plan were fully vested in all of their accounts which were merged into the Constellis 401(k) Plan.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Payment of benefits:

On termination of service due to death, disability, or retirement, a participant or their beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or partial withdrawals. Hardship withdrawals and in-service withdrawals at age 59.5 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time.

Forfeited accounts:

There were no forfeited non-vested accounts at December 31, 2016. Any forfeited non-vested accounts at May 12, 2017 were transferred to the Constellis 401(k) Plan.

2. Summary of Accounting Policies

Basis of accounting:

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates:

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements. All Plan assets were transferred to the Constellis 401(k) Plan before close of business on May 12, 2017.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes receivable from participants:

Notes receivable from participants is measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits:

Benefits are recorded when paid.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events:

The Plan has evaluated subsequent events through May 28, 2025, the date the financial statements were available to be issued. See Note 11 for discussion of subsequent events.

3. Information Certified by Custodian

The May 12, 2017, and December 31, 2016, Statements of net assets available for benefits, the investment activities included on the Statement of changes in net assets available for benefits for the period ended May 12, 2017, and the accompanying notes to the financial statements were prepared in part or entirely from information certified as complete and accurate by the Custodian in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$0 and \$5,853,100, and notes receivable from participants of \$0 and \$177,533, at May 12, 2017, and December 31, 2016, respectively, and the net appreciation in fair value of investments and dividends and interest income of \$437,067 for the period ended May 12, 2017.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820, "Fair Value Measurements", are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

4. Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2016.

Mutual funds – Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds – Money market funds are valued at the closing price as reported by the fund sponsor from an actively traded exchange. The money market funds are open-end mutual funds that invest in short-term debt securities and cash equivalents. These funds are required to publish their daily net asset value and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

Common collective trusts – Common collective trusts are valued based on the information reported by the investment advisor using the audited financial statements of the common collective trust at year-end. The Plan's investments in collective interest trusts are valued based upon the net asset value of units owned by the Plan at year-end. The fair value of the Plan's investments is based on the net asset values of the underlying open-end mutual funds.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2016.

5. Related Party Transactions

Certain Plan investments and related transactions were in investment funds managed by the Plan's Custodian and, therefore, these investments and transactions qualify as party-in-interest transactions. The notes receivable from participants are also considered to be party-in-interest transactions. These transactions are not considered prohibited by statutory exemptions under ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. As described in Note 1, the Plan was merged into the Constellis 401(k) Plan, effective May 1, 2017. Consequently, all employees eligible under the Plan became eligible to participate in and make contributions to the Constellis 401(k) Plan. All assets were transferred as of May 12, 2017 and Plan management believes it has structured the transfer in a manner that does not constitute a plan termination. Participant account activity subsequent to May 1, 2017 will be transacted under the Constellis 401(k) Plan.

7. Tax Status

The volume submitter profit sharing plan received a favorable tax determination letter dated March 31, 2014 from the IRS. Although the Plan itself has not received a determination letter and the volume submitter profit sharing plan has been amended since receiving that determination letter, Company management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and is tax-exempt.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination of the IRS. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of net assets available for benefits.

9. Commitments and Contingencies

The Employer has initiated corrective measures to remedy the Plan for certain errors, under the IRS's Employee Plans Compliance Resolution System ("EPCRS"). EPCRS is a voluntary program in which plan sponsors may correct certain plan qualification failures and preserve the favorable tax treatment of their employees' retirement benefits.

During the period ended May 12, 2017, and the year ended December 31, 2016, the Company inadvertently failed to make deposits of \$52,100 and \$269,684, respectively, of participant deferrals, including loan repayments, on a timely basis. The DOL considers late deposits, without regard to materiality, to be prohibited transactions. The general rule for deposits of 401(k) withholdings requires that the Company remit withheld employee 401(k) deferrals to the Plan as of the earliest date on which such amounts can reasonably be segregated from the Company's general assets, but in no event later than 15 business days after the end of the month in which the contributions were withheld. The Company has self-corrected the 2016 and 2017 delinquent contributions in October 2023 and May 2024, respectively.

During 2017, the Company also inadvertently failed to make deposits of \$52,676 and \$10,140 of participant deferrals, including loan repayments and employer matching contributions, respectively. The Company has self-corrected the 2017 missed deposits of employee deferrals and employer contributions between October 2024 and April 2025.

During 2016, the Company inadvertently failed to apply the correct definition of eligible compensation, as required by the plan document. Specifically, certain bonus pay was erroneously excluded from the calculation of eligible compensation. Consequently, the Company did not withhold deferrals from and did not make matching contributions on bonuses of approximately \$2.1 million. The Company has self-corrected the 2016 missing bonus deferrals in March 2024.

Participant accounts were credited with the amount of missing deferrals, related matching contributions, and investment income which would have been earned had the errors been remitted to the Plan on a timely basis.

The Plan has received notices of determination from the DOL assessing penalties for failure to file complete Forms 5500 with financial statements for the Plan for the 2016 and 2017 plan years. The Company and its legal counsel have been in the process of responding to the notices and expect to file amended Forms 5500 as soon as administratively possible. Any penalties paid as a result of these matters will be the responsibility of the Plan Sponsor.
