The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

## **Responsibilities of Management**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Note 1. Description of the Plan**

### ***General***

The following description of the LifeServe Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by LifeServe Blood Center (Organization) for the benefit of its employees. Employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Organization. Each employee will become eligible to receive an employer match after completing one year of service with a minimum of 1,000 hours and attaining 18 years of age. The contribution period for purposes of calculating the amount of matching employer contributions is each payroll period.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Voya Retirement Insurance and Annuity Company (Voya Insurance) and Lincoln National Life Insurance Company (Lincoln) serve as plan custodians for 2024 and 2023.

### ***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Organization make annual contributions of up to 100% of eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Once eligible, the Organization contributes 100% of the first 4% of base compensation that a participant contributes to the Plan. Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Investment account options available include various annuity accounts, mutual funds and guaranteed investment contracts. Each participant has the option of directing contributions into any of the investment account options offered by the Organization and may change the allocation to the extent permitted by the individual agreements.

The Plan has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Organization's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary and the Organization's contributions plus earnings thereon.

### ***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of their account, an annuity payment option or allow the funds to be rolled over into another qualifying account. Balances less than \$1,000 will be paid to the participant and balances between \$1,000 and \$5,000 are rolled over into an IRA in the employee's name if direction is not provided otherwise. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

***Forfeited Accounts***

Participants are fully vested upon entrance to the Plan; therefore, no portion of account balances may be forfeited upon exit from the Plan.

***Plan Loans***

Participants with a balance in the Lincoln annuity contract may borrow directly from Lincoln National using a portion of their plan account as security for the loan. Loans are made to any eligible participant demonstrating a qualifying need (hardship) or for the purpose of enabling a participant to meet certain specified financial situations. The minimum amount of a loan is \$600 with the maximum amount of \$50,000. These loans are direct loans between the participant and Lincoln and as such are not treated as a transfer from the investment funds to a note receivable from participant or as a plan asset. Interest is charged on the loans at a rate between 5-7%. There are no outstanding loan balances as of December 31, 2024 and 2023.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Quoted market prices, if available, are used to value investments. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, Voya Insurance and Lincoln, the custodians of the Plan. See *Note 4* for discussion of fair value measurements. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

The fair value of the variable annuity contracts is calculated by custodians and uses a unit value based on the fair value of the underlying investments in the fund.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Plan Loans***

Participants with participant balances at Lincoln, may receive plan loans. Participants pledge as security a portion of their balance at Lincoln, which represents 100% of the outstanding loan balances.

The Employee Benefits Security Administration (EBSA) has expressed concern that the pledging of collateral of a participant's balance could be considered a prohibited transaction; however, formal guidance has yet to be issued by the EBSA.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the employer or the Plan, at the Organization's discretion.

***Scope Limitations***

The Plan has not maintained sufficient accounting records and supporting documents relating to certain contracts and custodial accounts issued to current and former employees prior to January 1, 2009. The Department of Labor (DOL) did not require audited financial statements prior to this date and, accordingly, plan management is unable to determine the extent to which the accompanying financial statements and supplemental schedule may have been affected by these conditions.

Additionally, the Plan's financial statements do not present information regarding certain investments in annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. The Plan has excluded those contracts and accounts and related activity from the Plan's financial statements for purposes of the annual reporting requirements of ERISA as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. Presentation of this information is required by GAAP. The effects of this departure from GAAP on the Plan's financial statements are not reasonably determinable.

**Note 3. Certification of Plan Custodians**

The Organization has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520. 103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln and Voya Insurance and the directed custodian Lincoln and Voya, qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate.

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

**Recurring Measurements**

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Mutual funds – Valued at net asset value (NAV) of shares held by the Plan on the last trading day of the year. These funds are required to publish daily NAV and transact at that price and are deemed to be actively traded.

Variable annuity contracts – The fair value of the variable annuity contracts is calculated by Lincoln National Life Insurance Company and uses a unit value based on the fair value of the underlying investments in the fund.

Guaranteed investment contracts – The general accounts are valued at fair value through the valuation of the underlying general account holdings and other observable inputs, including crediting rate and minimum contract rates.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Investment Contract with Insurance Company**

The Plan holds investment contracts with Lincoln and Voya Insurance. Lincoln and Voya Insurance maintain the accounts in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Lincoln investment contract is considered fully benefit-responsive. The Voya Insurance contract promises contract value for a benefit event (termination, death, disability and retirement); however, there is a possible market adjustment when the funds are withdrawn prior to maturity. Therefore, the Voya Insurance contract is not considered benefit-responsive.

The Lincoln investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Organization or other events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

## **Note 6. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are managed by Voya Insurance and Lincoln. Voya Insurance is the custodian of the majority of investments and Lincoln is the custodian of a portion of the investments and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$79,670 and \$63,700 of administrative fees rendered by the Plan during 2024 and 2023, respectively.

The Organization provides certain administrative services at no cost to the Plan.

## **Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## **Note 9. Tax Status**

The Plan, together with the investment vehicles, is intended to be a tax-sheltered annuity plan under Section 403(b) of the Internal Revenue Code of 1986, as amended. The Plan has not requested or obtained a determination letter, as the Internal Revenue Service does not currently provide that service for 403(b) plans. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

## **Note 10. Subsequent Events**

Subsequent events have been evaluated through May 29, 2025, which is the date the financial statements were available to be issued.
