### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bolger, LLC Retirement and Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the Statements of Net Assets Available for Benefits as of September 30, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Bolger, LLC Retirement and Savings Plan and Trust financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

**NOTE 1      DESCRIPTION OF PLAN**

The following description of the Bolger, LLC Retirement Savings Plan and Trust (the Plan) is intended to provide general information only. Participants should refer to the Plan Agreement and Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a single employer 401(k) profit sharing defined contribution plan sponsored by Bolger, LLC (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and all requirements of Sections 401(a) and 401(k) of the Internal Revenue Code.

Plan Administration

The Company is the Plan Administrator for the Bolger, LLC Retirement Savings Plan and Trust. Alerus Financial N.A., the Trustee of the Plan, provides custodial and investment management services with respect to the net assets of the Plan. Alerus Financial also maintains the individual participant account records, pays the distributions and retirement benefits at the direction of the Plan Administrator and advises the Plan Administrator of compliance with ERISA and other matters related to the operation of the Plan.

Eligibility

The Plan excludes all union employees, certain part-time, temporary, or seasonal employees, leased employees, and certain non-resident aliens. All non-excluded employees of the Company, who have completed one hour of service within the 90-day period following the hire date and have attained age 21, are eligible to participate in the Plan.

Auto Enrollment

The Plan includes an auto-enrollment provision whereby all newly eligible employees are enrolled in the Plan unless they elect not to participate. Automatically enrolled employees have their deferral rate set at 2% of eligible compensation. Employee contributions will increase by 1% each year until reaching 6% of eligible compensation, unless the employee elects another deferral percentage.

Contributions

Participants may elect to make deferral contributions to the Plan up to the annual dollar limitation prescribed by the Internal Revenue Service (IRS). The Plan provides for employee rollover contributions from other qualified retirement or profit sharing plans for new participants entering the Plan. All Plan contributions are forwarded directly to the Trustee and are invested at the participants' discretion.

Participants may make two types of contributions to the Plan, a pre-tax 401(k) deferral or a Roth 401(k) deferral.

The Plan allows for discretionary employer matching contributions. In accordance with the Plan, the employer may also make discretionary profit sharing contributions for eligible participants. There were no discretionary employer matching or profit sharing contributions during the Plan years ended September 30, 2024 and 2023.

Rollover Contributions

The Plan provides for participants to rollover contributions from other qualified retirement or profit sharing plans.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the employer contributions, if any, allocation of forfeitures, and allocations of plan earnings (losses), and charged with plan withdrawals and an allocation of administrative expenses. Allocations of plan earnings (losses) and administrative expenses are based on participant earnings (losses) or account balances, as defined by the Plan.

Employer discretionary contributions are allocated based on the participant's eligible compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their contributions and all employer contributions into various investment options offered by the Plan. The Plan currently offers its participants 22 diversified funds as investment options.

Vesting

Participants are immediately vested in their elective deferral contributions, rollover contributions, and employer matching contributions plus actual earnings (losses) thereon.

The following schedule determines vesting percentages for employer profit sharing contributions based on years of service:

Notes Receivable from Participants

Participant loans are permitted in accordance with the Plan's written loan policy. Loans may not exceed 50% of the participant's vested account balance or \$50,000. Payments are made through payroll deductions over the loan term, not to exceed five years. Home loans are an exception where terms are not to exceed 15 years. At September 30, 2024, interest rates on participant loans ranged from 4.25% to 9.50%.

Payment of Benefits

Upon termination of employment, participants are entitled to receive an amount equal to their vested account balance, determined as of the valuation date. The participants may elect to receive their benefits in a lump sum payment or defer some or all of the distribution within the provisions set forth in the Plan document.

Forfeitures

Forfeitures of the employer discretionary profit sharing contributions are allocated to participants based on terms of the Plan document. They can be used to offset employer contributions and the remainder will be allocated to participants in the same proportion that compensation bears to the total compensation of all participants. There were no unallocated forfeitures as of September 30, 2024 and 2023.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In the event of plan termination, participants will become 100% vested in their accounts.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

The financial statements and related notes are intended to conform with The Department of Labor's rules of Section 2520.103-8 and regulation for reporting and disclosures under The Employee Retirement Income Security Act of 1974. All information required to comply with these laws has been included herein and is in conformity with those laws.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. The realized gain or loss on sales of investments is determined based upon the average cost of investments sold. Net appreciation in fair value of mutual funds on the statements of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold, as well as, held during the year. Dividend income is recorded on the ex-dividend date. Interest is recorded as earned.

Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Excess Employee Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were excess contributions of \$12,238 and \$13,335 as of September 30, 2024 and 2023, respectively.

Due to Broker

At September 30, 2024 and 2023, fund managers affiliated with Alerus Financial, N.A. had purchased \$25,693 and \$20,241, respectively, of investments for the Plan that settled after the Plan year end. Plan assets and Alerus Financial, N.A.'s certification included the investments purchased with a related amount due to broker for securities purchased in Plan liabilities as of September 30, 2024 and 2023.

Administrative Expenses

Personnel within the Company's organization perform various administrative services for the Plan. The payroll and related overhead costs associated with these services are not included as Plan expenses.

The Plan incurred administrative expenses during the 2024 and 2023 Plan years consisting of custodian and other administrative fees to Alerus Financial of \$39,056 and \$37,751, investment advisory fees to The Hays Group, Inc. of \$19,297 and \$20,000, and audit fees to LB Carlson, LLP of \$2,195 and \$1,655, respectively. During the 2023 Plan year the Plan Administrator paid \$13,517 of audit fees to LB Carlson, LLP that were accrued on the Plan's financial statements as of September 30, 2022. The accrued audit fees were reversed during the Plan year ended September 30, 2023.

The Plan participates in revenue sharing from investments in specific funds offered in the Plan. These revenues are received by Alerus Financial and credited to the Plan to pay for any allowable fees. For the Plan years ended September 30, 2024 and 2023 fees of \$4,297 and \$5,155, respectively, were paid via revenue sharing.

**NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan has received certifications from the Trustee that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

**NOTE 4 FAIR VALUE MEASUREMENTS**

The Fair Value Measurements Topic of the FASB Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"> <li>◆ Quoted prices for similar assets or liabilities in active markets;</li> <li>◆ Quoted prices for identical or similar assets or liabilities in inactive markets;</li> <li>◆ Inputs other than quoted prices that are observable for the asset or liability;</li> <li>◆ Inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li> </ul> If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan Administrator determines the fair value measurement policies and procedures subject to oversight by the Plan's investment committee. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted as necessary, based on current market conditions and other third-party information.

**NOTE 5 FEDERAL INCOME TAX STATUS**

Alerus Financial, the provider of the prototype Plan Document adopted by the Plan has received an opinion letter in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code. The Plan is relying on the opinion letter that the prototype plan received from the Internal Revenue Service, that the Plan is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees.

The prototype plan has been amended since receiving the opinion letter; however, the Plan Administrator believes the prototype plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan Administrator believes the Plan meets the requirements of Section 401(a) of the IRC and is exempt from federal income tax under Section 401(a) of the Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 PARTY-IN-INTEREST TRANSACTIONS**

Plan Trustee and Custodian

Fees incurred by the Plan for investment services are included in net appreciation in fair value of investments, as they are paid through revenue sharing and are charged directly to each participant's account, rather than a direct payment. In addition, as described in Note 2, the Plan made direct payments to Alerus Financial, N.A. of \$34,759 and \$32,596 for custodian and other administrative fees which were not covered by revenue sharing and included in administrative expenses for the Plan years ended September 30, 2024 and 2023, respectively.

**NOTE 7 RISKS AND UNCERTAINTIES**

The Plan provides for various investment fund options including U.S. Government securities, corporate debt securities, and equities. Investment securities in general are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect the value of investments.
