## Independent Auditors' Report

To the Board of Trustees  
Nogales Produce, Inc. Profit Sharing Plan

### Opinion

We have audited the financial statements of Nogales Produce, Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (Liquidation Basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (Liquidation Basis) for the year ended December 31, 2024, and the related notes to the financial statements (Liquidation Basis).

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Nogales Produce, Inc. Profit Sharing Plan as of December 31, 2024 and 2023 (in liquidation), and the changes in net assets available for benefits for the year ended December 31, 2024 (in liquidation) in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Emphasis of Matter - Terminating Plan and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Board of Directors of the Nogales Produce, Inc., the Plan's sponsor, voted on October 6, 2023 to terminate the plan. In accordance with accounting principles generally accepted in the United States of America, the plan has changed its basis of accounting from the ongoing plan basis to the liquidation basis used in presenting the 2023 and 2024 financial statements. Our opinion is not modified with respect to this matter.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. **Note 1 – Description of Plan**

The following description of the Nogales Produce, Inc. (the “Company”) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and its Adoption Agreement for a more complete description of the Plan's provisions.

*Termination*

On October 6, 2023, the Company approved the termination of the Plan effective December 31, 2023. Participants in the Plan became 100% vested as of December 31, 2023. The Company directed the distribution of participant’s accounts in a manner permitted by the Plan. As of December 31, 2024, the Plan had distributed all plan assets to participants.

*General*

The Plan is a defined contribution plan covering all full-time employees of the Company who have one year of service and are age twenty-one or older. It is subject to provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All the Plan’s investments are directed by the Plan Trustee. Effective January 1, 2020, the Plan was amended to allow for in-service distributions upon the attainment of age 59 ½. Effective January 1, 2022, the Plan was amended and restated to comply with the requirements of the SECURE, CARES, and CAA final regulations.

*Contributions*

The amount to be contributed each year is determined by management of the Company and is completely discretionary. There were no contributions for the years ended December 31, 2024 and 2023.

*Participant Accounts*

Each participant’s account is credited with an allocation of (a) the Company’s contribution, and (b) Plan earnings, gains and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Plan Administration*

The Plan is administered by the Plan Administrator who is appointed by management of the Company. The Plan’s custodian, Regions Bank, is responsible for the custody and management of the Plan’s assets.

*Vesting*

Vesting in the Company’s contribution portion of participant’s accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service. Effective with the Plan’s termination on December 31, 2023, participants became fully vested in their accounts.

*Payment of Benefits*

On termination of service due to death or disability or for any other reason, a participant will receive an amount equal to 100% of the participant’s interest in his or her account in a lump-sum amount.

*Forfeited Accounts*

When certain terminations of participants in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Non-vested accounts totaling \$- and \$370 were forfeited during 2024 and 2023, respectively. Forfeitures were reallocated to participants in the same manner as employer contributions.

**Note 2 – Summary of Significant Accounting Policies**

*Basis of Accounting*

For the years ended December 31, 2024 and 2023, the financial statements were prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

*Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Shares of registered investment companies (mutual funds) are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. See Note 4 for discussion of fair value measurements. As of December 31, 2023, all plan assets were invested in money market funds and publicly traded mutual funds with listed market values.

Purchases and sales of securities are recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits*

Benefits are recorded when paid.

*Administration Expenses*

Administrative expenses may be paid by the Plan or by the Employer.

**Note 4 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived primarily from of corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**Note 4 – Fair Value Measurements (continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Fund:* Valued at quoted market price as of the reporting date.

**Note 5 – Related Party and Party in Interest Transactions**

Officers or employees of the Company perform certain administrative functions for the Plan. No such officer or employee receives compensation from the Plan. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. Administrative fees paid directly by the Company amounted to \$32,200 during the year ended December 31, 2024.

**Note 6 – Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts. The Plan Sponsor elected to terminate the Plan on December 31, 2023. All participants became 100% vested in their accounts and may elect to have distributions paid directly to the participant or transferred to another eligible retirement plan or individual account.

**Note 7 – Tax Status**

Prior to plan termination, the Internal Revenue Service (“IRS”) had determined and informed the Company by letter dated June 30, 2020, that the Plan and related trust was designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan had been amended since receiving the determination letter. However, the Plan administrator believes that the Plan was designed and was currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes had been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS.

**Note 8– Risks and Uncertainties**

The Plan invested in various mutual funds. Investments in mutual funds were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investments in mutual funds, it is at least reasonably possible that changes in the values of the investment will occur in the near term and that such changes could materially affect participant account balances, and the amounts reported in the statements of net assets available for benefits.
