Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Augustana College Defined Contribution Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended August 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Augustana College Defined Contribution Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2024 and 2023, and for the year ended August 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. NOTE 1 DESCRIPTION OF PLAN

The following description of the Augustana College Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, originally effective September 1, 1986. The Plan has been amended throughout the years to comply with the legislation and most recently restated September 1, 2021. The Plan covers eligible employees of Augustana College (the College) who have completed 1,000 hours of service within a 12-month period. Eligible employees entered the Plan on the first of the month following the month in which they met eligibility requirements. The Plan also allowed eligible employees who had fully vested retirement benefits under the plan of a previous employer to enter the Plan on the next Plan entry date after their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The College amended the Plan to freeze the Plan, effective for the Plan years beginning on or after September 1, 2014. Any individual who was not a participant in the Plan on August 31, 2014 shall not be eligible to become a participant in the Plan.

Contributions

As a result of the amendment to freeze the Plan, no contributions of any type shall be made or permitted with respect to compensation paid after August 31, 2014. The Plan will not accept rollover contributions or contributions that are transferred directly from another plan qualified under sections 401(a) or 403(a) of the Internal Revenue Code (IRC) after August 31, 2014.

Participant Accounts

Each participant's account is credited with allocations of the Plan's earnings or losses and is charged with his or her withdrawals and allocation of administrative expenses. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting

As a result of the College's amendment to freeze the Plan for Plan years beginning on or after September 1, 2014, each participant in the Plan shall be fully vested in the participant's account balance effective August 31, 2014.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive benefits in a lump-sum amount equal to the value of their account, monthly installments over the life expectancy of the participant or the beneficiary (single life or survivor annuities), or for a fixed period of time. Lump-sum withdrawals from TIAA annuity contracts are subject to a 2.5% surrender charge and must be made within 120 days of termination of employment. Participants with investments in certain contracts of the TIAA Traditional Annuity may also elect to receive benefits over a seven-year fixed period. If the participant dies during the fixed period, payment will continue in the same amount to the participant's designated beneficiary for the duration of the period.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of investments are reflected on a trade-date basis. Interest income is recorded as earned and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefits paid directly to participants are recorded when paid. For participants who elect to receive benefits in the form of an annuity, an individual annuity contract is signed between the participant and TIAA and CREF. The distribution is deducted from Plan assets at the time the contract is initiated.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the College and are excluded from these financial statements. Certain professional fees are paid directly out of the Plan by first utilizing any revenue credits earned during the year. Fees related to the administration of participant transactions are charged directly to the participant's account. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through May 20, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

TIAA on behalf of TIAA, FSB and TIAA Trust, N.A., and TIAA and CREF, the qualified institutions of the Plan, have supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of August 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended August 31, 2024, and the supplemental schedule of assets (held at end of year) as of August 31, 2024.

NOTE 4 GUARANTEED FIXED ANNUITY

Each participant maintains an individual annuity contract with TIAA and/or CREF. TIAA may maintain a portion of the contributions in a "guaranteed account," which is called the TIAA Traditional Fixed Account. The account is credited with earnings on the underlying investments and changed for withdrawals and administrative expenses charged by TIAA.

The participant's principal, plus a specified rate of interest, are guaranteed by TIAA's claims paying ability. TIAA Traditional Annuity also provides an opportunity for participants to receive additional amounts, which the TIAA Board of Trustees may declare on a year-by-year basis, which begins each March 1. These additional amounts, when declared, remain in effect for a 12-month period and are not guaranteed for future years. The guaranteed minimum interest rate during the accumulation phase of the contract is generally between 1% and 3%. The guaranteed minimum interest rate during the payout phase is 2%.

Certain Traditional Fixed Account individual annuity contracts are considered to be nonbenefit-responsive. These contracts are included in the financial statements at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer. These contracts are subject to a seven-year withdrawal period. Upon termination of the contracts, the amount of each transfer payout annuity payment will be determined as of the annuity starting date for the transfer payout annuity by the amount of the Traditional Fixed Account accumulation and the interest rates in the rate schedules under which any premiums, additional amounts, and internal transfers were applied to the account.

Certain Traditional Fixed Account individual annuity contracts meet the fully benefit responsive criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 5 INVESTMENT LIQUIDITY

Investment liquidity in CREF variable annuity accounts and the pooled separate account is limited based on the various terms of the investment funds. Transfers and cash withdrawals from a CREF variable annuity account and the pooled separate account must generally be at least \$1,000 per transaction except for automatic, systematic transfers or withdrawals, which must generally be at least \$100 per transaction.

The CREF variable annuity accounts, and the pooled separate account also contain specific lock out provisions designed to discourage excessive trading. Under these policies and procedures, if within a 60 calendar day period, a participant redeems or exchanges any monies out of a CREF variable annuity account, subsequently purchases or exchanges any monies back into that same account and then redeems or exchanges any monies out of that same account, the participant will not be permitted to make electronic transfers back into the same account through a purchase or exchange for 90 calendar days. These restrictions do not apply to certain systematic transactions, automatic fund rebalancing, contributions, benefit payments, or other specified transaction types. Withdrawals from the pooled separate account can be executed on any business day but are limited to one withdrawal per calendar quarter.

Investment liquidity in the TIAA Traditional Annuity is also limited based on the terms of the investment contract. Participants in the RC contract may only make withdrawals from the annuity account in the form of a life annuity or in seven annual installments.

NOTE 6 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at August 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable Annuity Accounts: Valued at the unit value (UV) of units as determined by the insurance company. UV is a readily determinable fair value and is the basis for current transactions.

Nonbenefit-Responsive Fixed Account: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

Pooled Separate Account: Valued at the NAV of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

NOTE 8 PLAN TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the College by a letter dated October 7, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, Plan management believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by TIAA and CREF. TIAA and CREF are the qualified institutions of the Plan, as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 10 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
