Nvest, Inc. 401(k) Plan Notes to Financial Statements

1. Description of the Plan

Nvest, Inc. (the Company) established the Nvest, Inc. 401(k) Plan (the Plan), effective November 25, 2013, to provide participants with a means to fund their retirement on a tax-deferred basis. The Plan was amended and restated, most recently as of January 1, 2025.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan under provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by Company employees, who are responsible for selecting investment options offered under the Plan and monitoring investment performance. Ascensus Trust Company (Ascensus) is the Plan's trustee. Ascensus holds, invests, and reinvests Plan assets in the interest and direction of the participants and their beneficiaries. The Vanguard Group, Inc. (Vanguard) is the record keeper and has outsourced recordkeeping services to Ascensus, LLC.

Eligible Participants:

Employees who are at least 18 years of age, as defined by the Plan agreement, may participate in the Plan immediately upon date of hire.

Contributions:

Participants may make contributions to the Plan through pre-tax salary reductions or post-tax deductions up to 100% of annual compensation, as defined under the Plan agreement, subject to certain limitations under the Code. Participants who have reached the age of 50 may also elect to withhold additional catch-up contributions under the Code. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers), subject to Code regulations.

The Plan provides for automatic enrollment on the participant's eligibility date. The automatic election for eligible participants is 5% of their compensation, unless participants request a different amount to be contributed or formally decline participation.

1. Description of the Plan (continued)

Contributions: (continued)

The Company may make discretionary matching and profit-sharing contributions to the Plan, as determined by the Company's Board of Directors. In 2024, the Company made discretionary matching contributions representing up to 50% of each eligible participant's contributions, not to exceed 2% of the participant's eligible compensation. There have been no profit-sharing contributions made to the Plan through December 31, 2024.

Contributions are subject to certain limitations under the Code.

Participant Accounts:

Participant accounts are credited with participant contributions, Company contributions, and rollovers, plus earnings (less any losses) thereon. Allocations are based on participant earnings or account balances, in accordance with Plan agreement. The benefit to which participants are entitled to the benefit that can be provided from the participant accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

Vesting:

Participants are immediately vested in their salary deferral, after-tax, rollover, and Company discretionary matching contributions, plus earnings (less any losses) thereon. Vesting in Company discretionary profit-sharing contributions, if any, plus allocated earnings (less any losses) thereon, is based on years of continuous service. Participants would vest in Company discretionary profit-sharing contributions at the rate of 20% after two years of service and would become fully vested after six years or upon retirement, disability, or death.

Forfeitures:

Forfeitures of Company contributions, if any, are used to reduce future Company contributions or pay Plan administrative expenses. There was \$93 in the forfeiture account at December 31, 2024 (\$6,547 at **December 31, 2023**). Forfeitures of \$6,443 were used to pay to reduce employer contributions in 2024.

1. Description of the Plan (continued)

Notes Receivable from Participants:

The Plan agreement does not permit notes receivable from participants.

Payment of Benefits:

Upon termination of service, participants may elect to leave their account balances in the Plan or receive their benefits in a lump sum amount equal to the value of the participant account, or in partial payments. Accounts below \$1,000 may be automatically distributed directly to participants without participant approval. Benefits are recorded when paid.

Plan Expenses:

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the financial statements. Certain fees are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

Risks and Uncertainties:

The Plan offers a variety of investment options to participants. Investments are exposed to various risks, such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the financial statements.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a Plan termination, participants would become fully vested in their accounts and distributions would be made to participants, as described in the Plan agreement.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S.).

2. Summary of Significant Accounting Policies (continued)

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the U.S. requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments:

Investments consist of mutual funds and a money market fund. These funds are reported at fair value, which is the net asset value (NAV) of shares held by the Plan at year end, as quoted in active markets. It is not probable the funds will be sold at amounts that differ materially from the NAV of shares held.

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability at the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement is defined as follows:

- Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The Plan's mutual funds and money market fund are recorded at fair value and classified as Level I within the fair value hierarchy at December 31, 2024 and 2023.

2. Summary of Significant Accounting Policies (continued)

Income Recognition:

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on Plan investments bought, sold or held during the year.

3. Information Prepared and Certified by Ascensus

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Ascensus, the qualified institution of the Plan, has supplied the Plan administrator with certifications as to the completeness and accuracy of all investment and notes receivable information presented on the accompanying statements of net assets available for benefits as of December 31, 2024 **and 2023**, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Income Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan has been amended since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

4. Income Tax Status (continued)

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

5. Party-In-Interest Transactions

All Plan investments are managed by Vanguard. As Vanguard is the Plan's record keeper, purchases and sales of the Plan's investments qualify as party-in-interest transactions. Party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Subsequent Events

Subsequent events have been evaluated through May 30, 2025, which is the date the financial statements were approved by the Plan and available to be issued.
