Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the NueHealth Meridian 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of November 11, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits in liquidation for the period from January 1, 2024 through November 11, 2024, and the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of November 11, 2024 and December 31, 2023, and for the period from January 1, 2024 through November 11, 2024, and the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Basis of Accounting

As discussed in Note 1(a) to the financial statements, the Plan Sponsor approved a plan of liquidation on December 31, 2023. As a result, the Plan has changed its basis of accounting to the liquidation basis used in presenting the 2024 and 2023 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Notes to the Financial Statements

November 11, 2024 and 2023

(1) Description of plan

The following description of the NueHealth Meridian 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan was a defined contribution plan which was adopted on August 1, 2006 and provides retirement benefits for employees of ValueHealth, LLC employed at five facilities. Nueterra Capital, LLC, an affiliate of ValueHealth, LLC, is the Plan Sponsor. The Plan covered substantially all employees, except PRN employees, who are age twenty-one or older ("participants"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective December 31, 2023, the Plan was amended to provide for the termination of the Plan. As a result of the termination, all contributions to the Plan ceased as of September 1, 2023. Furthermore, participants became fully vested in their accounts in accordance with the termination. Approximately \$5,872,716 of participant account balances were distributed to participants or their beneficiaries during the period from January 1, 2024 through November 11, 2024.

(b) Contributions

Participants could voluntarily make qualified retirement contributions to the Plan which were deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participants could also make contributions on an after-tax basis. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants could contribute up to any amount of compensation, not to exceed limitations prescribed by the IRC. There were no participant contributions after September 1, 2023.

The Plan Sponsor made a matching contribution equal to 25% of each participant's contributions up to a maximum of 6% of the participant's compensation. Plan Sponsor and participant contributions could not exceed the maximum amount allowable for federal income tax purposes.

The Plan also provided that the Plan Sponsor could contribute each year a discretionary amount authorized by the Plan Sponsor's management; however, an annual contribution by the Plan Sponsor was not required. No discretionary contributions were made by the Plan Sponsor during 2024 or 2023.

(c) Participant accounts

Each participant's account was credited (charged) with the participant's contributions, Plan Sponsor contributions, investment earnings (losses), and administrative expenses. Allocations were based on participant compensation or account balances as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants were immediately vested in their elective salary deferrals plus actual earnings (losses) thereon. Vesting in the Plan Sponsor's contributions was based on years of continuous service. Participants vested 25% after the first year of service and 25% each year thereafter until fully vested after four years of service.

As of December 31, 2023, the Plan was terminated, therefore, making all participants fully vested in the Plan Sponsor contributions.

(e) Payment of benefits

On termination of service due to death, permanent disability, or retirement, a participant could elect to receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant would be entitled to receive only the vested interest in his or her account as a lump-sum distribution.

(f) Forfeited accounts

Forfeitures were created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures were used to reduce the Plan Sponsor's contributions to the Plan.

(g) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's vested account balance.

(h) Administrative expenses

All administrative expenses were paid out of the Plan. Certain fees incurred by the Plan for the investment management services and recordkeeping were included in net appreciation (depreciation) in fair value of investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

As described in Note 1(a), the Plan was terminated effective December 31, 2023. In accordance with accounting principles generally accepted in the United States of America ("GAAP"), the financial statements of the Plan have been prepared under the liquidation basis of accounting.

(b) Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by Capital Bank and Trust Company ("CB&T"). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Dividend income was recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as, held during the year.

(c) Payment of benefits

Benefits were recorded when paid.

(d) Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Events occurring after the reporting date

Plan management has evaluated events and transactions that occurred between November 11, 2024 and May 22, 2025, which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Information related to investments presented and disclosed in the accompanying financial statements, including the fair value of investments held at November 11, 2024 and December 31, 2023, and net appreciation in fair value of investments and dividend income for the period from January 1, 2024 through November 11, 2024 and for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by CB&T.

(4) Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at November 11, 2024 and 2023.

- (i) *Mutual funds*: Valued at the net asset value of shares held by the Plan at year end in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Income tax status

The Plan Sponsor adopted a pre-approved defined contribution plan, which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the pre-approved plan was designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter. However, the plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC and was therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 11, 2024 and December 31, 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Related party and party-in-interest transactions

The Plan's investments were held by CB&T, the trustee of the Plan, and were shares of mutual funds managed by American Funds Service Company, an affiliate of CB&T. Therefore, related transactions qualify as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers which also qualify as party-in-interest transactions.
