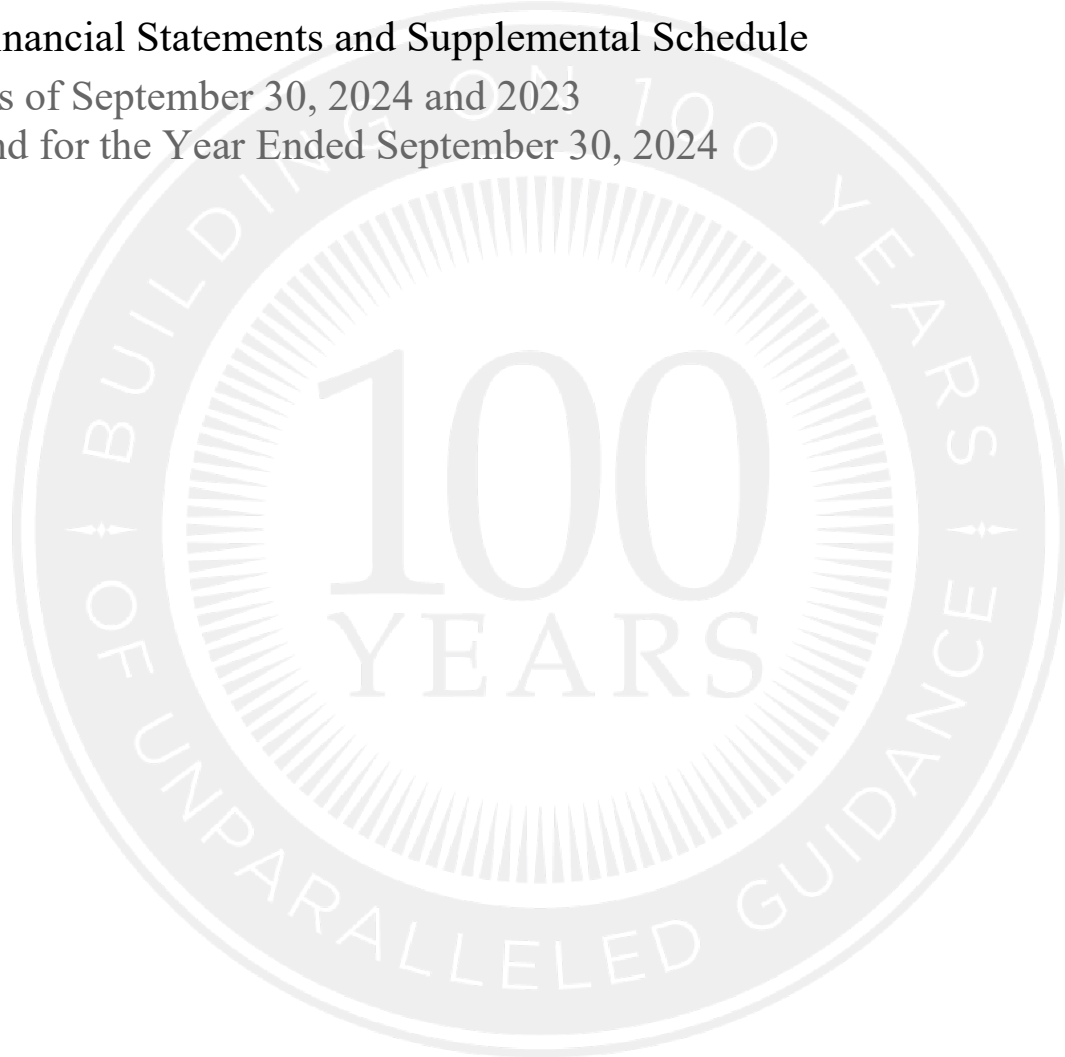

## Independent Auditor's Report

To the Plan Administrator of the North Coast Sea-Foods, Corp. 401(k) Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of North Coast Sea-Foods, Corp. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of September 30, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

## Notes to Financial Statements

As of September 30, 2024 and 2023 and for the Year Ended September 30, 2024

### 1. DESCRIPTION OF THE PLAN

The following description of the North Coast Sea-Foods, Corp. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan established for the benefit of the employees of North Coast Sea-Foods, Corp. and the employees of North Coast’s wholly-owned subsidiary, Long Point Trucking, LLC (collectively the “Company”). The Company is also the Plan Administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was most recently amended on October 1, 2020.

All assets acquired under the Plan from employee and Company contributions, income and other additions will be administered, distributed, forfeited and otherwise governed by the provisions of the Plan. The Plan is administered by the Company for the exclusive benefit of participants in the Plan and their beneficiaries.

#### *Eligibility*

Each person who is at least 21 years of age is eligible to participate in the Plan and may join the Plan on the first day of each plan year quarter following the date on which the participant meets the eligibility requirements. Each person who is at least 21 years of age, has completed at least 1,000 hours, and has one year of continuous service with the Company is eligible for Company contributions.

#### *Participant Contributions*

An active participant may elect to make two types of contributions to the Plan as follows:

##### *Salary Deferral Contributions*

Each active participant may elect, but shall not be required, to contribute a percentage or fixed dollar amount of their compensation up to the amounts determined by the Plan and subject to the applicable Internal Revenue Code Sections.

##### *Rollover Contributions*

An eligible participant may, with permission of the Plan Administrator, contribute to the Plan the distributions they receive from other qualified plans or individual retirement accounts, as long as the contributions satisfy the tax law requirements for a qualified rollover.

## ***Employer Contributions***

The Company may provide an annual discretionary matching contribution. During 2024, the Company provided matching contributions in an amount equal to 100% of each participant's elective deferral not to exceed 3% of the participant's compensation. Such amount is remitted subsequent to year end and is recorded as an employer contribution receivable at each year end.

The Company may also make a discretionary profit sharing contribution to the Plan. No profit sharing contributions were made in 2024.

## ***Participant Accounts***

Each participant's account is credited with the participant's contribution plus allocations of the Company's contributions and Plan earnings and is charged with an allocation of the Plan's administrative expenses. Allocations are based on participant earnings or account balances, as defined.

## ***Vesting***

A participant's vested interest in that portion of the participant's account attributable to matching contributions vest according to the following schedule with service being credited from date of employment:

## *Forfeitures*

As of September 30, 2024 and 2023, forfeited non-vested accounts total \$4,178 and \$11,151, respectively. In 2024, employer contributions were reduced by \$4,178 from forfeited nonvested accounts.

## *Investments*

Upon enrollment in the Plan, a participant may direct how their salary deferral and rollover contributions and any Company contributions will be invested. A participant may choose the various investment options offered by Voya Retirement Insurance and Annuity Company, and investment options in a self-directed brokerage account held in a trust by Voya Institutional Trust Company (the "Trustee"). Participants may change their investment options any time throughout the year via direct phone access or internet access to Voya Retirement Insurance and Annuity Company.

## *Payment of Benefits*

Generally, if a participant terminates employment under any circumstance, and the participant's vested account balance is \$5,000 or less, the vested balance will be distributed in one lump sum.

Unless elected otherwise, payment of vested benefits will begin at normal retirement age as defined by the Plan (age 65). If employment continues past normal retirement age, benefit payments will start on the participant's later retirement date, but no later than required by law, unless the normal date is elected. A participant may elect to have benefits paid at early retirement, as defined by the Plan. Upon death, vested benefits are paid to a participant's beneficiary. Upon retirement or death, various payment options are available as defined by the Plan.

## *Continuance of the Plan*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **2. SIGNIFICANT ACCOUNTING POLICIES**

### *Basis of Presentation*

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

## *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## *Investment Valuation and Income Recognition*

Investments are reported at the value reported to the Plan by the Trustee, which represents fair value. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## *Contributions*

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

## *Tax Status*

The Internal Revenue Service ("IRS") issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, it believes that the Plan is qualified and the related Trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor ("DOL"). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS and DOL, however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to examinations for years prior to September 30, 2021.

## *Excess Participant Contributions*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions for each year to the applicable participants in the following year.

## *Payment of Benefits*

Benefits are recorded when paid.

## *Administrative Expenses*

Substantially all administrative costs of the Plan were paid by the Company for the year ended September 30, 2024. Fees paid for investment management services for the Plan are not separately stated but are included as a reduction of the return earned on each investment fund option.

### **3. CERTIFIED INVESTMENT INFORMATION**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of September 30, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Institutional Trust Company.

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 – Valuation is based on quoted prices in active markets for identical assets or liabilities. Valuations are obtained from readily available pricing sources for market transactions involving identical assets or liabilities.

Level 2 – Valuation is based on observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – Valuation is based on unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. Level 3 assets and liabilities include financial instruments whose value is determined using unobservable inputs to pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

In certain cases, inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, an investment's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the investment.

The Plan recognizes transfers between levels at the end of the reporting period as if the transfers occurred on the last day of the reporting period.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Pooled separate accounts:* Valued at the accumulation unit value which is determined based upon the combination of the net asset values of the underlying investments. The net asset value ("NAV") equivalent is used as a practical expedient to estimate fair value. This practical expedient would not be used if it was determined to be probable that the funds will sell the underlying investments for an amount different from the reported NAV equivalent.

*Self-directed brokerage accounts:* Valued at observable prices for identical or similar assets.

Common stock is valued at the closing price reported on the active market on which the individual securities are traded. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Guaranteed interest accounts:* Valued at NAV as determined by the Trustee based on the underlying investments. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it was determined to be probable that the underlying investment will sell for an amount different from the reported NAV equivalent.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 6. PARTY-IN-INTEREST TRANSACTIONS

Voya Institutional Trust Company is the Trustee as defined by the Plan and, therefore, transactions with the Trustee qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee amounted to \$2,200 for the year ended September 30, 2024.

Certain Plan investments are shares of pooled separate and guaranteed interest accounts managed by the Voya Retirement Insurance and Annuity Company. The Voya Retirement Insurance and Annuity Company is affiliated with the Trustee and therefore these transactions qualify as party-in-interest transactions. Fees paid for investment management services are included as a reduction of the return earned by each pooled separate account.

### 7. RISKS AND UNCERTAINTIES

The Plan invests in a variety of investment securities. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risk factors in the near term could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
