Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the SEIU Local 200 United 401(K) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the SEIU Local 200 United 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the Service Employees Benefit Fund (SEBF), Service Employees Pension Fund of Upstate New York (SEPFUNY), SEIU Local 200 United (Local 200), 1199 SEIU Regional Pension Fund (1199 SEIU), Masonic Care Community of New York (Masonic), Finger Lakes Racing Association (FLRA), and Atalian US Northeast, LLC (Utica College) It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Board of Trustees is comprised of one trustee of Local 200 and one management representative. The assets of the Plan are held by VOYA Retirement Insurance and Annuity Company (VOYA), the Trustee. Crown Risk Management, LLC serves as the recordkeeper.

Eligibility

Eligibility is dependent upon the participating employer group for which a participant works. FLRA employees become participants in the Plan on the earlier of: 1) the first of January following the Plan year in which the employee was employed for 25 or more racing days of service; 2) the first of January following the completion of 25 or more racing days of service during a twelve consecutive month period; or 3) the date six months following the completion of 25 or more racing days of service during a twelve consecutive month period. FLRA employees continue participation in the Plan by completing a minimum of 25 days of service during each Plan year.

Employees who are not employed by FLRA or Masonic are eligible to participate in the Plan upon one hour of service. Newly hired Masonic employees are no longer eligible to participate as it is a closed Plan, and no new participants are accepted.

Contributions

Participants are permitted to contribute up to 100% of their pre-tax compensation, subject to certain limitations under the terms of the Plan and the Internal Revenue Code (IRC).

Each employer who has entered into a collective bargaining agreement (CBA) shall contribute to the Plan on behalf of each collectively bargained employee the amounts set forth in the applicable CBA.

Rollover contributions may be made to the Plan up to the entire amount of cash received in a lump-sum distribution from another qualified plan or individual retirement account.

1. DESCRIPTION OF THE PLAN (Continued)

Participant Accounts

Participants direct the investment of their contributions and their employer's contributions into various options offered by the Plan. These options may include the specific offerings of the Plan, or a portfolio of those offerings, that are automatically rebalanced based on allocation percentages determined by an investment advisor to achieve a set risk profile. Each participant's account is credited with the participant's contributions, the employer matching contributions, and actual earnings/losses thereon.

Vesting

Participants are 100% vested in employee contributions upon deposit into their accounts. Employer contributions are 100% vested after obtaining 3 or more years of service. For non-FLRA participants, a year of service is any vesting computation period during which the participant completes at least 1,000 hours of service with the employer. For FLRA participants, a year of service is any Plan year in which the participant completes 25 days of service. Participants with less than 3 years of service are not vested in their accounts.

Notes Receivable from Participants

Participants, excluding those participants employed by FLRA due to the seasonal nature of employment, may borrow from their accounts up to a maximum of the smaller of \$50,000 or 50% of their vested account balance, less any receivables outstanding. The minimum loan amount may not be less than \$1,000. The receivables are secured by the balance in the participant's account and bear interest at the prevailing rate for similar loans on the date of the receivable. This rate is fixed for the duration of the loan. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from the participant's account but shall not exceed the lesser of: 1) the amount required to meet the immediate financial need of the participant; or 2) the vested amount credited to the participant's account. Hardship withdrawals can only be taken against the participant's contributions. Hardship withdrawals are only permitted if necessary to satisfy the immediate and heavy financial needs of a participant.

Forfeitures

Forfeitures of non-vested portion of participant's accounts are used to offset Plan expenses. During 2024 and 2023, \$7,224 and \$800, respectively, in forfeitures were used to pay for Plan expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0- for both years.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States.

Cash

Cash consists of bank demand deposit accounts. At times, the balances in these accounts may exceed federally insured limits. The Plan has not experienced any losses in these accounts and management believes the Plan is not exposed to any significant credit risk with respect to cash.

Investments

The Plan provides options for various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the accompanying financial statements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques are used to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 or 2023.

Insurance contracts: Valued at fair value, as reported to the Plan by VOYA based on contributions made under the contracts, plus earnings, and reduced for withdrawals and administrative expenses and an estimate of the surrender charges if the Plan was terminated (Level 3). The contract period is on an ongoing basis and will only be terminated upon meeting certain conditions including written notification from the Plan's management subject to approval by the Plan and VOYA.

For Level 3 assets, the Plan discusses the fair value measurement valuation policies and procedures with the Trustee. The Plan, guided by the Trustee, determines if the current valuation techniques used in the fair value measurements are still appropriate and evaluates and adjusts the unobservable inputs used in the fair value measurements based on current market conditions and third-party information. There were no changes in the valuation techniques during the current year.

Pooled separate accounts: The separate accounts own and hold underlying mutual funds or collective unit trust shares which are valued daily at their net asset value. The Plan holds units of participation which are valued daily at the accumulation unit value (AUV) adjusted for changes in net asset value of underlying fund, dividends, and separate account charges. The accumulation unit value is the value of each unit in the separate account and the separate account is valued daily as the number of accumulation units held multiplied by the AUV. The pooled separate account pools funds in order to allow for lower trading costs and diversification of the investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Employer Contributions Receivable

Employer contributions receivable outstanding as of December 31, 2024 and 2023 have been collected in full by the Plan subsequent to the respective year-end. Therefore, no allowance for uncollectible receivables was required as of December 31, 2024 and 2023.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Benefits are recorded as an expense when paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Administrative Expenses

Administrative expenses are paid by the Plan.

Income Taxes

For employee benefit plans, their tax-exempt status itself is deemed to be an uncertainty since events could potentially occur to jeopardize their tax-exempt status. The Plan files the Annual Return/Report of Employee Benefit Plan (Form 5500) in the U.S. federal jurisdiction.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates and such differences may be significant.

4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Board of Trustees has the right to discontinue the Plan at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the interest of the affected participants in the Plan will remain fully vested and non-forfeitable. The Board of Trustees shall determine the value of each participant's and beneficiary's account based on current valuations, and the amount shall be promptly distributed. However, the Board of Trustees has the option of deferring distribution until it would normally become due under the Plan, had the termination not occurred.

5. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan sponsor by a letter dated October 1, 2015, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

6. PARTY-IN-INTEREST TRANSACTIONS

Shared Services

The Plan receives employer and participant contributions weekly from the SEBF, SEPFUNY, Local 200 and SEIU. The Plan receives and then deposits and transfers all contributions through consolidated checks or through ACH received from the employers. FLRA checks are received monthly due to the seasonal nature of the workforce.

Participating employers reimburse the Plan for annual Plan administrative expenses in accordance with their participation agreements. As of December 31, 2024 and 2023, there was \$14,013 and \$14,022, respectively, in Plan administrative expenses that were to be reimbursed to the Plan by the participating employers.

Plan participants are subject to a flat fee plus a pro rata amount to cover Plan expenses. Participant accounts are charged \$40 per quarter plus a pro rata amount to cover additional Plan expenses. The participant fees are administrative fees in the accompanying financial statements. The Plan expenses paid with these participant fees, rather than by a participating employer, are administrative expenses in the accompanying financial statements.

Investments

The Plan has holdings in various pooled separate accounts managed by VOYA, the Trustee as defined by the Plan, which qualify as party-in-interest transactions.

Certain Plan assets consist of notes receivables from participants, which qualify as party-in-interest transactions.
