Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter—Supplemental Schedules Required by ERISA**

The supplemental schedules of schedule H, Line 4a—schedule of delinquent participant contributions for the year ended December 31, 2023, and schedule H, Line 4i—schedule of assets (held at end of year) as of December 31, 2023, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note 1. Plan Description

The following description of the Barkley, Inc. (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all full-time employees of the Company who are age 21 or older. The Board of Directors is responsible for the oversight of the Plan. The Plan's management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility:** Leased employees and employees who are covered by an agreement between a union and the Company shall not be eligible to participate in the Plan if retirement benefits were the subject of good faith bargaining between the union and the Company. Additionally, temporary employees and those employed in an internship position working less than 1,000 hours are not eligible for the Plan. Eligibility for discretionary employer matching contributions is immediate upon meeting the eligibility requirements to participate in the Plan. Eligibility for nonelective employer contributions requires at least 1,000 hours of service during the Plan year and employment on the last day of the Plan year.

**Contributions:** Each year, participants may contribute an amount not to exceed 50% of their compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan will automatically enroll participants hired or rehired at a 4% deferral rate on the first entrance date following the participant becoming eligible to participate unless the participant elects a different deferral rate prior to the automatic enrollment date.

The Company may make discretionary matching contributions to the Plan. The discretionary matching contributions are subject to annual review and adjustment by the Company's Board of Directors. The Company contributed to the Plan discretionary matching contributions equal to 50% of a participant's elective deferral up to 4% elective deferral, not exceeding 4% of participant compensation for the year ended December 31, 2023.

Additional nonelective employer contributions may be contributed at the option of the Company's Board of Directors. There were no nonelective employer contributions were made during the year ended December 31, 2023. Contributions are subject to certain limitations.

**Investments:** Participants direct the investment of their contributions and the Company contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, a common collective trust, a money market fund and brokerage accounts as investment options for participants. Participants have purchased shares of common stock, cash, money markets and mutual funds through the brokerage accounts. Participants may change their investment options any time throughout the year via internet access.

**Participant accounts:** Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution, and allocations of (1) Company nonelective employer contributions and (2) Plan earnings, and charged for loan fees and an allocation of administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Note 1. Plan Description (Continued)

**Vesting:** Participants are vested immediately in their contributions, discretionary matching contributions and earnings thereon.

Participants hired before January 1, 2020, are vested immediately in their nonelective employer contributions and earnings thereon.

Participants hired after January 1, 2020, vest in their nonelective employer contributions and earnings thereon as follows: 0% in Year 1, 0% in Year 2, and 100% after Year 3.

**Forfeited accounts:** At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$29,392 and \$0, respectively. These accounts may be used to reduce employer contributions and pay Plan expense. During the year ended December 31, 2023 forfeitures were used to reduce employer contributions are \$43,189.

**Notes receivable from participants:** Participants may borrow from their fund accounts the lesser of \$50,000 or 50% of their vested account balance. Participants are limited to a maximum of five outstanding loans at one time. These transactions are treated as transfers between the investment fund and the participant notes receivable fund. The notes receivable are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Notes receivable are repayable through payroll deductions. Notes receivable must be paid back within five years, except if the note receivable is used to purchase a primary residence, in which case the note receivable must be repaid within 10 years. The interest rates ranged from 4.25% to 9.5% for all outstanding loans at December 31, 2023. A fee of \$75 is charged to the participant for new loan setup.

**Payment of benefits:** On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or receive benefit payments in the form of an annuity. If a participant's vested account balance is less than \$1,000, a lump-sum payment of the vested balance will be distributed automatically. Vested account balances greater than \$1,000 but not more than \$5,000 will be rolled over to an individual retirement plan account.

**In-service withdrawals:** Participants may withdraw all or a portion of their vested account balance once they attain age 59½ or, in the case of financial hardship, a distribution may be made from the employee contributions account and any earnings thereon. Financial hardship is defined as an immediate heavy financial need resulting from medical expenses, payment of tuition for postsecondary education, the purchase of the participant's principal residence, or to prevent eviction from or foreclosure on the mortgage of the participant's principal residence.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Contributions:** Contributions from Plan participants, the employer discretionary matching contributions, and the employer nonelective contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determines the Plan's valuation policies utilizing information provided by Fidelity Management Trust Company, the trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the 2023 statement of net assets available for benefit.

**Allowance for credit losses:** The Plan adopted Accounting Standards Codification (ASC) 326, Financial Instruments—Credit Losses, as of January 1, 2023, with the cumulative-effect transition method with the required prospective approach. The measurement of expected credit losses under the current expected credit loss (CECL) methodology is applicable to financial assets measured at amortized cost, which include employer and participant contributions receivable. An allowance for credit losses under the CECL methodology is determined using the loss-rate approach and measured on a collective (pool) basis when similar characteristics exist. Where financial instruments do not share risk characteristics, they are evaluated on an individual basis. The CECL allowance is based on relevant available information, from internal and external sources, related to past events, current conditions and reasonable supportable forecasts. Management recorded no allowance for credit losses as of December 31, 2023, as all amounts were determined to be fully collectible.

Prior to the adoption of ASC 326, the Plan maintained an allowance for doubtful accounts to reserve for potentially uncollectable receivables. Management recorded no allowance for doubtful accounts as of December 31, 2022, as all amounts were determined to be fully collectible.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced, and a benefit payment is recorded based on the terms of the Plan.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

**Payments of benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include fees related to the administrator of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation in the fair value of investments.

#### Note 3. Information Certified by the Fidelity Management Trust Company (Trustee)

The following is a summary of the Plan's asset information as of December 31, 2023 and 2022, and for the year ended December 31, 2023, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan and a qualified institution.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

#### Note 4. Fair Value Measurements (Continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Brokerage accounts:** Valued at the value of the underlying investments at the end of the plan year.

**Money market fund:** Valued based at the NAV of the underlying assets at the end of the plan year.

**Common collective trust:** Valued based on the NAV of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### Note 5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

#### Note 6. Tax Status

The Plan adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service stating that the firm of the pre-approved plan's document was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since adopting the pre-approved plan document. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken any uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7. Related-Party and Party-in-Interest Transactions

Certain Plan investments are mutual funds, a money market fund, brokerage accounts and a common collective trust managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Fidelity Management Trust Company for administrative expenses totaled \$67,109 for the year ended December 31, 2023. Other fees for investment management services have been netted against gains and losses on investments.

#### Note 9. Prohibited Transactions

During the year ended December 31, 2022, the Company inadvertently failed to deposit \$138,535 of participant contributions and loan payments within the required time frame as stated by the United States Department of Labor (DOL) regulations. The Plan Sponsor deposited lost earnings to correct this failure in 2024. The Plan Sponsor will file Form 5300 and will pay the applicable excise tax in 2025. The correction and excise tax payments will be made from the Plan Sponsor's assets and not the assets of the Plan.

#### Note 10. Subsequent Events

Effective January 1, 2025, the Plan was amended to approve the merger of OKRP Retirement Savings Plan into the Plan. Total net assets from the OKRP Retirement Savings Plan will be transferred in 2025. The merger does not impact participant benefits as the benefit provisions will be incorporated in the Plan.

Management has evaluated events through February 25, 2025, which is the date the financial statements were available to be issued.
