## INDEPENDENT AUDITOR'S REPORT

To the Procter & Gamble U.S. Business Services Company:

### Opinion

We have audited the financial statements of The Gillette Company Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.



## NOTES TO FINANCIAL STATEMENTS AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of The Gillette Company Employee Stock Ownership Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General** — The Plan is a defined contribution plan sponsored by The Gillette Company, a subsidiary of The Procter & Gamble Company (collectively, the “Company”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was adopted on January 17, 1990, in conjunction with modifications to the Company’s U.S. retiree medical benefit program. The Plan is specifically intended to qualify as a stock bonus plan under Section 401(a) of the Internal Revenue Code (the “IRC”) and as an employee stock ownership plan under Section 4975(e)(7) of the IRC. The Company is the sponsor of the Plan. Northern Trust serves as the trustee of the Plan. The Procter & Gamble U.S. Business Services Company (Plan Administrator) controls and manages the operation and administration of the Plan.

The Plan covers eligible employees who were hired (or who have an adjusted service date, if applicable) before July 1, 1990, and retire from the Gillette Company after January 1, 1992.

**Contributions** — The Company previously contributed to the Plan. The Company has discontinued contributions to the Plan and since January 1, 2002, there have been no Company contributions to the Plan. There are no employee contributions to the Plan.

**Participant Accounts** — Individual accounts are maintained for each Plan participant. Each participant’s account is credited with allocations of Plan earnings and charged with administrative fees, withdrawals and an allocation of Plan losses. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants over age 55 who have completed 10 years of participation under the Plan may elect to diversify a portion of their investment in Company common stock into other investment fund choices made available. Once a participant qualifies, the participant may elect, within 90 days after the close of each of the first five plan years, to diversify, on a cumulative basis, up to 25% of the shares of Company common stock held in his or her account into the mutual fund offerings. In the sixth year and thereafter, the participant may elect to diversify, on a cumulative basis, up to 50% of the shares of Company common stock held in his or her account.

Participants are entitled to exercise voting rights for the shares of Company common stock and J.M. Smucker (“Smucker’s”) common stock allocated to their accounts.

**Vesting** — Participants are fully vested in their Plan accounts.

**Investments** — As of December 31, 2024 and 2023, the Plan offers three mutual funds as investment options for participants who are eligible to diversify.

**Administrative Expenses** — Investment management fees are netted against investment income. In addition, recordkeeping fees of the Plan are paid by participants through a reduction of their account balances.

**Payment of Benefits** — For eligible Plan participants who retire after January 1, 1992, and elect to participate in the Company’s retiree medical benefit program, retiree medical premiums will be paid in part from their Plan account balances. Included in benefit payments in the accompanying financial statements is \$ 3,657,084 and \$ 4,037,355 of payments for retiree medical premiums for the years ended December 31, 2024 and 2023, respectively.

If a participant is eligible for distribution, he or she may elect to defer payment to a date no later than the year following the year the participant reaches age 70 1/2. If a participant terminates employment but is not eligible for the retiree medical benefit program under the Plan, the participant’s account will automatically be transferred into an account for the participant under The Procter & Gamble Savings Plan (the “Savings Plan”) for participants located in the United States and The Procter & Gamble Commercial Company Employees’ Savings Plan (“Commercial Company Savings”) for participants located in Puerto Rico, in accordance with procedures established by the Plan Administrator.

Upon distribution, the participant may elect to receive the fair value of the shares allocated to his or her account in cash or Company common stock, payable in a lump sum. Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but had not yet been paid at December 31, 2024 and 2023.

**Transfers** — Transfers out of the Plan to the Savings Plan in 2024 and 2023 resulted from termination of participants not eligible for retiree medical benefits and who did not elect payout of their Plan balances. Transfers to the Plan from the Savings Plan in 2024 and 2023 resulted from participants who became eligible for retiree medical benefits and had Plan balances that were transferred to the Savings Plan due to prior ineligibility for retiree medical benefits. Transfers to the Savings Plan in 2024 and 2023 were \$0. Transfers to the Plan from the Savings Plan in 2024 and 2023 were \$ 872,731 and \$ 348,286, respectively. There were no transfers to/from the Commercial Company Savings in 2024 and 2023. Transfers out of the Plan to the Savings Plan or Commercial Company Savings or to the Plan from the Savings Plan or Commercial Company Savings may occur in the future.

**Plan Amendments** — The Company has the right to amend the Plan at any time. However, no amendment can reduce the amount of any participant’s account.

**Subsequent Events** — For the year ended December 31, 2024, the Company has evaluated subsequent events for potential recognition and disclosure through May 30, 2025, the date the financial statements were available for issuance.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** — The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** — The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties** — The Plan utilizes various investment instruments, including common stock, a common collective trust fund, and mutual funds. Investment securities are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that such changes in the values of investment securities could occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Concentrations of Investments** - Included in investments at December 31, 2024 and 2023, are shares of the sponsor's common stock of \$ 363,563,946 and \$ 344,824,739, respectively. This investment represents 98.9% percent and 98.8% percent of total investments at December 31, 2024 and 2023, respectively. A significant decline in the market value of the sponsor's stock would significantly affect the net assets available for benefits.

**Investment Valuation and Income Recognition** — The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held throughout the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

### 3. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Asset Valuation Techniques** — Valuation methodologies maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common Stocks* — Valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual Funds* — Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission.

These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are actively traded.

**Transfers Between Levels** — The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. The Plan’s policy is to recognize transfers between levels at the actual date of the event or change in circumstances that caused the transfer.

We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended, December 31, 2024 and 2023, there were no transfers between levels.

**Common Collective Trust Fund** - As permitted by GAAP, the Plan uses NAV as a practical expedient to determine the fair value of the common collective trust fund. NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Redemption for the common collective trust is permitted daily with no other restrictions or notice periods and there are no unfunded commitments. In accordance with GAAP, the common collective trust fund measured at NAV has not been classified in the fair value hierarchy. The fair value amounts presented in the table below are intended to permit reconciliation to the amounts presented in the Statements of Net Assets Available for Benefits.

#### 4. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of P&G common stock and funds managed by Northern Trust. Transactions with the recordkeeper, trustee, and custodian qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

At December 31, 2024 and 2023, the Plan held 2,168,589 and 2,353,110 shares, respectively, of common stock of the Company, the sponsoring employer, with a cost basis of \$ 104,731,806 and \$ 106,411,490, respectively. During the years ended December 31, 2024 and 2023, the Plan recorded dividend income on Company common stock of \$ 8,956,681 and \$ 9,168,663, respectively.

During the years ended December 31, 2024 and 2023, the Plan’s investment in Company common stock, including gains and losses on investments bought and sold as well as held during the year, appreciated / depreciated in value by \$48,921,397 and by (\$ 12,486,769) respectively.

## 5. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA.

## 6. FEDERAL INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated October 19, 2017, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. The Plan is also exempt from Puerto Rico income taxes under the provisions of the Puerto Rico Internal Revenue Code (PRIRC).

The Plan is subject to routine audits by taxing jurisdictions at any time. The Plan has been amended since receiving the determination letter. However, the Company and the Plan administrator believe that the Plan is designed and operated in compliance with the applicable requirements of the IRC and the PRIRC and the Plan and related trust continued to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## 7. NON-PARTICIPANT DIRECTED INVESTMENT

Company common stock is considered to be non-participant directed under the guidance of ASC 962-325, *Plan Accounting - Defined Contribution Pension Plans – Investments - Other*. Participants are to maintain all investment holdings in the Company common stock. Participants who are over age 55 and have completed 10 years of participation under the Plan may elect to diversify a portion of their investment in Company common stock.
