As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of October 10, 2024 and for the period beginning January 1, 2024 and ended October 10, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Basis For Opinion On The Financial Statements***

### ***Emphasis Of Matter - Plan Termination And Liquidation Basis Of Accounting***

As discussed in Note 1 to the financial statements, the Board of Directors of Surdex Corporation approved a plan of liquidation, and management determined liquidation to be imminent. As a result, the Plan has changed its basis of accounting from the ongoing plan basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities Of Management For The Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Except as described in the Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit For The Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with auditing standards generally accepted in the United States of America, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Management of the Plan is responsible for the accompanying statement of net assets available for benefits as of December 31, 2023. We have performed a compilation engagement in accordance with Statements on Standards for Accounting and Review Services promulgated by the Accounting and Review Services Committee of the American Institute of Certified Public Accountants. We did not audit or review the statement of net assets available for benefits as of December 31, 2023, nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by management of the Plan. Accordingly, we do not express an opinion, a conclusion, nor provide any form of assurance on the statement of net assets available for benefits of the Plan as of December 31, 2023.

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of The Plan

The following brief description of the Surdex Corporation 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### General

The Plan, a defined contribution plan, was established June 1, 1973, and is sponsored by Surdex Corporation (the Company). The Plan was restated effective January 1, 2022. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Plan Termination

The Company approved a resolution to terminate the Plan effective April 2, 2024. As a result, all participant accounts were fully distributed as of October 10, 2024. All participants became immediately vested in their accounts upon termination of the Plan.

#### Eligibility

The Plan covered substantially all employees of the Company, excluding employees under the age of 20 1/2. Once eligible, employees could enter the Plan immediately upon employment commencement.

#### Plan Administration

Alerus Retirement and Benefits was the Plan's recordkeeper and Alerus Financial N.A. was the asset Custodian.

#### Contributions

Participants could contribute up to 100% of their annual compensation up to the maximum amount allowed by the law, as defined in the Plan Document, as pre-tax contributions, Roth contributions, or a combination thereof. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Contributions were subject to certain Internal Revenue Service (IRS) limitations.

The Plan provided for an automatic enrollment feature, where once eligible, participants were automatically enrolled in the Plan at a default deferral percentage of 3%. Participants could opt out or change their deferral percentage at anytime.

### Notes To Financial Statements *(Continued)*

The Company provided a discretionary Company matching contribution equal to 50% of participant deferral contributions, not to exceed 6% of eligible compensation.

The Company also provided discretionary nonelective contributions. There were no discretionary nonelective contributions made during 2024.

### **Vesting**

Participants vested in their contributions under a modified two-year schedule with participants being 0% vested with less than one year of service, 50% vested after one year of service, and 100% vested with two or more years of service.

### **Participant Accounts**

Each participant's account was credited with the participant's contributions, rollover contributions, discretionary matching contributions and an allocation of Plan earnings and expenses. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined by the Plan Document. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

### **Notes Receivable From Participants**

Active participants could borrow from their account a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Participants could have up to three loans outstanding at any given time. Note terms ranged from one to five years or up to 15 years for the purchase of a primary residence. The notes were secured by the balance in the participant's account and bore interest at the Wall Street Journal prime rate plus 1%. Principal and interest were paid ratably through payroll deductions.

### **Payment Of Benefits**

Participants were entitled to receive the balance of their accounts upon death, total disability, retirement, or termination of employment in the form of a lump-sum or installments.

### **In-Service Withdrawals**

Participants who attained the age of 59-1/2 could withdraw any portion of their vested account balance. In certain circumstances, a participant could elect a hardship distribution, as defined in the Plan Document. Hardship distributions were permitted from participant pre-tax deferrals, Roth contributions, discretionary Company matching contributions and rollover funds.

### Notes To Financial Statements (*Continued*)

#### **Administrative Expenses**

A significant portion of the administrative expenses of the Plan were paid by the Company. The Plan paid expenses related to transactions, asset management fees and recordkeeping fees. Investment-related expenses are included in the net change in fair value of investments.

#### **Investment Options**

Upon enrollment in the Plan, a participant could direct contributions in any of a variety of investment options available.

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

Due to the Plan termination, management determined that liquidation of the Plan is imminent and the financial statements for 2024 have been prepared using the liquidation basis of accounting. Under the liquidation basis of accounting, assets are measured at the expected cash proceeds from liquidation and liabilities are measured in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) that otherwise apply to those liabilities. The 2023 financial statements were prepared on the accrual basis of accounting.

#### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation And Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan concluded that no allowance for current expected credit losses was necessary at December 31, 2023.

#### **Payment Of Benefits**

Benefit payments are recorded when paid.

#### **Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

### **3. Certified Investment Information**

The following is a summary of the Plan's asset information as of October 10, 2024 and for the period beginning January 1, 2024 and ended October 10, 2024, included throughout the Plan's financial statements that was prepared by or derived from information certified by the Custodian, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the Custodian that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements. There were no investment assets remaining as of October 10, 2024.

The Custodian also certified to the completeness and accuracy related the following investment income and interest income on notes receivable from participants for period beginning January 1, 2024 and ended October 10, 2024:

#### **4. Fair Value Measurements**

The Plan follows current accounting standards, which establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

#### **Registered Investment Companies**

Registered investment companies are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

These transactions qualified as party in interest transactions allowable under ERISA.

#### **6. Income Tax Status**

The Plan adopted a pre-approved defined contribution plan sponsored by Alerus Financial, for which a favorable IRS opinion letter was received dated March 31, 2017. The Plan has been amended since the date of the opinion letter. The Plan Administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the Internal Revenue Code (IRC). Therefore, no provision for income tax has been included in the Plan's financial statements.
