**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Critigen LLC 401 (K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of November 5, 2024 (date of Plan dissolution) and December 31, 2023 (in liquidation) and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to November 5, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 2024 and 2023 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 5, 2024 and December 31, 2023, and for the period from January 1, 2024 through November 5, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Critigen LLC 401 (K) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Plan Dissolution and Basis of Accounting**

As discussed in Note 1 to the financial statements, the governing body of Critigen LLC 401(k) Plan approved a plan of liquidation on December 7, 2023, and the Plan was dissolved on November 5, 2024. As a result, the accompanying financial statements are presented on the liquidation basis of accounting. Our opinion is not modified with respect to these matters.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS**

**NOTE 1 - DESCRIPTION OF THE PLAN:**

The following description of the Critigen LLC 401(k) Plan (the “Plan”) provides only general information. Participants and others should refer to the Plan document for a more complete description of the Plan’s provisions.

Effective December 7, 2023 (the “Effective Date”), the Plan was amended to freeze and terminate. The financial statements are therefore presented on the liquidation basis of accounting. As of the Effective Date, no further contributions were made to the Plan. The assets of the Plan were distributed to all participants, with the final distribution and Plan dissolution on November 5, 2024. All accounts became fully vested upon execution of the amendment to terminate the Plan.

The Critigen LLC 401(k) Plan is a contributory, defined contribution plan for the benefit of the employees of Locana LLC, formerly known as Critigen LLC (“the Company”). The Plan was established September 11, 2009, and has since been amended. The following description reflects the provisions of the most recent plan document dated January 1, 2021, prior to Plan termination. The Plan is administered by the Company and the Plan assets are held in a trust by Empower Trust Company, LLC (“Empower”). The funds must be used for the exclusive benefit of Plan participants and their beneficiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Prior to the Effective Date, the Plan included a 401(k) feature whereby employees may contribute up to 90% of their pre-or post-tax compensation, as defined in the Plan and subject to statutory limitations. There were no age or service requirements for participation. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans, and if the participant is at least age 50, catch-up contributions may be made. New employees were automatically enrolled at a deferral rate of 4% of pre-tax compensation. Effective January 1, 2021, this rate was increased 1% each Plan year after the participant has two full years in the Plan, until a rate of 6% was attained. Employees could opt for a different deferral rate than the auto enroll rate, including opting out.

Employer matching contributions were discretionary. In 2023, through the Effective Date, a safe harbor employer contribution of 3% of eligible compensation was declared. Employees eligible to participate in the 401(k) portion of the Plan were eligible for the safe harbor contribution, even if the employee did not defer compensation under the 401(k) provisions.

Contributions to the Plan of employee deferrals and the match were made with each payroll.

**NOTE 1 - continued:**

Employee contributions, employer contributions, and earnings thereon were invested as directed by the participants. The investment options include a variety of mutual funds, including blended investment risk funds. The blended investment risk funds are managed portfolios, composition of which is based on the participant's desired risk level.

Each participant's account was credited with the participant's contribution, and allocations of the related matching contribution and net plan earnings. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participants are immediately and fully vested in their deferrals. Prior to the Effective Date, employer contributions and allocated earnings thereon vested with individual participants based upon years of service with the Company, with 100% vesting after 2 years of service, upon attaining normal retirement age (age 65), upon disability, or upon termination of the Plan. As disclosed above, effective December 7, 2023, all accounts in the Plan became fully vested.

All Plan participants were required to take a distribution of their account subsequent to the Effective Date.

Prior to the Effective Date, unvested benefits of terminated participants were forfeited and used to reduce employer contributions or to pay administrative expenses. Unallocated forfeitures at December 31, 2023 were \$3,127. These forfeited amounts were used to pay Plan expenses during the liquidation period.

Prior to the Effective Date, participants could borrow from their accounts the lesser of \$50,000 or 50% of their vested account balance, with a minimum loan of \$1,000. The loans bear interest at a reasonable rate, are secured by the participants' vested account balances and were repaid ratably through monthly payroll deductions. The loans were repaid in full through the Plan liquidation process.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES:****Use of estimates-**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of assets and net assets available for benefits at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

**NOTE 2 - continued:****Valuation of investments-**

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value and contract value as described above approximate the liquidation basis for the Plan's investments.

**Recognition of income and expenses-**

The Plan records income and expenses on the accrual basis of accounting. In accordance with generally accepted accounting principles, benefits are recorded in the period paid. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments represents the net increase in the fair value of investments sold during the year or held at year-end over (1) the fair value of investments held at the prior year-end, or (2) the cost of investments acquired during the current year.

Certain administrative costs of the Plan are borne by the Company. In addition, the Company may provide services to the Plan for which the Company receives no compensation. The costs borne by the Plan include recordkeeping and mutual fund expenses. The Plan also funds investment advisory fees.

**Notes receivable from participants -**

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Principal and interest are paid with each pay period. Due to adequate collateral, no allowance for credit losses is needed.

**NOTE 3 - FAIR VALUE MEASUREMENTS:**

Fair value is a market-based measurement determined based on assumptions that market participants would use in pricing an asset or liability. There are three levels, which prioritize the inputs used in measuring fair value as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities;
- Level 2: Observable market inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

**NOTE 3 - continued:**

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and classified within level 1 of the valuation hierarchy. The fair value of mutual funds equals the liquidation basis value of such funds.

**NOTE 4 - GROUP ANNUITY CONTRACT:**

The Plan has a group annuity contract with an insurance company that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly, and cannot be less than 0%. For the partial year 2024 and for 2023, the average yield earned by the fund was approximately 1%. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The contract meets the fully-benefit responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully-benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contract by the Plan; (2) complete or partial Plan termination or merger with another plan; (3) bankruptcy of the Plan sponsor; or, (4) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The execution of the Plan termination amendment did not limit the Plan's ability to transact at contract value due to the Plan providing adequate notice to the insurance company.

#### **NOTE 5 - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN:**

The Plan's management elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Under this provision of ERISA, certain information certified by a qualified trustee or custodian need not be subject to independent audit.

The Plan's custodian is Empower Trust Company, LLC. Plan's management has obtained certifications from the custodian that the following information included in the Plan's financial statements is complete and accurate:

1. Fair value and contract value of investments as of November 5, 2024 and December 31, 2023,
2. The balance of notes receivable from participants as of December 31, 2023,
3. Investment and interest income earned for the period from January 1 through November 5, 2024,
4. Investment transactions for the period from January 1 through November 5, 2024.

#### **NOTE 6 - FEDERAL INCOME TAXES:**

Effective January 1, 2021, the Plan adopted a volume submitter plan. The Internal Revenue Service has determined and informed the sponsor of the volume submitter plan by a letter dated June 30, 2020, that the form of the volume submitter plan is acceptable under Section 401 of the Internal Revenue Code (IRC). The Plan's administrator believes that the Plan is designed and being operated in compliance with the applicable IRC requirements. Therefore, the administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has concluded that as of November 5, 2024, the Plan has not taken any uncertain positions that would require recognition or disclosure. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress and years prior to 2021 are no longer subject to audit.

#### **NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS:**

Empower acts as custodian for investments of the Plan. Therefore, transactions with Empower and its affiliates qualify as party-in-interest transactions.

**NOTE 8 - SUBSEQUENT EVENTS:**

Management has evaluated subsequent events through May 30, 2025, the date the financial statements were available to be issued.
