## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Holton Brothers, Inc. Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Holton Brothers, Inc. Retirement Savings Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from Empower Trust Company, LLC and Empower Annuity Insurance Company of America as of and for the year ended December 31, 2024 and as of December 31, 2023 and for the period from November 6, 2023 to December 31, 2023, and Associated Trust Company, N.A. for the period from January 1, 2023 to November 5, 2023 stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

### **ERISA-Required Supplementary Information**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - Holton Brothers, Inc. Retirement Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

**Accounting estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through May 19, 2025, which is the date the financial statements were available to be issued.

**Risks and uncertainties** - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Key parties of the plan** - Holton Brothers, Inc. is the plan sponsor, employer and plan administrator. Prior to November 1, 2023, Associated Trust Company, N.A. ("Associated") was the trustee that held custody of plan investment assets, recordkeeper that maintained participant accounts and related information, third party administrator that maintained plan documents, and tax counsel that performed various compliance tests. Effective November 2023, Empower Retirement, LLC assumed the recordkeeping, third party administrator and tax counsel responsibilities. Empower Trust Company, LLC became the trustee that holds custody of the plan's mutual funds and common/collective trust investments. Empower Annuity Insurance Company of America holds custody of the plan's guaranteed investment contract. The Empower entities discussed above are collectively referred to as "Empower". Effective November 2023, the plan name was changed from Holton Brothers, Inc. Profit Sharing Plan to Holton Brothers, Inc. Retirement Savings Plan. Morgan Stanley is the plan's investment advisor.

**Investments** - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Earnings on investments bought, sold and held during the years are reflected in the statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

**Fair value measurements** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Notes to Financial Statements

Following is a description of the valuation methodologies used for investments measured at fair value.

*Mutual funds* - The mutual funds held by the plan are valued at the daily quoted market prices as reported by the fund. The mutual funds are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

*Common/collective trusts* - The common/collective trusts held by the plan are direct filing entities valued at their NAV. The NAV is used as a practical expedient to estimate fair value and is generally based on the fair value of the underlying investments held by the common/collective trust less its liabilities. This practical expedient would not be used if it is determined to be probable that the trust would sell the investment for an amount different from the reported NAV.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

**Investment at contract value** - The plan invests in the EI Fixed Account - Series I, a general account product of Empower. The investment is a fully benefit-responsive guaranteed portfolio investment through a group fixed annuity contract issued by Empower. As a general account product, participants' principal and interest amounts are fully guaranteed by the general assets of Empower. The methodology for calculating the interest crediting rate is based on prevailing market conditions and earnings of medium-long investments compared to a minimum interest crediting rate, as more fully described in the plan's contract with Empower. The interest crediting rate is reset quarterly. The average yield earned by the fund was 1.41% and 1.23% during 2024 and 2023.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal of all or a portion of the investment at contract value.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. The plan sponsor may request a full distribution at any time. In the event the plan requests an immediate lump sum distribution, a market value adjustment is calculated or the plan may request the distribution in installments over a period of 12 months at contract value.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with the issuer. As of the date these financial statements were available to be issued, the plan administrator is not aware of any events that might limit the ability of the plan to transact at contract value with the contract issuer or limit the ability of the plan to transact at contract value with the participants.

## 2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

**General** - The plan was adopted effective February 1, 1981 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - Employees are eligible once they have completed one year of service and have reached age twenty-one. Employees can enter the plan on the earlier of the first day of the plan year or the first day of the seventh month of the plan year coinciding with or next following the date on which the plan's eligibility requirements are met. Effective November 1, 2023, employees can enter the plan on the first day of the month following completion of the eligibility requirements.

**Contributions** - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. Effective January 1, 2024, after meeting the eligibility requirements, new employees are automatically enrolled in the plan and have 5% of compensation withheld as elective deferral contributions. Effective January 1, 2025, the automatic enrollment percentage increased to 6%. Such employees have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans. There were no rollover contributions in 2024 or 2023.
- c. Safe harbor employer contributions are made in conjunction with each pay period equal to 3% of each eligible employee's compensation.
- d. Additional discretionary employer contributions may be made on an annual basis. No such contributions were made for 2024 or 2023.

**Participant accounts** - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of employer contributions. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each pay period.

**Vesting** - Participants are always 100% vested in their elective deferral contributions, rollover contributions, safe harbor contributions and related earnings. Participants become 20% vested in any discretionary employer contributions and related earnings upon two years of service. The participant then vests at the rate of 20% for each year thereafter. Upon death or attainment of normal retirement age while still employed, participants become 100% vested.

**Payment of benefits** - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or retirement. Distributions can be made in the form of single lump sum payments, installments or partial withdrawals. In-service withdrawals can commence upon attaining the age of 59½. Hardship withdrawals are not permitted under the plan.

**Administrative expenses** - Certain administrative fees of the plan are paid by the employer and not included in these financial statements. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in these financial statements. Such expenses include participant directed charges for distribution fees and nonparticipant directed charges for services and administrative fees. Nonparticipant directed fees are allocated on an account value basis.

**Forfeitures** - Forfeited nonvested accounts would be used to reduce employer contributions or pay plan expenses. Forfeiture activity is insignificant.

**Notes receivable from participants** - Participant loans are not permitted under the plan.

### 3. PARTY-IN-INTEREST TRANSACTIONS

Associated was the trustee that held custody of the plan's investment assets and also managed certain of the plan's investment options. As such, transactions between Associated and the plan qualified as party-in-interest transactions. Associated also provided certain administrative services to the plan pursuant to a service agreement between the plan sponsor and Associated. Associated received revenue from certain mutual fund service providers for services Associated provided to the funds. This revenue was considered indirect compensation and was used to offset certain amounts that would otherwise be owed by the plan to Associated for its administrative services to the plan. Direct fees paid by the plan to Associated were \$40,000 in 2023.

Empower holds custody of the plan's investment assets and also manages the guaranteed contract investment. As such transactions between Empower and the plan qualify as party-in-interest transactions. Empower receives indirect compensation from the plan's mutual fund investment providers for services Empower provides to the funds. Certain revenues received by Empower from such service providers are remitted to the plan in the form of service credits (as part of an administrative services agreement between the plan sponsor and Empower). Such service credits received by the plan are used by the plan to pay advisory services and other plan fees. There are also certain other plan expenses that Empower charges that are paid by the plan directly. Direct fees paid by the plan to Empower were \$9,000 in 2024. Direct fees paid by the plan to Empower in 2023 were insignificant.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### **4. TERMINATION OF PLAN**

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any discretionary employer contributions and related earnings.

#### **5. INCOME TAX STATUS**

The plan was operating under an Associated Trust Company, N.A. pre-approved profit sharing plan through October 31, 2023. The pre-approved profit sharing plan obtained a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Effective November 1, 2023, the plan adopted an Empower Retirement LLC pre-approved profit sharing plan that received a favorable opinion letter on November 14, 2022, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan; however, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

#### **6. INFORMATION CERTIFIED BY ASSOCIATED AND EMPOWER**

Management has obtained certifications from Associated and Empower, which are qualified institutions under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the fair values and contract values of such as of December 31, 2024 and 2023;
- b. Dividends and interest income from investments and net appreciation (depreciation) in fair values of investments during 2024 and 2023;
- c. Purchases and sales of investments during 2024 and 2023; and
- d. Contributions to, withdrawals from, purchases, sales and inter-fund transfers between accounts during 2024 and 2023.
