We have performed an audit of the accompanying financial statements of Bethshan Association 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of August 31, 2024, the related statement of changes in net assets available for benefits for the year the ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have an audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the year ended August 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

1. DESCRIPTION OF THE PLAN:

The following brief description of the Bethshan Association 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution retirement plan covering all employees of Bethshan Association (the Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The organization's management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the organization's board of directors.

On September 1, 2023, the Bethshan Association Tax-Deferred Annuity Plan merged into the Plan and transferred assets of \$4,135,135.

CONTRIBUTIONS

All employees are eligible upon hire to make elective deferral contributions up to the limits defined by the Internal Revenue Code. Participants who have attained age 50 are eligible to make catch-up contributions. Rollover contributions are also allowed by the Plan. Employees who are at least 18 years old and have worked a minimum of 83 1/3 hours per month, except the Executive Director, are eligible to receive matching contributions after they have completed twelve consecutive months of service. The employer matching contribution is equal to 100% of the employee's elective deferral up to 5% of compensation.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contributions and allocations of (a) employer contributions and (b) Plan earnings and charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant-directed.

VESTING

Participants are vested immediately in all contributions plus actual earnings thereon.

1. DESCRIPTION OF THE PLAN, continued:

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may apply for a loan from their participant account. The total of the loans that a participant has outstanding is limited to the lesser of \$50,000 or 50 percent of the participant's account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above prime rate, as defined, at inception of the participant loan. Each loan shall be amortized in level payments, not less frequently than quarterly, over a maximum of 5 years (with certain exceptions for loans used to acquire a principal residence). Participant loans are reported as notes receivable from participants on the statement of net assets available for benefits.

PLAN LOANS

Previously, the Plan allowed participants to borrow from Teachers Insurance and Annuity Association (TIAA) and College Retirement Equity Fund (CREF) using a portion of their Plan account as security for the loan. The Plan administrator has concluded that these loans are not Plan assets and that such arrangements are exempt transactions. The loan balances at August 31, 2024 and 2023, were \$29,967 and \$40,999, respectively and are secured by the balance in the participant's account and bear interest between 4.00%-5.72% and 4%-5.73%, respectively.

PAYMENT OF BENEFITS

Upon attainment of age 59 1/2 or disability, participants may elect to receive in-service benefit payments from employee deferrals, matching contributions and custodial account. Upon termination of service or death, a participant with an account balance of \$5,000 or more may elect to receive an amount equal to the value of the participant's vested interest in his or her account in the form of a lump sum, partial payments, installment payments, or annuity contracts. If the vested balance of the account is less than \$1,000, the participant will receive a lump sum amount.

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

2. SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

USE OF ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion on fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Loan transactions are treated as transfers between the investment fund and notes receivable from participants. These loans are carried at the loan's unpaid principal balance plus accrued interest and are recorded as notes receivable from participants in the statement of net assets available for benefits. Participant loans from TIAA and CREF accounts as of August 31, 2024 and 2023, totaled \$90,516 and \$23,809, respectively. If a loan is defaulted, the participant has the opportunity to repay the loan, resume current status of the loan by paying missed payments plus interest, or if distribution is available under the Plan and investment arrangements, request distribution of the note. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of August 31, 2024 and 2023.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

Investment management and administrative fees paid to TIAA are included with net appreciation in fair value of investments on the statement of changes in net assets available for benefits. All other administrative expenses, such as consulting and accounting fees, were paid by the Organization.

3. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. TIAA and CREF, qualified institution, has certified the completeness and accuracy of all assets reflected on the accompanying statement of net assets available for benefits as of August 31, 2024 and 2023, and the related interest income on notes receivable from participants and investment activity reflected in the statement of changes in net assets available for benefits for the year ended August 31, 2024, and the supplemental Schedule H, Line 4i—schedule of assets (held at end of year) as of August 31, 2024. TIAA, Trust N.A. is the custodian of the portion of Plan assets invested in mutual fund shares and has authorized TIAA to certify investments held by TIAA, Trust, N.A. TIAA and CREF is the issuer of the remaining assets in the Plan.

4. FAIR VALUE MEASUREMENTS:

The Plan uses appropriate valuation techniques to determine fair value based on inputs available. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 1 inputs consist of unadjusted quoted market prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Variable annuity contracts are valued at the net asset value (NAV) of units held by the Plan at year end based on the fair value of the underlying investments. NAV is a readily determinable fair value which is published daily and is the basis for current transactions. Non benefit-responsive fixed annuity contracts are not actively traded, and significant other observable inputs are not available. Therefore, the fair value of the fixed annuity contracts is determined using an income approach by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. These contracts have liquidity restrictions and are non-benefit responsive. The fair value of the pooled separate account units is valued using independent pricing sources.

Changes in valuation techniques: None.

Level 3 investments totaled \$498,675 and \$555,542 as of August 31, 2024 and 2023, respectively. Total purchases of Level 3 investments were \$112,992 and total sales were \$205,729 during the year ended August 31, 2024.

5. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANY:

The Plan has benefit-responsive guaranteed investment contracts with TIAA. TIAA maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of benefit responsive guaranteed investment contracts at August 31, 2024 and 2023, was \$1,159,093 and \$16,371, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than three percent. Such interest rates are reviewed on a quarterly basis for resetting.

5. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANY, continued:

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreements prior to the scheduled maturity date. The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. TAX STATUS:

The Plan has adopted a prototype plan document sponsored by TIAA. The prototype plan document has obtained an opinion letter from the Internal Revenue Service (IRS) dated August 7, 2017, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code. The Plan has not received a determination letter from the IRS; however, the Plan administrator and the Plan's counsel believe that the Plan is designed in compliance with the applicable requirements of the Internal Revenue Code.

8. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. PARTY-IN-INTEREST TRANSACTIONS:

TIAA and CREF, issuers of variance annuity contracts in the Plan, manage Plan investments. Therefore, these transactions qualify as party-in-interest transactions and are denoted as such on the supplemental schedule of assets (held at end of year). For the year ended August 31, 2024, \$1,300 of direct fees and \$40,968 of indirect fees were paid by the Plan to these parties-in-interest for the investment management services and were included as a reduction of the return earned on each fund.

10. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through June 4, 2025, which represents the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.


