We have performed an audit of the accompanying financial statements of FORCE America, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

1. Description of Plan

The following brief description of the FORCE America, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document or Summary Plan Description for more information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

General

The Plan is a defined contribution plan sponsored by FORCE America, Inc. (the "Company" and "Plan Sponsor") for the benefit of its employees. To be eligible to participate in the Plan, the employee must be hired as full time, which is defined as having more than 1,000 hours of service during the eligibility computation period, and must be eighteen years of age or older. To be eligible for the employer matching contributions, the employee must also be hired as full time, be eighteen years of age or older, and must complete 30 days of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended ("ERISA") and the Internal Revenue Code ("IRC"). The Plan is administered by the Company's Administrative Committee (the "Committee"). The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On April 1, 2023, the Plan was restated to adopt the Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company preapproved non-standardized adoption agreement.

Contributions

Participants may make elective deferral contributions of pre-tax or Roth up to the maximum allowed by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older who are making contributions to the Plan are allowed to make catch-up contributions as defined in the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation, unless the eligible participant elects a higher deferral rate.

During the year ended September 30, 2024, the Company made a discretionary employer matching contribution in which the Company contributes 33.33% of the first 6% of base compensation that a participant contributes to the Plan. The Company can also contribute a discretionary employer non-elective contribution. The Board of Directors needs to approve the discretionary employer non-elective contribution. No discretionary employer non-elective contributions were made during 2024.

Contributions are subject to annual limitations prescribed by the IRC.

Participant Investment Account Options

Participants are allowed to invest in a variety of investment choices including mutual funds, common collective trusts, and pooled separate accounts, that are more fully described in the Plan's literature. Participants may change their investment options on a daily basis.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Plan's matching contribution, and the allocation of Plan earnings; each participant account is charged an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (Continued)

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable From Participants

Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Participants cannot have more than two notes outstanding at any time. Notes are secured by the balance in the participant's account. The notes bear interest at a fixed rate commensurate with the prevailing commercial loan interest rates at the date of issuance. At September 30, 2024, outstanding notes receivable have interest rates between 4.25% to 9.50% with maturity dates through 2039. Principal and interest are paid ratably through biweekly payroll deductions for active participants. Participant notes receivable are valued at their unpaid principal balance plus accrued interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Note terms do not exceed five years unless for the purchase of a home, in which case the note term cannot exceed 15 years.

Payment of Benefits

On termination of service, a participant may receive a lump-sum distribution or installments equal to the participant's vested interest in his or her account, net of tax, roll over the entire vested portion to a qualified plan or an individual retirement account, or leave the vested portion of their balance in the Plan if the balance is at least \$5,000 at time of termination.

The method of payment depends on the participant's account balance. If the vested account balance does not exceed \$1,000, a lump-sum distribution, net of tax, will be made. If the vested balance is between \$1,000 and \$5,000 and the participant does not specify whether the distribution should be paid directly to an eligible retirement plan or paid directly to the participant, the Plan Administrator shall make a distribution in a direct rollover to an individual retirement account designated by the Plan Administrator.

Active participants may also take distributions from the Plan for reasons of financial hardship or upon attainments of age 59 ½. In-service withdrawals are subject to certain limitations.

Benefits are recorded when paid.

Forfeited Accounts

If a participant terminates employment before becoming fully vested in their account balance, the forfeited portion of the account balance is used to reduce future employer contributions and to pay Plan expenses. At September 30, 2024 and 2023, there was approximately \$13,000 and \$5,000 of forfeited nonvested account totals in the Plan, respectively. Approximately \$6,000 of forfeitures were used to reduce employer contributions to the Plan during the year ended September 30, 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Accounting Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with US GAAP. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein, and the disclosure of contingent assets and liabilities and the reported revenues and expenses. Actual results could differ from those estimates; the effect of any changes could be material. The most significant estimate relates to the valuation of investments. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value or net asset value (NAV) as a practical expedient to fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Shares of registered investment company mutual funds are valued at fair value using quoted market prices. Investments in the collective investment trusts and pooled separate accounts are stated at NAV as determined by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the "Trustee"), based on the fair market value of the underlying investments less the fund liabilities.

Participant redemptions can be transacted daily with a one-day redemption notice period, and there are no unfunded commitments for the collective investment trusts or pooled separate accounts.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held during the year, are presented in the net appreciation (depreciation) in value of investments.

Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan will distribute the 2024 excess contributions to the applicable participants during 2025.

SECURE 2.0

In December 2022, SECURE 2.0 was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2020 CARES Act. Most of the provisions of SECURE 2.0 became effective in 2024 and beyond. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect, however no decisions have been made as of September 30, 2024.

Subsequent Events

The Plan has evaluated subsequent events through May 12, 2025, the date which the financial statements were available to be issued.

Effective October 1, 2025, Plan management authorized the merger of the LDI Industries, Inc. Retirement Savings Plan into the Plan. As a result of this amendment, LDI Industries, Inc. Retirement Savings Plan merged approximately \$18,041,000 in plan assets to the Plan on October 15, 2024.

3. Information Prepared and Certified by the Trustees

As of and for the year ending September 30, 2024, the Plan's investments were held in a bank-administered trust fund of Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the "Trustee"). Participants in the Plan may direct the Trustee as to the investment of their individual account balances.

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and contract value, and notes receivable from participants, as shown in the accompanying statements of net assets available for benefits as of September 30, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended September 30, 2024.
- Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of September 30, 2024.

At the direction of the Plan Administrator, the Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. Fair Value Measurements

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the FASB fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Plan at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety. The Plan uses valuation techniques in a consistent manner from year-to-year.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds are valued daily based on active market prices.

4. Fair Value Measurements (Continued)

Pooled separate accounts and collective investment trusts are measured at fair value using the NAV practical expedient as determined by the Trustee based on the fair value of the underlying investments of each pooled separate account or collective investment trust, which is generally obtained by using quoted prices for similar assets in active markets, and include dividends and capital gains declared. The valuation of the underlying investments of each pooled separate account or collective investment trust depends on the types of investments held by the pooled separate account or collective investment trust and may be based on inputs based on other than quoted market prices.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment at Contract Value

The Plan provides a stable value investment option issued by Federated that simulates the performance of a guaranteed investment contract. The trustee maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Federated, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

6. Related Party Transactions

Certain Plan transactions and investments are managed by the Trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management and other services are included in administrative expenses. The Plan made payments to the Trustee of approximately \$55,000 for the year ended September 30, 2024. Notes receivable from participants also qualify as party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

7. Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their employer contributions, and the Plan assets will be distributed according to the provisions of the Plan documents.

8. Tax Status

The Plan adopted the non-standardized pre-approved plan sponsored by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. The non-standardized pre-approved plan obtained its latest opinion letter on June 30, 2020 in which the Internal Revenue Service stated that the non-standardized pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The non-standardized pre-approved plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of September 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. The Plan's investments are exposed to various risk factors, such as interest rates, market conditions, and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risk factors in the near term could materially affect the amounts reported in the financial statements.
