Notes to the Financial Statements

Note 1: Description of Plan

The following description of the Health Benefit Plan for the Employees of Allegiance Benefit Plan Management, Inc. (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan provides health and other benefits covering all eligible participant employees of Allegiance Benefit Plan Management, Inc. and affiliated entities ("the Plan Sponsor"), Intermountain Underwriters, Inc., Allegiance COBRA Services, Inc., Dagger, LLC and Allegiance Care Management, LLC herein referred to as "Allegiance Companies". The Plan is funded by the Allegiance Companies and was established August 1, 1990. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Plan provides health benefits including medical, hospital, surgical, major medical, vision, dental, and pharmaceutical, to eligible participants and their covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The Plan purchases reinsurance for individual and aggregate stop losses each year effective September 1. The coverage is for medical and prescription claims. The Plan is self-insured for health benefits to an annual maximum of \$100,000 per employee.

Contributions

All contributions to the plan for participants working 40 hours per week are made by the Allegiance Companies. Participants working between 30-40 hours per week are required to pay a percentage of the monthly contribution on their behalf. The Allegiance Companies do not pay contributions to the Plan for dependents of plan participants. Participants working between 30-40 hours per week are eligible for the Plan, upon meeting a 59 day waiting period.

Other

The Plan's management has the right under the Plan to modify the benefits provided to plan participants.

Notes to the Financial Statements

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). Contributions are recorded when earned and distributions are recorded paid.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Estimated Health Claims Incurred but Not Paid

The Plan's liability for estimated health claims incurred but not paid as of August 31, 2024 and 2023, is estimated based on claims paid subsequent to the Plan year end.

The Plan Sponsor is obligated to contribute amounts necessary to pay for the benefits of the Plan which may ultimately exceed the estimate. Any receivable from the Plan Sponsor is considered fully collectible.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair-value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 3: Tax Status

The trust established under the Plan is a taxable trust. The trust does not have a tax liability. The Plan sponsor believes the trust continues to operate in accordance with applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Trust has determined that they are subject to examination of their federal information return filings in the United States of America for the three preceding open tax years.

Note 4: Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to, and required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Allegiance Companies or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 5: Related-Party Transactions and Party-in-Interest Transactions

The Allegiance Companies provide certain accounting and administrative services to the Plan for which no fees are charged. The Allegiance Companies are considered related-party.

HCC Life Insurance Company provided stop-loss insurance under the Plan. For the Plan years ended August 31, 2024 and 2023, HCC Life Insurance Company received \$1,144,015 and \$1,089,486, respectively, in premiums paid from the net assets of the Plan and are included in health benefit payments on the statements of changes in benefit obligations and net assets available for benefits.

Note 6: Administrative Expenses

Administrative expenses are disclosed on the financial statements and paid for from the net assets of the Plan. The Sponsor pays certain other miscellaneous expenses on behalf of the Plan and is not reimbursed for those expenses. Expenses paid by the Sponsor are not included in these financial statements.
