Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **SQZ Biotechnologies Company Retirement Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits in liquidation – modified cash basis as of November 11, 2024, and December 31, 2023, and the related statement of changes in net assets available for benefits in liquidation – modified cash basis for the period January 1, 2024 through November 11, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of **SQZ Biotechnologies Company Retirement Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **SQZ Biotechnologies Company Retirement Plan** and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As described in Note 1 to the financial statements, the Board of Directors of SQZ Biotechnologies Company voted to terminate the Plan in 2023. As a result, the Plan has changed its basis of accounting to the liquidation basis. The final distribution out of the Plan occurred on November 11, 2024.

Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting as described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable preparation of the financial statements in the circumstances, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about **SQZ Biotechnologies Company Retirement Plan's** ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of **SQZ Biotechnologies Company Retirement Plan's** internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about **SQZ Biotechnologies Company Retirement Plan's** ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1: DESCRIPTION OF PLAN

The following description of the SQZ Biotechnologies Company Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan was a defined-contribution plan established on July 20, 2015, to provide retirement and other related benefits to all employees of SQZ Biotechnologies Company (the "Company"). Union employees, nonresident aliens, leased employees and interns, temporary or seasonal employees with less than 1,000 hours of service worked during the Plan year and co-op employees hired on or after January 6, 2020, were excluded from eligibility. An employee who was age 21 or older became eligible to participate for purposes of salary reduction contributions immediately upon hiring. Entry dates occurred on the first day of each month. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Termination: The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. On October 20, 2023, the Board of Directors of the Company voted to terminate the Plan effective November 15, 2023. Contributions to the plan were frozen at that time. As a result, the Plan has changed its basis of accounting to the liquidation basis of accounting. Participants became fully vested in their accounts as a result. All plan assets were distributed out to participants on November 11, 2024.

Contributions and Allocations: Each year, participants contributed an amount up to a certain percentage of their pretax annual compensation, as defined in the Plan. Participants who had attained the age of 50 before the end of the Plan year were eligible to make catch-up contributions as prescribed by Treasury regulations. Participants could designate a portion, or all, of their deferred contributions as Roth contributions, which were includable in the participant's gross income. Participants, with the consent of the Plan Administrator, could deposit amounts received from any other retirement plan which satisfy the tax rules for rollovers. Contributions were subject to certain limitations under the Internal Revenue Code ("IRC"). Unless instructed otherwise by the participant, upon becoming eligible to participate in the Plan, 4% of a participant's eligible compensation was contributed to the Plan subject to annual limits set by the Internal Revenue Service ("IRS").

The Company would determine in its sole discretion how much, if any, it could make as a matching contribution. For the period ended November 11, 2024, the Company did not make discretionary matching contributions to the Plan.

The Company could also make a discretionary non-elective profit-sharing contribution to the Plan based on each participants' compensation and age. There were no profit-sharing contributions made for the period ended November 11, 2024.

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts: Each participant’s account was credited with the participant’s contributions and Plan earnings or losses and charged with an allocation of administrative expenses, if any. Allocations of participant earnings (losses) were based on account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant’s vested account balance.

Investment Options: Participants directed the investment of contributions into various investment options offered by the Plan. The Plan offered various mutual funds and a common/collective trust as investment options for participants.

Vesting: Participants were immediately vested in their voluntary contributions and any related earnings thereon. Prior to the resolution to terminate the Plan, employer discretionary matching contributions and related earnings were subject to a vesting schedule based on the number of years of service as follows:

Forfeited Accounts: At November 11, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0. These accounts could be used to pay administrative expenses or used to reduce future employer contributions. During 2024, \$4,154 of forfeitures were used to reduce Plan expenses.

Notes Receivable from Participants: Participants could borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances, whichever was less. Loans were secured by the balances in the participants’ accounts and bore interest at rates based on the prevailing interest rates charged by persons in the business of lending money for loans that would be made under similar circumstances. Principal and interest were paid ratably usually through payroll deductions. A participant could only have one loan outstanding at any time. If participants terminate or retire, they could have the choice of repaying the loan or having the loan offset from their account. The offset loan amount could be considered a taxable distribution.

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits: Benefits were payable either in lump sum payments or installments upon a participant's normal retirement age, in service withdrawals after age 59½, death, permanent disability, separation of service, or reasons of proven hardships. The hardship withdrawals were subject to a minimum of \$1,000. Withdrawals could be made under certain other circumstances in accordance with the Plan Document. The Plan required a lump-sum distribution if a participant terminates employment, and the vested balance was less than \$5,000.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements were prepared using the liquidation basis and modified cash basis of accounting, which was a basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). The liquidation basis required all assets to be reported at fair market value. Under the modified cash basis of accounting, investments were recorded at fair value, contributions were recorded when received and benefits were recorded when paid. The modified cash basis of accounting was an acceptable alternative method of reporting under regulations issued by the Department of Labor ("DOL"). The financial statements have been prepared to satisfy the reporting and disclosure requirements of ERISA.

Investment Valuation and Income Recognition: Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees and other parties involved with the Plan. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Administrative Expenses: Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation of fair value of investments.

Use of Estimates: The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Risks and Uncertainties: The Plan utilized various investment instruments. Investment securities, in general, were exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities could occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits - modified cash basis.

Payment of Benefits: Benefit payments to participants were recorded when paid.

Notes Receivable from Participants: Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses was recorded as of November 11, 2024 or December 31, 2023.

Uncertain Tax Positions: The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 11, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress. The Plan Administrator believes it was no longer subject to income tax examinations for years prior to 2022.

NOTE 3: TAX STATUS

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan had not received a determination letter specific to the Plan itself; however, the Plan Administrator believed that the Plan was designed and was currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 5: FAIR VALUE MEASUREMENTS

The Financial Accounting Standard Board ("FASB"), Accounting Standards Codification ("ASC") 820, "*Fair Value Measurement and Disclosures*", provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 were described as follows:

Level 1 - inputs to the valuation methodology were unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 - inputs other than quoted market prices included within Level 1 that were observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that were observable for the asset or liability;
- inputs that were derived principally from or corroborated by observable market data by correlation or other means.

NOTE 5: FAIR VALUE MEASUREMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs that were unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following was a description of the valuation methodologies used for assets measured at fair value at December 31, 2023. There were no assets at fair value at November 11, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Common/collective trust: Valued at the net asset value of units of a collective trust. The NAV, as provided by the fund manager, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it was determined to be probable that the fund could sell the investment for an amount different from the reported net asset value.

The preceding methods described produced a fair value calculation that could not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no assets held for investment at November 11, 2024.
