INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Ed Herrington, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended November 30, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Ed Herrington, Inc. 401(k) Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan covering substantially all employees of Ed Herrington, Inc. (the "Company"), who have 90 days of service and are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended at various dates to conform with prototype plans utilized by the plan administrators. These were amendments of the preexisting qualified plan which was originally effective December 1, 1964.

Contributions

Participants may make pre-tax and/or Roth contributions to the Plan through payroll deductions up to 100% of compensation, as defined, up to the limit prescribed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions as determined by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options among a predetermined group of investment options offered by the Plan. Additionally, the Plan allows for contributions to be invested in self-directed investment options outside the predetermined group of investment options, as determined by the participant.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rates set at 5% of eligible compensation. Contributions are invested in a designated fund until changed by the participant.

The Company shall contribute and allocate to each participant with at least one year of service and at least 18 years of age, a safe harbor plan match of 100% of the first 3% of eligible compensation that a participant contributes to the Plan, plus 50% of the next 2% of eligible compensation that a participant contributes to the Plan. The Company also has the option to make an additional discretionary profit-sharing contribution up to certain Internal Revenue Service (IRS) limitations. For the years ended November 30, 2024 and 2023, there were no additional discretionary profit sharing contributions to the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, optional participant rollovers, if any, and Plan investment earnings, less allocated administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the accumulated balance of each participant's vested account.

Vesting

Participants are immediately vested in their contributions and safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's additional discretionary profit-sharing contribution is based on years of service. A participant is 20% vested after two years of service, increasing by 20% per year, with 100% vesting after 6 years of credited services.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Note terms range from 1-5 years, or a reasonable number of years determined by the Plan administrator for the purchase of a primary residence. The notes are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing borrowing rates as determined by the Plan administrator. The rate of interest remains constant throughout the term of the loan. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Withdrawals from the Plan are generally permitted in the event of termination of employment, normal retirement date (65), severe financial hardship as defined by the Plan, qualified military duty, disability, death, or for any reason after attaining age 59 ½. Distributions for reasons other than death are eligible for lump sum distribution equal to the value of the participant's vested interest in his or her account. Distributions due to death may be distributed as a lump sum or through annual installments over a fixed number of years not to exceed the participants beneficiary's life expectancy. Lump-sum payments will be automatically distributed for participant vested account balances that are \$5,000 or less.

Forfeited Accounts

Forfeitures from participants' nonvested accounts may be used by the Company to reduce future company contributions or pay administrative expenses under the Plan. At November 30, 2024 and 2023, forfeited nonvested accounts totaled \$4,531 and \$1,252 respectively. There was \$1,752 in forfeitures used during the year ended November 30, 2024 to reduce employer contributions to the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment in accordance with the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Investment management expenses are deducted from investment returns and classified under net appreciation in fair value of investments. Administration and recordkeeping fees paid by the Plan are classified as administrative and related expenses. All other administrative expenses of the Plan are paid by the Company and excluded from these financial statements.

Subsequent Event

The Plan has evaluated subsequent events through May 30, 2025 the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices of identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or 2 were not available.

The asset's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 3 – FAIR VALUE MEASUREMENTS (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2024 compared to November 30, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: The collective investment held by the Plan invests solely in the MetLife Group Annuity Contract 25053. The common collective trust fund is valued at the net asset value (NAV) on the last day of the calendar year of the period; as a result, the investment is not classified within the fair value hierarchy. The primary investment objective of the Fund is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices, as well as U.S. government securities that are valued using pricing models maximizing the use of observable inputs for similar securities.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – INFORMATION CERTIFIED BY TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC as an authorized representative of Ascensus Trust Company ("Ascensus"), the trustee, has furnished certain financial information to the plan administrator and certified as to its completeness and accuracy. These certifications are as of November 30, 2024 and 2023, and for the year ended November 30, 2024 and includes investment information related to fair value of investments, notes receivable from participants, interest and dividend income, interest income on notes receivable from participants and net appreciation (depreciation) in fair value of investments that is included in the Plan's financial statements and supplemental schedule of assets (held at end of year).

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Ascensus. Ascensus is the trustee as defined by the Plan, and therefore these transactions qualify as exempt party-in-interest transactions.

Notes receivable from participants qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

NOTE 6 – TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the volume submitter profit sharing plan adopted by the Plan, as then designated, is in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the advisory letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however there are currently no audits for any tax periods in progress.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all of their accounts.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
