Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tidal Power Services, LLC 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Empower Trust Company, LLC as of December 31, 2024 and for the period from March 2, 2024 to December 31, 2024, and John Hancock Life Insurance Company as of December 31, 2023 and for the period January 1, 2024 to March 1, 2024 stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

A. Description of Plan

The following description of the Tidal Power Services, LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan was established on January 1, 2007 as a defined contribution plan sponsored by Tidal Power Services, LLC. The Plan Sponsor is a member of a controlled group, which includes Tidal Power Services Louisiana, LLC as a participating employer (collectively, the Employer or Company). The Plan covers substantially all employees of the Company. The Plan excludes union employees, nonresident aliens, and leased employees. The Plan is subject to the provisions of ERISA. The Plan Administrator and Investment Committee are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings, and monitor investment performance.

Effective January 1, 2024, the Plan was amended to change the Plan name, remove the discretionary employer matching and profit sharing contributions, remove the exclusion of part-time employees with less than 1,000 service hours, temporary and seasonal employees, remove the age requirement to participate in the Plan, and to clarify the Plan's definition of eligible compensation. Effective March 1, 2024, Plan management changed Plan custodial and recordkeeping services from John Hancock Life Insurance Company to Empower Trust Company, LLC.

2. *Contributions.* Each year, participants may contribute up to 100% percent of pretax or after-tax annual eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a safe harbor match amount which was 100% of the first 3% of compensation that a participant contributed to the Plan for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.
3. *Participant accounts.* Each participant's account is credited with the participant's contributions and Employer contributions, rollovers, as well as allocations of Plan earnings and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. *Vesting.* Participants are vested immediately in their contributions and the Company's safe harbor matching contributions, plus actual earnings thereon.

5. *Payment of benefits.* On termination of service a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or partial withdrawals. Distributions after termination of employment for reasons other than the above shall commence as soon as administratively feasible. For distributions of \$7,000 or less, no participant consent is required and may only be made as a lump sum.
6. *Forfeited accounts.* These accounts will be used to reduce future Company contributions or pay Plan expenses. During the year ended December 31, 2024, no forfeitures were used to reduce Company contributions or to reduce expenses nor were there forfeiture balances as of December 31, 2024 or 2023 available for use.

B. Summary of Accounting Policies

1. *Basis of accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).
2. *Use of estimates.* The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. *Investment valuation and income recognition.* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator and Investment Committee determine the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. *Payment of benefits.* Benefits are recorded when paid.
5. *Expenses.* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to withdrawals are included with benefits paid to participants in the statement of changes in net assets available for benefits. Recordkeeping and investment advisory fees are charged directly to administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

6. *Subsequent events.* The Plan has evaluated subsequent events through May 30, 2025, the date the financial statements were available to be issued.

C. Certified Investments

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and John Hancock Life Insurance Company, the Trustee and former custodian of the Plan, respectively, has certified that the following data included in the Plan's financial statements and supplemental schedule is complete and accurate. Empower Trust Company, LLC has certified information as of December 31, 2024 and for the period from March 2, 2024 to December 31, 2024. John Hancock Life Insurance Company has certified information as of December 31, 2023 and for the period January 1, 2024 to March 1, 2024.

D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective trust: Valued at the NAV of underlying investments of participant units held by the Plan as of the last trading day of the period, as reported by the managers of the trust.

Pooled separate accounts: The underlying assets of the pooled separate accounts consist of funds known as sub-accounts. Each sub-account invests its shares or units in an underlying mutual fund. Sub-accounts are measured in terms of accumulation units. The sub-accounts are valued based on the quoted market prices of the mutual funds. Certain fund fees and expenses, mortality and risk charges, and administration charges are deducted from the value of the mutual funds to arrive at the value of the sub-accounts. The accumulation units are valued at NAV on a daily basis. The NAV is made publicly available by the former custodian.

F. Party in Interest Transactions

Plan investments are managed by the Trustee. The Trustee is also the recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Included in administrative expenses in the statement of changes in net assets available for benefits are fees paid to parties in interest related to recordkeeping and administration for the year ended December 31, 2024. Fees paid to the Trustee for investment management are netted against net appreciation (depreciation) in the fair value of investments.

G. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

H. Tax Status

The Plan has adopted a prototype non-standardized defined contribution plan with CODA that has received an advisory letter dated November 14, 2022, in which the Internal Revenue Service stated that the non-standardized plan was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Once qualified, the Plan is required to operate in accordance with the IRC to maintain its qualification. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. As of December 31, 2024, approximately 27% of the Plan's net assets available for benefits were invested in one of the Plan's mutual funds. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
