INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
MAA 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of MAA 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We

are required to be independent of MAA 401(k) Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of MAA 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Mid-America Apartment Communities, Inc. (the Sponsor). Each employee of the Sponsor who has completed six months of service is eligible to participate in the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Collective bargaining employees, non-resident aliens, leased employees and reclassified employees are excluded from the Plan.

Plan Administration

Empower Trust Company, LLC (Empower) serves as trustee of the Plan, and T. Rowe Price Trust Company (TRPTC) is the custodian of the T. Rowe Price Stable Value Fund. Empower Retirement is the recordkeeper for the Plan.

Contributions

Each year, participants may contribute up to 75% of compensation, as defined, subject to certain Internal Revenue Code (IRC) limitations. Any eligible employee hired who fails to make an affirmative election whether to participate in the Plan will be automatically enrolled in the Plan, and an election of 2% of the employee's annual compensation will be contributed to the Plan. No further increases will occur. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan will accept eligible rollover contributions on behalf of the participant from qualified plans. Participants may direct the investment of their contributions into various investment options offered by the Plan.

The Sponsor makes safe harbor matching contributions to all eligible participants. Matching contributions of 100% of the first 3% and 50% of between 3% and 5% of eligible compensation will be made to participant accounts.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Sponsor's contributions as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are used to pay the recordkeeper's fee to administer the Plan. Allocations are based on participant earnings or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

As part of the safe harbor amendment effective January 1, 2016, participants are immediately vested in their total account. Participants in the Plan prior to the amendment are vested in the Sponsor's pre-amendment contribution portion of their accounts plus actual earnings and losses; thereon, based on years of service. These participants vest by 20% per year of credited service and are fully vested at the earlier of death, disability, attainment of age 65 or after five years of credited service. Employees who were employees of Post Properties, Inc. who terminated on November 30, 2016, in connection with the Mid-America Apartment Communities, Inc. merger, as well as those employees who had a transition services agreement and were still employed on

the end date of the transition services agreement are 100% vested at all times in all Sponsor accounts.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The interest rate is calculated as prime rate plus 1%. Participants may only take out one loan at a time. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon normal retirement at age 65, attaining age 59½, termination of employment, death or disability, the participant or the participant's beneficiary can elect to receive their vested account balance in one lump sum or in partial payments. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. All vested balances less than \$5,000 may be automatically distributed after termination of employment and moved to an individual retirement account. Effective April 2024, this amount changed to \$7,000.

Forfeitures

Forfeitures by non-vested participants are used to reduce Sponsor contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$130,596 and \$93,916, respectively. The Sponsor applied forfeitures of \$20,263 to reduce Sponsor contributions and \$925 to reduce Plan expenses during 2024.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by Empower and TRPTC, the Certifying Entities. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. During 2024, the Plan paid administration fees and investment and advisory fees, which are included in the statement of changes in net assets available for benefits. Expenses relating to specific participant transactions are charged directly to the participant's account.

Subsequent Events

Management has evaluated events through May 29, 2025, which is the date that the financial statements were available to be issued and has determined there are no subsequent events that require disclosure under the Subsequent Events topic of Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 855, *Subsequent Events*.

3. INFORMATION CERTIFIED

Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower and TRPCT.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 *Fair Value Measurements* are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Mutual funds: Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Common collective trust funds: These funds are valued at the net asset value (NAV) of units of the collective fund. The NAV is based upon the fair value of the underlying investments held by the respective fund less its liabilities and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were funds managed by TRPTC. TRPTC is a custodian to the Plan. Empower is the recordkeeper for the Plan, and Empower Advisory Group, LLC, served as advisors to the Plan during 2024. Therefore, fees paid to these entities qualify as party-in-interest transactions.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

7. TAX STATUS

The Plan adopted a GWTC standardized prototype plan document. The underlying prototype plan document received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the prototype plan documents is qualified under Section 401(a) of the IRC; and is therefore, tax-exempt. The Plan itself did not receive a determination letter from the IRS. The prototype plan document has been amended since receiving the opinion letter; however, Plan management believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, including the IRS. The Plan is not currently under IRS examinations for any Plan years.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
