## INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustee of the  
Remington Advertising Agency Group Health Benefit Plan

### Opinion

**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Remington Advertising Agency Group Health Benefit Plan (the Plan), is provided for general information purposes only. Participants should refer to the summary plan description for more complete information.

**General** - The Plan was established on January 5, 2001 to provide health and welfare benefits to the employees of the Remington Advertising Agency, Inc. (the Plan Sponsor) in accordance with the terms outlined in the plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Benefits** - The Plan provides health benefits (medical, prescription drug, vision and dental), short-term and long-term disability, and other employee welfare benefits, as well as death benefits to eligible employees of the Plan Sponsor. With the exception of a few categories of employees specified in the plan agreement, eligibility is obtained after 30 days of full or part-time employment.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of Accounting** - The accompanying financial statements are prepared using the accrual basis of accounting.

**Investment Valuation and Income Recognition** - Money market fund is carried at fair value which generally represents reported market value as of the last business day of the year.

Purchases and sales of investments are recorded on a trade-date basis. Interest and dividends are recorded on the accrual basis.

**Funding Policy and Revenue Recognition** - The Plan Sponsor makes contributions to the Plan in accordance with the plans specifications for benefit coverage. Additionally, employees may make additional payments for extended benefit coverage. Employer contributions are accounted for as exchange transactions. The contributions are due on a monthly basis. It is the policy of the Trustee to pursue monies due.

The Plan also accepts self-payments from those participants who are covered under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA), and those making contributions to maintain eligibility.

## **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

Employer contributions due but not paid at year end are recorded as contributions receivable. The Plan believes that the receivables are fully collectible; therefore no allowance for credit losses is recorded.

**Stop Loss** - Stop loss refunds are recorded when earned in the period in which the benefit was recorded.

**Benefit Obligations** - Benefit obligations at August 31, 2024 and 2023, for health claims incurred by participants, but not reported at that date, have been estimated by the Plan's Third Party Administrator based on actual claim payment data subsequent to year-end.

**Payment of Benefits** - Premiums paid by third-party claims administrators are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when paid by a third-party claims processor. These payments are recorded as benefit payments in the accompanying statements of changes in net assets available for benefits.

**Rebates** - The Plan receives rebates related to prescription drugs which are recorded when earned. Rebates received subsequent to year-end for coverage during the year are recorded in other receivables on the statements of net assets available for benefits, with the offset being netted against claims paid. For the years ending August 31, 2024 and 2023, rebates totaling \$23,986 and \$27,659, respectively, have been netted against benefits payments in the accompanying statements of changes in net assets available for benefits.

**Estimates** - The presentation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

## **NOTE 3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**NOTE 3. FAIR VALUE MEASUREMENTS (continued)**

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended August 31, 2024 and 2023, there were no transfers in or out of levels 1, 2, or 3.

There have been no changes in valuation methodologies used at August 31, 2024 and 2023.

**NOTE 5. TAX STATUS**

The Plan has obtained a favorable determination letter in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under section 501(c)(9) of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

**NOTE 6. PRIORITIES UPON TERMINATION**

It is the intent of the Plan Sponsor to continue the Plan in full force and effect. However, in order to safeguard against any unforeseen contingencies, the Plan Sponsor has the right to suspend or terminate the Plan subject to the provisions of the plan agreement and ERISA Regulations. In the event of the Plan termination, the Plan Sponsor will be responsible for all claims incurred under the Plan prior to the termination date of the Plan. Any remaining net assets in the Plan after the payment of all claims must be transferred to another trust which provides benefits to the employees of the Plan Sponsor.

**NOTE 8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**NOTE 9. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan is related through a common Board of Trustee member to Ruchman & Associates Inc. 401(k) Profit Sharing Plan (the 401(k) Plan) and have the same Plan Sponsor. For the years ended August 31, 2024 and 2023, the Plan paid certain expenses of \$0 and \$20,600, respectively, on behalf of the 401(k) Plan.

**NOTE 9. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (continued)**

The money market is held at Wilmington Trust financial institution, and are managed by Manufacturers Traders Trust Company (M&T). M&T is the directed Trustee and Wilmington Trust financial institution is the custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. These transactions have been denoted as such on the supplemental schedule of assets held at end of year and schedule of reportable transactions. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA. For the years ended August 31, 2024 and 2023, the Plan paid fees of \$10,312 and \$9,642, respectively, to M&T. As of August 31, 2024 and 2023, the Plan did not have any outstanding obligations to M&T.

**NOTE 10. CONCENTRATION OF RISK**

The Plan maintains its cash in accounts which may exceed federally insured limits. The Plan has not experienced any losses on such accounts and management does not believe the Plan is exposed to any significant financial risk.

**NOTE 11. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through May 30, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.


