### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Mountain Cascade, Inc. Profit Sharing/401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1:**      **Description of Plan**

The following description of the Mountain Cascade, Inc. Profit Sharing/401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan was established on April 1, 1982, by Mountain Cascade, Inc. (the Company) to provide retirement benefits for its employees in accordance with section 401(k) of the Internal Revenue Code (IRC). This Plan is a defined contribution plan covering all eligible employees completing 500 hours of service within six consecutive months of employment and who have reached age 21. Employees who are non-resident aliens or who are subject to a collective bargaining agreement are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan, up to the limits defined by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan is a traditional automatic contribution arrangement 401(k) plan. Employees are automatically enrolled on October 1 or April 1 following the point they reach eligibility. The employer will withhold a percentage of 3% eligible compensation with annual increases of 1% up to a maximum of 6% of compensation. The Company may also elect to make discretionary profit sharing contributions. These contributions are invested in various investments held by the Plan custodians.

**Participant Accounts**

Each participant's account is credited with the participant's own contributions, an allocation of the Company's contributions, and an allocation of net earnings from investments and changes in investment values. Allocations are based on each participant's contributions, earnings, or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's account.

**Vesting**

Participants are vested immediately in their contributions as well as the nonelective safe harbor contributions and any earnings thereon. Participants vest in discretionary profit sharing company contributions at the rate of 20% per year, with 0% vested until the end of the second year, and 100% vesting at the end of the sixth year. One year requires completion of 1,000 hours of service in each of the years of continuous service. The nonvested portion of a terminated participant's account balance is forfeited. Forfeited accounts are applied to reduce employer contributions and Plan expenses.

**Forfeitures**

At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$28,454 and \$516, respectively. These accounts will be used to pay plan expenses or offset future employer contributions. During the year ended September 30, 2024, no employer contributions were used from forfeited nonvested accounts.

**Notes Receivable from Participants**

Notes receivable from participants consist of loans received by participants in exchange for promissory notes to the Plan. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years, except for loans used to finance the purchase of a principal residence. Loans bear interest at rates commensurate with local prevailing rates as determined by the Plan administrator, and remain fixed throughout the life of the loans. Principal and interest are paid ratably through payroll deductions. Loans to participants are stated at the principal amount outstanding, which approximates fair value.

**Payment of Benefits**

Upon termination of service, including termination due to death, disability, or retirement, a participant may receive a lump-sum distribution or a direct rollover distribution into a qualified plan. At the time of retirement, if a participant's account balance is in excess of \$5,000, the participant may delay the distribution. However, for all participants, minimum required distribution must be made by April 1<sup>st</sup> following the year the participant retires or reaches the age 73.

**Administrative Expenses**

The Company, as Plan sponsor, pays certain administrative expenses on behalf of the Plan. Participant's accounts are adjusted for fees pertaining to loan or termination processing, and are charged for expenses incurred by the custodian in the performance of their duties.

**Note 2: Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Payment of Benefits**

Benefits are recorded when paid.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions which affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are stated at fair value and contract value as certified by the Plan's custodians. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 and 2023. If a participant ceases to make loan payments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Subsequent Events**

In preparing the accompanying financial statements, management has considered events that have occurred after September 30, 2024, through April 22, 2025, the date these financial statements were available for issuance. As of such date, management was not aware of any subsequent events requiring additional disclosure.

**Note 4: Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1) Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2) Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3) Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment funds:* Investments in collective investment funds are valued at the NAV of the units of the collective investment fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities.

**Note 5: Tax Status**

On June 30, 2020, the IRS stated that the non-standardized pre-approved plan adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all accounts become fully vested and non-forfeitable. Plan assets would first be used to pay any expenses properly charged to the Plan. The remainder would then be distributed to participants in a lump sum.

**Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8: Non-Exempt Transactions**

During the Plan years ended September 30, 2024 and 2023, the Company failed to remit to the Plan's custodian certain employee contributions totaling \$1,022,983 and \$839,379, respectively, within the period prescribed by the Department of Labor regulations. Delays in remitting contributions to the custodian were due to administrative errors. The Company made corrective contributions associated with the 2023 delinquent contributions during the plan year ended September 30, 2024. The Company intends to correct the 2024 delinquent contributions during the plan year ended September 30, 2025.
