## Notes to Financial Statements

### Note A – Description of Plan

The following description of Manning Building Supplies, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan was classified as a defined-contribution plan that was established effective January 1, 1985, and was last restated as of January 1, 2021. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan covered all employees of Manning Building Supplies, Inc. (the “Company” or the “Employer”) who have worked at least 1,000 hours annually, completed one year of service and have reached 21 years of age.

Effective February 1, 2024, as part of the acquisition between the Company and US LBM Holdings, LLC, the existing 401(k) plan was merged into the US LBM Holdings 401(k) Plan. As a result, the Plan recorded a transfer out of the full balance of the Plan’s net assets available for benefits.

#### Administration

The accounting records were maintained by the Company. The Plan’s assets were held and managed by Voya Retirement Insurance and Annuity Company (the “Custodian”). Contributions were held by the Custodian, who invests cash received, interest and dividend income, as directed by the participant, and makes distributions to participants.

#### Contributions

The Plan did not allow for participant salary deferral contributions. However, the Plan allowed for direct rollover contributions by participants from other eligible retirement plans. The Company may also make profit sharing contributions at their discretion. The amount of the contribution was based on the profitability of each location. Participants received their share of the contribution based on their compensation as a percentage of total compensation for that division. No profit-sharing contribution was declared for the period from January 1, 2024 to February 1, 2024.

#### Participant Accounts

Each participant’s account was credited with the allocations of the Company’s contribution, if any, and Plan earnings, and charged with an allocation of administrative expenses. Allocations of Plan earnings or losses were based on each participant’s investment fund balance in proportion to the total investment fund balance. The benefit to which a participant was entitled was the benefit that can be provided from the participant’s account.

#### Vesting

Participants were immediately vested in their rollover contributions plus actual earnings thereon. Vesting in any Company contributions was based on years of continuous service. A participant was 100% vested after six years of credited service as follows:

### Note A – Description of Plan

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 % of their vested account balance. Loan terms can be up to five years. These loans were collateralized by the balance in the participant's account and bear interest at prevailing rates as determined by the Plan Administrator. Principal and interest were paid by payroll deduction in substantially equal payments over the life of the loan, with payments not less frequently than monthly.

Notes receivable from participants were measured at their unpaid principal balances plus any accrued but unpaid interest. If any portion of principal and interest remains unpaid 90 days after due, the loan will be considered in default. In the event of default, the unpaid portion of the participant's loan will be treated as a taxable distribution.

#### Distribution of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum cash payment, in equal monthly, quarterly, semiannual, or annual cash installments, or, upon retirement, in installments based upon the participant's life expectancy at the time of retirement. A participant at age 65 may withdraw any part of their vested balance only twice in a twelve month period from discretionary contribution balances. Any participant may make up to two withdrawals in a twelve month period from their rollover contribution balance. Hardship withdrawals were permitted under the Plan. There were no unpaid amounts allocated to participants who elected to withdraw from the Plan as of February 1, 2024 and December 31, 2023, respectively.

#### Forfeitures

Forfeited balances of terminated participants' non-vested accounts were used to reduce Plan expenses and future Employer contributions. As of December 31, 2023, there was approximately \$14,000 outstanding that could be used to offset Plan expenses or future Employer contributions. During 2024, no forfeited non-vested accounts were utilized to reduce Employer contributions, and the forfeiture balance was included in the transfer out of the plan to the successor plan.

### Note B – Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

#### Valuation of Investments

The Plan's investments were stated at fair value, except for the fully benefit-responsive investment contracts, which were reported at contract value as described in Note D. Fair value was based on quoted market prices at year-end as reported by the Custodian. Purchases and sales of securities were recorded on a trade date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date.

#### Payment of Benefits

Benefits were recorded when paid.

### Note B – Summary of Significant Accounting Policies (continued)

#### Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Employer. Expenses that were paid by the Employer were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net appreciation of fair value of investments.

#### Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value in Accounting Standards Codification 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1*            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2*            Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
  - If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
  
- Level 3*            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

*Pooled separate accounts:* Valued at the net asset value ("NAV") provided by the custodian. The NAV was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2023. Participant-directed redemptions have no restrictions and were recorded at the end of every business day.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. Investments measured using the NAV as a practical expedient were exempt from being presented in the fair value hierarchy. As all of the Plan's investments were exempt from the fair value hierarchy, the table has been excluded.

### Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2024 to February 1, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian, a qualified institution. As of February 1, 2024 and December 31, 2023, and for the period from January 1, 2024 to February 1, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by the Custodian, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note D – Fully Benefit-Responsive Investment Contracts

Fully benefit-responsive investment contracts, at contract value on the statement of net assets consist of the following investment(s):

As of December 31, 2023, the Plan was invested in a guaranteed interest account (Voya Fixed Account, "the Fund") provided through a group annuity contract. Under the Fund, a crediting rate was established and was credited with contributions and charged for participant withdrawals and administrative expenses charged by the custodian of the Fund. The guaranteed interest account issuers were contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. Fair value of the investment contract closely approximates contract value and such, there was no adjustment reflected in the accompanying statements of net assets available for benefits.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan,) (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exempt under ERISA. The Plan Administrator did not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The Fund did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### Note E – Income Tax Status

The Plan received a determination letter from the Internal Revenue Service dated June 30, 2020 stating that the Plan was qualified under Section 401(a) of the Internal Revenue Code ("IRC") and, therefore, the related trust was exempt from taxation. Subsequent to the issuance of the determination letter, the Plan was amended. Once qualified, the Plan was required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believed the Plan was being operated in compliance with the applicable requirements of the IRC and, therefore, believed that the Plan, as amended, was qualified and the related trust was tax-exempt.

### **Note E – Income Tax Status (continued)**

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan was no longer subject to examination by taxing authorities for years prior to 2020.

### **Note F – Parties-In-Interest Transactions**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments were pooled separate accounts and fully benefit-responsive investment contracts managed by the Custodian. Transactions related to these investments qualify as party-in-interest transactions. Notes receivable from participants were also considered to be party-in-interest transactions because they were transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$1,000 for the period from January 1, 2024 to February 1, 2024.

### **Note G – Subsequent Events**

Subsequent events have been evaluated through May 29, 2025, which is the date the financial statements were available to be issued.
