## 1. Description of Plan

The following brief description of the Incentive Savings and Investment Plan for Employees of National Cargo Bureau, Inc. (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution retirement plan covering substantially all of the employees of the National Cargo Bureau, Inc. (the "Bureau" or "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") as amended.

### **Eligibility and Contributions**

Employees become eligible to participate in the Plan after three consecutive months of service. Employees may contribute up to 50% of their base salary, excluding any additional compensation, through payroll deductions made on a pre-tax or after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing contributions from other qualified plans. The Plan satisfies the safe-harbor requirements by providing a 3% contribution of compensation to eligible employees that is fully vested at all times. The Employer also makes matching contributions in an amount equal to 100% of a participant's contributions not to exceed 3% of their base salary, subject to Internal Revenue Service ("IRS") limitations.

### **Vesting**

Participants are vested immediately in their contributions and the Employer safe-harbor contributions plus actual earnings thereon. Vesting in the Employer matching contributions portion of their account is as follows:

**1. Description of Plan (continued)**

***Notes Receivable from Participants***

Loans of up to 50% of a participant's account balance, a minimum amount of \$500 but not more than \$50,000 are permitted. Loans bear interest based on loans granted under similar circumstances by the Bureau's principal banking institution. All loan repayments are made through payroll deductions. Loans are required to be repaid within a five-year period. Loans to acquire a principal residence may be repaid within 25 years.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,746 and \$4,473. These accounts will be used to reduce future Employer contributions. During 2024, no forfeitures were used to reduce Employer contributions.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

***Participant Accounts***

Each participants account is credited with the participant's contributions and allocations of (a) the Bureau's contribution and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested account.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### 2. Summary of Significant Accounting Policies *(continued)*

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. The mutual funds and money market fund are valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price and are deemed to be actively traded. The common/collective trust is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined that the Plan will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Bureau and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value on investments.

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is May 29, 2025.

### **5. Common/Collective Trust**

The Vanguard Retirement Savings Trust (the "Trust") is a common/collective trust that provides for the collective investment of assets of tax-exempt retirement plans. The Trust invests solely in the Vanguard Retirement Savings Trust Master Trust ("VRST Master Trust"). The underlying investments of VRST Master Trust are primarily in a pool of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by bond funds.

The Trust pays Vanguard Fiduciary Trust Company, the trustee of the Trust, a fee calculated at an annual percentage rate of the Trust's proportionate share of the total investments of the VRST Master Trust. During the year ended December 31, 2024 and 2023, the annualized rate charged to the Trust was 0.28%. The fee is determined by the trustee and may be adjusted periodically.

Distributions of net investment income to unit-holders are declared daily and reinvested on the first business day of the following month. Distributions received from the VRST Master Trust are accrued daily.

Withdrawals may be made for the primary purpose of funding an authorized distribution withdrawal, or loan disbursement by a participating plan to an employee or beneficiary covered thereunder, or for the purpose of the participating plan making an employee directed transfer to another investment election of the employee's interest in the Plan. Certain plan directed withdrawals may be subject to market value adjustments calculated in accordance with the provisions of the investment contracts.

### **6. Party-in-Interest Transactions**

Certain investments of the Plan are managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Bureau. No such officer or employee receives compensation from the Plan.

### **7. Administrative Expenses**

Although not required by the plan document, the Bureau paid the Plan's legal, accounting and other administrative expenses except for processing fees related to the issuance and maintenance of a loan from the Plan which is charged to the individual participant's accounts.

### **8. Plan Termination**

Although it has not expressed any intent to do so, the Board of Directors of the Bureau has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

### **9. Tax Status**

On June 30, 2020, the IRS stated that the prototype plan document adopted by the Employer, qualifies under Internal Revenue Code ("IRC") Section 401(a). Although the Plan has been amended, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **10. Risks and Uncertainties**

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements.
