Opinion

We have audited the financial statements of City Wide Profit Sharing Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of City Wide Profit Sharing Plan as of August 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the "Auditor's Responsibilities for the Audit of the Financial Statements" section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about City Wide Profit Sharing Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Description of the Plan

General

The following description of City Wide Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Oddo Property Management LLC (the Company) for the benefit of its employees who were employed as of September 1, 2000, except for collective bargaining employees, who completed one year of service and were age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The trustees oversee governance of the Plan.

Effective January 1, 2023, the Plan was amended to update the plan sponsor from Oddo Development to Oddo Property Management LLC.

Contributions

Contributions to the Plan were discontinued effective September 1, 2000.

Participant Accounts

There have been no participant or Company contributions or non-elective Company contributions since September 1, 2000. Earnings and expenses continue to be allocated based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in Company contributions plus actual earnings thereon were based on years of continuous service. For vesting purposes, a year of service is defined as a Plan year including at least 1,000 hours of service. All participants are fully vested.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's interest in his/her account. If a participant dies, his/her designated beneficiary will receive the benefit. The Plan also allows in-service withdrawals for participants who have reached age 59½ including required minimum withdrawals.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Concentration of Risk

The Plan maintains its bank account at a single financial institution where accounts are insured by the FDIC up to a maximum of \$250,000. The balance in this account regularly exceeds the federally-insured limit. At August 31, 2024 and 2023, the Plan had approximately \$156,000 and \$0, respectively, in uninsured balances.

The Plan's investment in real estate is concentrated in two buildings in the Kansas City metro area. The Company performs ongoing credit evaluations of its tenants' financial condition and generally requires security deposits from its tenants.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Trustee determines the Plan's valuation policies. The Trustee or his designee is responsible for the investment of all assets held by the Plan.

Unit Values

Participants do not have beneficial ownership in specific underlying assets, but have an interest therein represented by units valued on the last business day of the plan year. Generally, withdrawals from each account are converted to units by dividing the amount of such transactions by the unit value as last determined, and the participants' accounts are charged with the number of units properly attributable to each participant.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

During the plan years ended August 31, 2024 and 2023, repairs and maintenance services were provided by two companies owned by the plan trustees. The Plan also reimbursed the companies for insurance premiums paid by the companies on behalf of the Plan. These transactions qualify as party-in-interest. Amounts paid by the Plan were \$50,775 and \$20,013 for the years ended August 31, 2024 and 2023, respectively, and are included in rental expenses. In addition, \$21,796 and \$10,462 was due to the companies as of August 31, 2024 and 2023, respectively, and is included in accounts payable and accrued expenses.

Benefit payments of \$368,000 and \$568,500 for the years ended August 31, 2024 and 2023, respectively, were made to the plan trustees of the Company.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

Recurring Measurements

The following table presents the fair value measurements of assets recognized in the accompanying statements of net assets available for benefits measured at fair value on a recurring basis and the level within the fair value hierarchy in which the fair value measurements fall at August 31, 2024 and 2023:

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended August 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified

in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. See the table below for inputs and valuation techniques used for Level 3 securities.

Level 3 Activity

Activity in Level 3 assets was limited to the appreciation/depreciation earned during the year. For the years ended August 31, 2024 and 2023, the gain (loss) was \$972,318 and (\$86,844), respectively. During the years ended August 31, 2024 and 2023, there were approximately \$0 and \$290,000 of additions, respectively. There were no disposals in 2024 or 2023.

Unobservable (Level 3) Inputs

The fair value of the Plan's real estate investments is estimated based on economic valuations using an income capitalization approach using significant unobservable inputs, including contract rents on existing leases, operating expenses, and capitalization rates based on the location, size and use of the real estate, as well as market data. Real estate market price fluctuations, occupancy rates and market rental rates are also considered in determining a reliable measure of fair value.

Note 5. Leases

The Plan is the lessor of two office buildings under operating leases expiring in 2025.

Future minimum rentals to be received under noncancelable operating leases are as follows:

Rental income, including common area maintenance charges, for the years ended August 31, 2024 and 2023 was \$937,435 and \$897,677, respectively.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by CCH Incorporated. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Note 8. Risks and Uncertainties

The Plan invests in real estate. Real estate is exposed to various risks such as liquidity, interest rate, market and tenant-related risks. Due to the level of risk associated with real estate, it is at least reasonably possible that changes in the value of real estate will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Effective October 16, 2024, the Plan entered into a real estate purchase agreement to sell the property located at 6800 Squibb Road for approximately \$3,896,500. The sale of the property closed on May 9, 2025.

On December 20, 2024, the Plan entered into a real estate lease. The lease term shall commence on May 1, 2025 and expire on April 30, 2037. On February 12, 2025, the Plan entered into a real estate lease with an existing tenant, which extends the lease's termination date by an additional five years to April 30, 2031.

Subsequent events have been evaluated through June 6, 2025, which is the date the financial statements were available to be issued.
