## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Wisconsin Stamping & Manufacturing, LLC 401(k) Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Wisconsin Stamping & Manufacturing, LLC 401(k) Savings Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - Wisconsin Stamping & Manufacturing, LLC 401(k) Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

**Accounting estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through May 26, 2025, which is the date the financial statements were available to be issued.

**Risks and uncertainties** - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Key parties of the plan** - Wisconsin Stamping & Manufacturing, LLC is the plan sponsor, employer and the plan administrator. Pension Inc. is the third party administrator and performs various compliance tests as tax counsel. John Hancock Life Insurance Company (U.S.A.) ("John Hancock") is the agent that maintains investment and participant records and holds custody of plan assets. LPL Financial, LLC is the plan's investment advisor. One officer of the plan sponsor is the plan trustee.

**Investments** - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Participants should refer to the investment account summaries and prospectuses for more information.

At the end of each business day, John Hancock determines the fair value of the investments held in its sub-accounts and allocates the fair value to the participants. The net appreciation (depreciation) in the fair values of the John Hancock sub-accounts, including investments bought, sold or held during the years, is reflected in the accompanying statements of changes in net assets available for benefits.

**Fair value measurements** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

**John Hancock sub-accounts** - The sub-accounts are valued at net asset value ("NAV") as provided by John Hancock. The NAV is generally based on the fair value of the underlying investments held by the sub-account less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the sub-account would sell the investment for an amount different than the reported NAV.

- (a) The objective of these funds is to seek capital appreciation and current income utilizing a risk profile that is consistent with the target date of the funds.
- (b) The objectives of these funds are to provide for capital appreciation and/or income consistent with the risk and return of the fund type summarized above. These funds utilize various U.S. and foreign equity market segments to accomplish their objectives. Certain funds included in these fund types summarized above are considered specialty funds that accomplish their objectives by investing in specific market segments. The specific market segments include investments in real estate investment trusts and real estate companies, federal and other government bonds, corporate bonds and utilities/energy. Total investments in such specialty funds are approximately \$582,000 and \$519,000 as of December 31, 2024 and 2023.

## 2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

**General** - The plan was adopted effective January 1, 2007 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - Employees are eligible to contribute to the plan once they have completed sixty days of service and have reached age twenty-one. Effective May 2023, the age requirement was reduced to eighteen. An employee is allowed to enter the plan on the first day of each month immediately following completion of eligibility requirements. Upon meeting these eligibility requirements, employees are also eligible to participate in the employer matching program.

For purposes of nonelective contributions, employees are eligible the first day of the plan year or the first day of the seventh month of the plan year if they have completed twelve months of employment, provided they have completed at least 1,000 hours of service during the plan year and were employed on the last day of the plan year to which the contribution relates.

**Contributions** - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways.

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan allows Roth elective deferral contributions. Upon meeting the eligibility requirements, employees are automatically enrolled in the plan and have 6% of their compensation withheld as elective deferral contributions. Additionally, participant deferral percentages automatically increase by 1% each year until they reach a maximum of 10%. Such participants have the option to increase, decrease, or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Employer matching contributions may be made at the employer's discretion. Employer matching contributions were equal to 50% of the first 6% of the employee compensation contributed as elective deferral contributions in 2024 and 2023. These contributions are funded coinciding with each payroll. Employer matching contributions were approximately \$243,000 in 2024 and \$188,000 in 2023.
- d. An additional nonelective contribution may be made at the employer's discretion on an annual basis. Such contributions are allocated to participants in the ratio that each participant's compensation bears to the compensation of all eligible participants. These contributions are funded annually subsequent to year-end. Nonelective contributions, prior to forfeitures being utilized, were approximately \$284,000 in 2024 and \$203,000 in 2023.

**Participant accounts** - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of employer contributions. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each payroll.

**Vesting** - Participants are always 100% vested in their elective deferral contributions, rollover contributions and related earnings. Participants begin vesting in any employer contributions and related earnings upon two full years of service, at which time they are 20% vested. The participant then vests at the rate of 20% for each year thereafter. Participants become 100% vested upon attainment of normal retirement age.

**Payment of benefits** - Benefit payments are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age. Distributions are generally required to be in the form of a single lump sum. Partial withdrawals or installments are only permitted for participants who must receive required minimum distributions. In-service withdrawal can commence upon attaining the age of 59½. Hardship withdrawals are permitted under the plan in certain circumstances.

**Administrative fees** - Certain administrative fees of the plan are paid by the employer. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution fees and nonparticipant directed charges for service, administrative and advisory fees. Nonparticipant directed charges are allocated to the participants on an account value basis.

**Forfeitures** - Forfeited nonvested accounts can be used to reduce employer contributions or pay plan expenses. Forfeitures used to reduce employer contributions were approximately \$25,000 in 2024 and \$27,000 in 2023. There were no forfeitures used to pay plan fees in 2024. Forfeitures used to pay plan expenses were approximately \$2,000 in 2023. Unapplied forfeitures are approximately \$39,000 and \$32,000 as of December 31, 2024 and 2023.

**Notes receivable from participants** - Loans to participants are not permitted under the plan.

### 3. PARTY-IN-INTEREST TRANSACTIONS

The plan investments are managed by John Hancock. John Hancock is the agent as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions. Direct administration fees paid to John Hancock by the plan were approximately \$45,000 in 2024 and \$31,000 in 2023.

John Hancock also provides certain administrative services to the plan pursuant to a services agreement between the plan sponsor and John Hancock. John Hancock may receive revenue from mutual fund service providers for services John Hancock provides to the funds. This revenue is used to offset certain amounts that would otherwise be owed by the plan to John Hancock or other third parties for its administrative and investment advisory services to the plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any employer contributions and related earnings.

### 5. INCOME TAX STATUS

The plan adopted a Pension Inc. pre-approved profit sharing plan that received a favorable opinion letter on June 30, 2020. The opinion letter from the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan, however, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits in progress.
